

H&P Deptt starts month-long skill upgradation training for staff

JAMMU: The Department of Hospitality and Protocol, J&K, Jammu on Thursday started a month-long training programme to upgrade skills of the staff members and equip them with the essential requirements in providing best services to the Guests. The training forms part of the endeavors initiated by the Commissioner/Secretary, Hospitality and Protocol Department, J&K. The training programme will cover different aspects viz. Liaisioning, Personal and Food hygiene, safety, Hospitality etiquettes and courtesies etc.

First event in this series was a programme on "First Aid Training" organized in collaboration with Indian Red

Cross Society, Jammu Region, in which all staff members of the department participated and were sensitized on the basic fundamentals of first aid. The training was organized with an objective to equip the staff with the basic techniques of providing first aid in the event of any untoward situation/accident. The training session was conducted by Dr. Shelly Mahajan, M.D Anaesthesia, Medical Officer Indian Red Cross Society. She explained about the basic characteristics of a first aider and discussed his role in the scenarios like injury due to an accident, heart attack, snake bite, heat stroke, electrocution, transportation of an injured patient etc. She also emphasized on the do's

and don'ts of the first aid on an unconscious patient as well. Further, Demonstration of Cardiopulmonary Resuscitation (CPR) was conducted, that was also practiced by the staff members. She also sensitized the staff members about the Food Hygiene and practices associated with it.

The whole event was conducted under the overall guidance of Ansuja Jamwal, Joint Director, Hospitality and Protocol, Jammu. In her address, the Joint Director highlighted the significance of such a sensitization programme for the staff members who cater to various VVIP/VIP guests on a routine basis. She also emphasized that the purpose of such training was to preserve life by increasing the quality and quantity of Responsible First Aiders. Assistant Director, Convention Centre, Jammu, Aamir Choudhary; Assistant Director, H&P, Jammu, Madhur Anand; Assistant Director, H&P, Jammu Puneet Kour and other officials were also present on the occasion.

Order No. 474-HME of 2014 dated: 11-08-2014.
3. The in-service applicant has to forward his/her application form through proper channel.
4. In-service candidate if selected shall be on deputation for three (3) years as per SRO-75 dated 15-04-1993.
5. The non-service applicant shall be engaged on academic arrangement basis as per terms and conditions of S.O 364 dated: 27-11-2020.
6. The appointee shall be entitled the salary as applicable under S.O-364 dated 27-11-2020.
7. The Maximum age for non-service applicants at the time of submission of application should be 50 years.
8. The applicant should be BDS or equivalent as recognized by the Dental Council of India.
9. The applicant having Post Graduate (MDS) qualification in the concerned discipline as recognized by the Dental Council of India will be given preference in terms of Govt. Order No. 706-HME of 2007 dated: 11.01.2007.
10. Those doctors who have already completed their tenure/working as Registrar/Tutor/Demonstrator after their Post Graduation in the discipline in any institution as recognised/approved by Dental Council of India within or outside the UT need not apply and their application forms shall not be considered. However, this restriction shall not be applicable in respect of such doctors who have done their Registration/Tutorship/Demonstration in the discipline prior to the passing of their post-graduation.
