Whereas, the Govt. of India through Ministry of Road Transport and highway (MoRTH) vide Notification No. SO 3869 (E) Dated:- 28-10-2020 under Section 3A of National Highway Act, 1956 declared its intention to acquire the land particulars of which are mentioned in the schedule for construction of Double lane Road with paved shoulders on the Existing Double lane specification Akhnoor-Poonch NH-144A in Village Thandi Kassi Tehsil and District Rajouri.

Whereas, the said notification issued under Section 3A of National Highway Act, 1956 was published by Competent Authority Land Acquisition (CALA) in News paper, "State Times" dated 22.11.2020, Hind Samachar dated:- 21-11-2020, "Umar Ujala" dated:- 06-02-2021 and "Daily Excelsior" dated:- 06-02-2021 for inviting objections from the interested persons within stipulated time frame of 21 days from the date of publication,

Whereas, none of the land owners/ interested persons objected before the competent Authority for land Acquisition (CALA) within stipulated period of time and accordingly the Govt. of India through Ministry of Road Transport and highway (MoRTH) issued Notification under section 3D of National Highway Act, 1956 vide No. SO 1296 (E) dated 23-03-2021 for an area of 1.1724 Hectare (including the village Thandi Kassi) declared that land specified is to be acquired for aforesaid purpose.

Whereas, the aforesaid 3D Notification bearing No. SO 1296 (E) Dated:- 23-03-2021 was published by Competent Authority for land Acquisition (CALA) in local daily viz "Amar Ujala" Dated: 01-04-2021.
