Dear Sir,

1. The above said work stands allotted to vide Superintending Engineer PMGSY Circle Batote vide allotment No. PMGSY/SE/B/4121-26 dated 23-03-2021 for an amount of 515.03 lacs.
2. Whereas the said work was to be completed by you within 9 months i.e. by or before 08-01-2022, which stands expired since long.
3. Whereas vide this office letter No.PMGSY/K/902-05 dated 07-06-2021 under which the sunset date of PMGSY I & II was given up to 31-03-2022 and you were advised to speed up the execution of work.
4. Whereas vide this office letter No. PMGSY/K/1508-12 dated 07-07-2021 under which you were advised to deploy sufficient men and machinery at site within 5 days. But your progress remained very slow.
5. Whereas vide this office letter No. PMGSY/K/2925-29 dated 15-09-2021, where under you were again advised to deploy sufficient men and machinery from both ends of the road otherwise this office has left no option other than to recommend your case for termination.

6. Whereas vide Superintending Engineer's PMGSY circle Batote letter PMGSY/SE/B/2266-68 dated 12-10-2021 you were directed to execute the above subject work at an accelerated pace by deploying sufficient men and machinery at site within the time period allotted by the Executive Engineer.

7. Whereas vide Chief Engineer PMGSY JKRRDA Jammu letter No. CEJ/PMGSY/16484-87 dated 11-11-2021 you were notified to accelerate the progress on the work by employing sufficient machinery, men and material to ensure completion of the project by 31-12-2021.

8. Whereas vide this office letter No. PMGSY/K/4645-50 dated 23-12-2021 you were advised to deploy additional men and machinery and ensure timely completion of scheme.

9. Whereas vide this office letter No. PMGSY/K/5714-18 dated 25-02-2022 you were given road wise decisions taken in the meeting held under the chairmanship of Chief Engineer PMGSY Jammu on 22-02-2022, and you agreed in principal for additional 1No. Excavator to be deployed from takeoff point on 03-03-2022 and completion of scheme by 30-06-2022.

10. Whereas vide this office letter No. PMGSY/K/5827-31 dated 03-03-2022 you were once again advised to resume the work from takeoff side by deploying sufficient men and machinery so that the scheme can be completed by you before June-2022.

11. Whereas vide this office letter No. PMGSY/K/125-29 dated 09-04-2022 you were once again advised to resume the work within 5 days on the project from take off side so that the scheme can be completed before June 2022.

12. Whereas the chain of reminders regarding the resumption of work have been issued to you for a-starting of the work from takeoff side but even till date you have not started the work for the reason best known to you. As the alignment is totally encumbrance free for execution of work from takeoff side also as you are executing the work with slow pace on the tail end only. You are aware with the facts that sunset date for completion of PMGSY I & II has been re fixed before September-2022. The stage-II work is also being delayed due to your slow pace on tail end side only. Your action and false promises clearly speaks that you are not interested to complete the said work before the sunset date.

13. Whereas you are once again given an opportunity to resume the work from takeoff point by deploying additional men and machinery and also accelerate the work on both end sides within 7 days from the issue of this notice otherwise action as warranted under SBD clauses shall be taken against you.
