Apart from the cleaning process, a thick layer of security has been thrown around the lake to secure the meeting venue, and Marine and NSG commandos will also be deployed as an extra security measure.

At a security review meeting here last week, Additional Director General of Police (ADGP) Kashmir zone Vijay Kumar emphasised the importance of river and lake domination in ensuring the security of the G20 summit, a police handout said.

Kumar also emphasised the need for the Marine Commandos (MARCOS) to be deployed to provide a strong security cover for the water bodies around the summit venues, it added.

"The ADGP Kashmir shared with all stakeholders that NSG teams will be used for counter fidayeen attack along with SOG and specialise NSG teams to counter drones will be deployed at all venues," the police said.

Shah's praise for the BSF did not go well with West Bengal's ruling TMC, which has repeatedly accused the border force of laxity in dealing with cattle smuggling and excesses on the people living along the border.

"Firstly, Amit Shah should have visited Manipur, which is on the boil due to ethnic violence. Secondly, he praised the BSF, he should first answer why cattle are being smuggled across the border in the presence of the force. The CBI had arrested a BSF officer for involvement in cattle smuggling," TMC spokesperson Kunal Ghosh said. Reacting to the TMC leader's comment, BJP national vice-president Dilip Ghosh said, "The TMC should not dictate what Amit Shah ji should do or not. And regarding the cattle smuggling scam, senior TMC leaders have been questioned and arrested for their involvement.

TMC's Birbhum district president Anubrata Mondal was arrested in connection with cattle smuggling cases by the CBI in August last year.

Stage set for...

In an appeal to "brothers and sisters" of the State, Modi sought their blessings in the mission of making Karnataka the number one state in the country.

"My appeal is for the bright future of Karnataka. It is for the bright future of your family, especially the younger generations," said the prime minister, who addressed 19 public meetings and held six roadshows as part of BJP's aggressive campaign in the state

In a lengthy complaint to the chief election commissioner, Congress general secretary in charge of Karnataka Randeep Surjewala asked the commission whether it will remain a "mute and helpless spectator" or fulfil its constitutional duty and act against the prime minster.

With the stakes being high in the mega battle of ballots, the major political parties in contention--the BJP, Congress and JD(S)--have made a strong pitch to boost their electoral prospects. The Aam Aadmi Party(AAP), which is in power in Punjab and Delhi, has also fielded candidates

Voting will take place from 7 am to 6 pm amid tight security arrangements and the ballots will be counted on Saturday. A total of 2,615 candidates are in the fray. While the ruling BJP, riding on the Modi juggernaut, wants to break a 38-yearold jinx -- Karnataka has never voted the incumbent party to power since 1985, the Congress is hoping for a morale booster victory to give it a much-needed elbow room

and momentum to position itself as the main opposition player in the 2024 Lok Sabha elections. The battle-ready BJP with its well-oiled election machine ran its campaign with a blitzkrieg by Prime Minister Modi.

It was clear the double-engine Sarkar' sought to heavily bank on Modi's appeal to bolster its campaign, shore up its prospects and fight "anti-incumbency"

Also what needs to be watched out for is whether former Prime Minister H D Deve Gowda-led Janata Dal (Secular) will emerge as a "kingmaker" or a "king" by holding the key to government formation, in the event of a hung verdict, as it has done in the past. The Congress manifesto proposing to ban the Bajrang Dal heated up the later half of the campaign as the BJP and Prime Minister Modi aggressively latched on to the issue to portray the grand old party as being against Lord Hanuman and the sentiments of Hindus.

Modi also likened the proposed ban to locking up Hanuman itself.

He also made it a point to chant 'Jai Bajrang Bali' in all his speeches after the Congress released its manifesto.

Chief Minister Basavaraj Bommai (Shiggaon), Leader of Opposition Siddaramaiah (Varuna), JD(S) leader H D Kumaraswamy (Channapatna) and state Congress President D K Shivakumar (Kanakapura) are the among the top candidates in the fray.

Other than Siddaramaiah and Kumaraswamy, Jagdish Shettar (Hubli-Dharwad Central) is the other former CM, who is in the fray. Shettar had recently joined Congress, quitting BJP.

government called the Rangers to control the law-and-order situation in the province and imposed section 144 under which not more than five people can gather at one point. The Punjab government also requested the Pakistan Telecommunication Authority to suspend Internet and mobile services in the areas of the province where violent protests took place.

A large number of PTI workers also pelted stones at the residence of Interior Minister Rana Sanaullah in Faisalabad city. Similarly, protests were held in Multan, Jhang, Gujranwala, Sheikhupura, Kasur, Khanewal, Vehari, Gujranwala Hafizabad and Guirat cities.

Interior Minister Sanaullah said that Khan failed to appear before the court despite being issued several notices. "The arrest has been conducted by the National Accountability Bureau for causing losses to the national treasury," he said.

He asserted that Khan was not tortured.

In a pre-recorded video issued by the party after his arrest, Khan said, "till the time these words of mine reach you, I will be arrested in a baseless case. This shows that fundamental rights and democracy in Pakistan have been buried.

"All this is being done because they want me to accept the corrupt, imported gov ernment that has been forcefully imposed on us," Khan said.

He said if someone has a warrant, they should directly bring it to me. "Bring the warrant, my lawyer will be there. I'm ready to go to jail myself," Khan said. His arrest came a day after the powerful Pakistan Army on Monday slammed

Khan for "highly irresponsible and baseless" allegations by him against a serving ISI officer without any evidence. Islamabad police released a brief statement quoting Inspector General (IG) Akbar Nasir Khan as saying that Khan had been arrested in relation to the case which con-

cerns allegations that Bahria Town allotted land worth Rs 530 million to Al-Qadir Trust, owned by the PTI chairman and his wife Bushra Bibi. The police chief also said that the situation in Islamabad was "normal". He added that Section 144 had been imposed in the federal capital and action would be taken

It was said that Khan was shifted to NAB office in Rawalpindi where a medical checkup was carried out. However, PTI leader Fawad Chaudhry claimed that Khan

was shifted to an unknown location. Geo News reported that Khan's medical examination was performed but the report was not released so far. The channel also said that the NAB was preparing to pres-

ent him before an anti-corruption court tomorrow and secure physical remand to further probe in the case. It also reported that a special room has been prepared by NAB's office in Rawalpindi and Khan will be kept there during the night. It is the same room of NAB where former premier Shahid Khaqan Abbasi was kept when arrested during

the government of Imran Khan. Meanwhile, the Islamabad High Court on Tuesday reserved its judgment in the case about the arrest of Khan from the court premises.

IHC Chief Justice Aamer Faroog took notice of the arrest by Rangers when Khan was present to mark his biometric attendance before the start of hearing of anoth-

The court summoned various officials and heard arguments on the merit of arrest and if it was legal to arrest someone present inside the court.

After hearing the case, the chief justice reserved the judgment without saying when it would be announced. Quoting Barrister Gohar Khan, who was at the court during Khan's arrest, Dawn

newspaper said the former prime minister was "tortured". "They hit Imran's head and leg...his wheelchair was also tossed aside during the

arrest," Gohar was quoted as saying by the paper. Former minister and senior PTI leader Hammad Azhar said that Khan's arrest was "not acceptable" and asserted that the party chief "is our red line". He called on

Khan has been facing a slew of cases since his ouster through a no trust vote in April last year. He has rejected all these cases as political victimisation by the ruling alliance.

NEW DELHI: President Droupadi Murmu on Tuesday conferred eight Kirti Chakras, including five posthumously, to personnel of the Army and paramilitary and police forces for displaying indomitable courage and extraordinary valour in the line of duty. Kirti Chakra is India's secondhighest peacetime gallantry award.

President Murmu, who is the Supreme Commander of the armed forces, also presented 29 Shaurya Chakras, including five posthumously, to the personnel of the armed forces, Central Armed Police Forces and state/Union Territory police during a defence investiture ceremony held

at the Rashtrapati Bhavan, the defence ministry

Sudip Sarkar, Constable/GD, in the Border Security Force, Rohit Kumar, Sg. Constable, J&K Police, and three others -- one sub-inspector and two head constables. Chhattisgarh government. have been conferred the Kirti Chakra posthumously, it said.

Three personnel, including one of a Majorrank, from the Army's Rashtriya Rifles, have been conferred the Kirti Chakra, the ministry

The Rashtrapati Bhavan later also shared pictures from the ceremony on its official Twitter

"President Droupadi Murmu presents Kirti Chakra to Major Shubhang, Dogra Regiment, 62nd Battalion, Rashtriya Rifles. He exhibited extraordinary valour despite sustaining gunshot wound and eliminated a terrorist during an operation in Budgam, J&K," it tweeted.

The gallantry awards were given for displaying conspicuous gallantry, indomitable courage and extreme devotion to duty, the ministry said.

"President Droupadi Murmu presents Kirti Chakra to Shri Shrawan Kashyap, Head Constable, Chhattisgarh (Posthumous). He displayed extraordinary courage and made supreme

sacrifice for the nation while fighting and killing the Naxals during an operation in Bijapur, Chhattisgarh," the Rashtrapati Bhavan tweeted. Among the Shaurya Chakra (posthumous)

awardees is Rifleman Aurangzab, Jammu and Kashmir Light Infantry, 44th Battlion, the Rashtriya Rifles, This award of Shaurya Chakra (posthumous) was announced on the Independence Day in 2018, it added.

Sepoy Karn Veer Singh (Rajput Regiment) and Gunner Jasbir Singh (Regiment of Artillery). both from the Rashtriya Rifles, are also among those who have been posthumously conferred the Shaurya Chakra.

The other two bravehearts to have been conferred this gallantry award posthumously are Constable Mudasir Ahmad Sheikh, Jammu and Kashmir Police (Baramulla) and Naik Jasbir Singh, 6th Battalion, the Jammu and Kashmir Rifles, the statement said.

A group of personnel from the Army, the Air Force, Navy and those rendering services under the Ministry of Home Affairs have also been conferred the Shaurya Chakra, according to the statement.

The Shaurya Chakra is India's third-highest peacetime gallantry award after the Ashok Chakra and Kirti Chakra.

Education Deptt issues guidelines for seeking permission, affiliation, recognition of private schools

JAMMU: Section 11 of Jammu & Kashmir School Education Act 2002 provides that no school shall be established, run or maintained without permission of the Competent Authority. The procedure to be followed for grant of permission to such schools is enshrined in Rule (4) of School Education Rules 2010.

Further Section (12) of the said Act provides that only such private schools, which are recognised, shall be permitted to function. These instructions have been issued from time to time for strict compliance by the com-

petent authorities. However, it has been observed that some institutions are still running without permission or undertaking classes/courses for which they have not been permitted in terms

said in a statement.

Accordingly, the Education Department has enjoined upon all the private schools/institutions to run only after seeking proper permission from Competent Authority through online portal https://schedujammu.nic.in/ pvtschool/.

It has further asked the private schools to impart education for those courses/classes for which they have been permitted under law/rules; Display the recognition and affiliation status issued by competent authority on their sign boards; Register on Adharshila (online monitoring Portal) www.schedujammu.nic.in/adharshila alongwith their recognition/affiliation order and ensure that the error free information of all the students is updated on the portal; get Management Committee Certificate renewed after expiry of every 03 years and recognition/permission/affiliation

after expiry of every 05 years. Further, the department has impressed upon the parents of the students to ensure that the schools in which their wards are seeking admission are recognized affiliated by Director of School Education/Chief Education Officer/JKBOSE/CBSE etc. as the case may be.

Meanwhile, the Chief Education Officers/Zonal Education Officers have been asked to ensure that no unrecognized school is allowed to run within their respective jurisdiction. The CEOs shall also ensure that the schools are undertaking only those classes/courses for which they have been permitted by the competent authority under rules.
