Whereas, among others Mrs. Jameela Akhter was regularised as Junior Grade Nurse as migrant substitute with effect from 16-05-2006 in Govt. Medical College in terms of Govt. order No. 574 of 2013 dated 24-10-2013 issued under endorsement No. HD/46/NG/2004 dated 24-10-2013; and

Whereas, Mrs. Jameela Akhter has represented vide application (dated 29-09-2022) supported with Date of Birth certificate issued by the Jammu and Kashmir State Board of School Education issued under Roll No:- 11050 for the session Oct- Nov 1986, that her name may be considered as "Jamula Akhter" in the service records instead of "Jameela Akhter" which has been wrongly reflected in her official documents from time to time; and

Whereas, the said official during this course from the date of her initial engagement on migrant vacancy as Junior Grade Nurse till submission of application (dated 29-09-2022), never represented for rectification of her name, but has off late represented for its correction; and

Whereas, the request of the official was forwarded to the Administrative Department for further examination and grant of necessary directions in this regard on the strength of the documentary evidence produced by the official, vide this office communication No. AH/Est-II/MC/2022/4519-21 dated 01-12-2022; and

Whereas, the Administrative Department vide communication No. ME-Leg/128/2022-02 dated 07-02-2023, conveyed the instruction to take appropriate steps in the instant case strictly in light of OM No. 19016/1/Estt(A) dated 12-03-1987 issued by GOI, regarding procedure to be adopted for change in name / correction and modification to be done by a Govt. Employee and have further directed to get a certificate for the concerned Teshildar and SHO concerned to the effect that "Jamula" and "Jameela" are not two different persons but a single person and decided to invite the objections from the general public before acceding to request of Mrs. Jameela Akhter; and

Whereas, the Medical Superintendent Govt. SMHS Hospital Srinagar was accordingly conveyed vide this office communication No. AH-9/Est-II/MC/2023/1000 dated 21-02-2023 to get the case verified from both the concerned quarters and get a certificate to the effect that "Jamula" and "Jameela" are not two different persons but a single person; and

Whereas, in response, the Medical Superintendent Govt. Majid Reshi and Jameela Akhter D/o Ab. Majid Reshi R/o Peth Dialgam Tehsil and District Anantnag is one and same the individual.

Now, therefore, through the medium of this notice, objection(s), if any, are hereby invited from the general public regarding request of the official for changing of her name from "Jameela Akhter" to "Jamula Akhter" in her service records. The objections must reach the office of the undersigned within a period of 14 days from the date of publication of this notification. No representation / objection shall be entertained after expiry of the stipulated time-period.
