It is hereby noified notified that land in the area specified is likely to be required to be required for the above purpose. A committee was constituted in terms of under Section (4) of the Jammu & Kashmir right to fair.

Compensation and transparency in land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment Study). Vide No 01/CLA JPDCL) of 2023 dated: - 31-03-2023, for preliminary enquiry regarding acquisition of above-mentioned land. The Committee visited at sport and conduct enquiry regarding the land under acquisition and submitted its report with following recommendation

During spot visit it is found that 3.15 MVA, 33/11 KV Receiving Station already Stands constructed on the said ladn and is already under use for public purpose. There is no rehabilitation or resettlement involved in the instant case of acquisition. Moreover, There in no Adverse socia or environmental impact by the acquisition of the said land. Also, the extent of land is absolute bare minimum needed for the project. Report of Social impact Assessment Committee was submitted to worthy Deputy Commissioner Jammu for appraisal by an expert group as pe ection 4(b) of Right to fair compensation and Transparency in land Acquisition, Rehabilitation and resettlement Act 2013.

Deputy Commissioner, Jammu vide her letter No DCJ/LA/PDD/2023-24/153-54 Dated: - 13-05-2023. Directed that since, in the instant case in view of the position stated above as also the fact that the consent of the owner is there as the landowner has represented before the hon'ble high court, J&K for compensation. No Scope Is left of further SIA study therefore the report by the SIA committee Constituted by the collector PDD Shall be treated as SIA and Collector PDD to to Further proceed for issuance of preliminary Notification U/S 11(1).


