Officials said it is not that all invitees attend every meeting and some have skipped those held in other parts of the country also.

Asked about the negative travel advisories of many foreign countries on Jammu and Kashmir, India's G20 Sherpa said the "officials from G7 countries were participating and they would not have come here if there were any such advisory".

"We are going to soon declare national tourism policy for India. We are planning global tourism investment summit," Reddy, the minister for Culture and Tourism,

Reddy said the Union government and the Ministry of Tourism are closely working with all the ministries and the state governments to encourage tourism

"The government of India is also working with all the G20 countries and invited countries for developing sustainable tourism," he added. Speaking at the presser, G20 Sherpa Kant said India is hosting G20 presidency at

a time of "global turbulence".

"Seventy per cent countries are facing debt crisis. People have lost jobs. But, India sees G20 as an opportunity," he said.

We are growing at a high rate of around seven per cent. We have built 40 million houses, provided toilet connection to 110 million people, drinking water connection to 240 million people. We have made 55,000 kilometres of road. Inclusive, resilient and sustainable growth is our priority. If there is growth, we will be able to lift people out of poverty," he said.

There is a need to transform multilateral financial institutions to ensure that resources flow to emerging countries, Kant said.

He said India thought of making G20 as people's presidency and the country is hosting the G20 events in 60 cities.

"It is unparalleled. The meeting in Kashmir is very very important for us as we believe in peace and prosperity," he said. Minister of state in Prime Minister's Office Jitendra Singh said holding the G20

event in Srinagar was an achievement in itself. "I am sure the delegates coming here will be able to falsify the perception that is

sought to be created by vested interests. The common man wants to move on. "He wants development and progress. He no longer wants to be part of Pakistansponsored terrorism. He has seen the development across the country and avenues for progress under the leadership of PM Narendra Modi. He does not want to miss

the bus," Singh said. He said the G20 meeting in the valley is being carried out in the same format as is being done in other 60 venues.

"This speaks of the mainstream activity happening here," he added.

"Special Court, Kulgam designated under NIA Act issued proclamation orders under section 82, CrPC against five active terrorists involved in various terror crime and target killing cases, including killing of lady teacher Rajni Bala and bank manager Vijay Kumar in Kulgam district last year," a police spokesperson said in a statement.

On the request of the Special Investigation Unit (SIU), Kashmir, the proclamation orders were issued against Arjumand Gulzar alias Hamza Bhuran, son of Gulzar Ahmed Dar, resident of Kharbatapora Ratnipora Pulwama; Bilal Ahmed Bhat, son of Gh Rasool Bhat, resident of Chaki Cholend Shopian; Sameer Ahmed Sheikh alias Kamran Bhai, son of Farooq Ahmed Sheikh, resident of Chaki Cholend Shopian; Abid Ramzan Sheikh, son of Mohd Ramzan Sheikh, resident of Chotipora Shopian and Basit Amin Bhat son of Mohd Amin Bhat resident of Frisal Kulgam, the spokesperson said.

Before the issuance of the proclamation orders, the court had issued open-ended non-bailable warrants (NBWs) against all five, he added.

The proclamation orders were read out at conspicuous places in the villages of the terrorists and copies of the orders were pasted at their houses as well as villages, the police spokesperson said.

Before the initiation of further legal proceedings against the five, the court has given them a chance to surrender before it or the investigation agency, he added.

The police spokesperson said SIU teams, along with local police and magistrates, went to the villages of the terrorists in Kulgam, Shopian and Pulwama districts for the execution of the proclamation orders.

He was addressing the delegates from the G20 countries on the side event 'Film Tourism for Economic and Cultural Preservation'. The event is a part of the third Tourism Working Group Meeting of the G20 countries being held in the city.

"We believe in peace and prosperity. Prime Minister Narendra Modi believes tourism has a multiplier effect and it is a job creator. This destination is unique because no Bollywood movie was complete without a shoot in Kashmir. No romance in India was complete without Kashmir," he said.

He added that Kashmir is the finest destination to shoot movies, especially of the romance genre. "We will help you to bring

more and more romance and glamour to your films," Kant said addressing the event. Referring to famous movies

Material recovery facility transforming Jammu into clean, green city

JAMMU: Jammu city is rapidly transforming into a "clean and green city", with noticeable improvements in cleanliness in streets, footpaths, flyovers and residential areas

The city is making significant progress towards achieving zero waste and at the forefront of this positive change is the Material Recovery Facility (MRF). also known as the 'Swachhta Kendra' (cleanliness centre), established in 2021.

The first-ever MRF in Jammu and Kashmir on the outskirts of the city operates under the collaboration of the Regional and Urban Development Agency (RUDA) $\,$

and the Jammu Municipal Corporation (JMC). It employs a sustainable approach to integrated plastic waste management and efficient recycling within the city. "This MRF in Jammu is the

first of its kind. We have established it in partnership with the Municipal Jammu Corporation. It has been operational for almost three years now, with a daily capacity to handle five tonnes of waste. Currently, we collect, segregate, and recycle approximately 150 to 200 tonnes of trash every month," Sajeev Arora, Chief Executive Officer (CEO) of

RUDA, told PTI. Equipped with state-of-theart technology, the MRF collects, separates, and processes dry waste before sending it to recycling centres. As a result, it significantly contributes to the reduction of carbon emissions and the effort is to make the city clean and green, he said. "To date, we have collected

7,000 metric tonnes of plastic waste, which we have success fully segregated and recycled. From an environmental perspective, every kilogram of plastic waste collected indirectly prevents three kilograms of carbon emissions. Through our efforts, we have already reduced 20,000 to 22,000 metric tonnes of carbon emissions in the atmosphere," Arora said.
