has applied for leave to appear in BAMS Exam and forward her application for seeking permission for pursuing BAMS Course/appear ing in the exam staring from 06.12.2021 to 29.12.2021: WHEREAS, this office vide letter No. Estt/ACST/A&E/J/1659 dated 04.01.2022 asked the State Taxes Office Circle 'J' Jammu

WHEREAS, State Taxes Office Circle 'J' Jammu vide letter No. STO/J/707 dated 11.12.2021 stated that Ms. Arushi Barghav, Orderly
