# CRIME REPORT

## Brawl over parking, BJP leader among five injured

JAMMU: A brawl between the two parties over the parking of the car late on Friday night in Kachha Talab area of Bishnah area leads injuries to five persons including a BJP leader. According to the information, a clash erupted between two car drivers over parking their cars near a pond in Bishnah area. The matter increased so much that a scuffle started with each other in which they attacked each other with sticks. During this, BJP leader Satish Bharti also came in between and got injured. He too was attacked. In which he was also injured. Police team reached the spot and took the injured to the hospital. Both the cars have been seized and investigation has been started.


## Woman dies during treatment in Kathua hospital; family ransacks premises

KATHUA: A woman died during treatment at Government Medical College Kathua and enraged by this, family members ransacked the premises. The woman was admitted to the hospital on May 24 following a heart attack. The relatives allege that the patient admitted in the hospital was not being taken care of. After the uproar, hospital management shifted the woman to the ICU. The woman's husband Dayal Chowdhary told that wife Shakuntala was admitted to the hospital. Seeing his condition, the doctors shifted him to the ICU and two days of treatment she was shifted to the ward but there was no proper care of his patient. When the patient's condition started deteriorating last night, no doctor came to see her and she died.

## Narco smuggler nabbed; 2.06 grams heroin recovered

JAMMU: Continuing its drive against drug trafficking and substance abuse, police on Saturday nabbed a narco smuggler and recovered 6 grams of heroin from his possession.

As per details, a team of Police Station Gandhi Nagar led by SDPO South Sachit Sharma assisted by SHO Gandhi Nagar Inspr Pankaj Sharma and PSI Sayaf Khan while on Naka duty near Govt. Girls Higher Secondary School Shastri Nagar rounded up one suspected person on a vehicle (JK02DB/3351). During search, 06 grams of heroin was recovered from the accused later identified as Sarabjeet Singh, son of Santokh Singh, resident of 152/2 Ajit Nagar Tehsil Gadigarh Jammu. He was arrested and FIR No. 131/2023 under sec-



tions 8/21/22/25 NDPS Act was registered against him at Police Station Gandhi Nagar.

## Huge quantity of seized contraband destroyed

RAMBAN: In compliance with the order of the Court of Principal & Sessions Judge Ramban, a committee headed by C/M Ramban Bashier Ahmed Munshi, comprising of SSP Ramban Mohita Sharma, ADC Ramban Harbans Lal Sharma, DySP Hqrs Ramban Pardeep Singh Sen, DySP DAR Viqar Younis, PP Sessions Court Ramban Ranjeet Singh Bandral & SHO Ramban Anil Choudhary, destroyed a huge quantity of the seized drugs and psychotropic substances under section 52A of NDPS Act. The destroyed contraband substances were seized under the 23 Narcotics related cases lodged in the police stations of Ramban district. The destroyed illicit substances included 11.425 Kgs of Charas, 7 Quintal 98 Kgs 150 grams of Poppy Straw, 1.30 Kg of Heroin. These seized items were destroyed at Kowbag area of District Ramban in the presence of esteemed committee members headed by the Hon'ble Chief Judicial Magistrate Ramban and other Police officers of the district. C/M lauded the efforts of the police department in eradicating the menace of drugs from the society.

## 4 drug peddlers arrested; contraband, cash recovered

SRINAGAR: Continuing its efforts to eradicate the menace of drugs from the society, police on Saturday arrested 04 drug peddlers in various parts across Kashmir and recovered contraband substances and cash from their possession.

As per details, a party of Police Post Wachi at a checkpoint established near Petrol Pump Melhura Wachi, arrested a drug peddler identified as Shahid Afridi Shah son of Gh Hassan Shah resident of Melhura. During search, officers were able to recover 177grams of Charas, 04 grams of Brown Sugar and ?10,000 (proceeds of narcotic crime) from his possession.

Similarly, a party of Police Station Shopian at a checkpoint established at Sofanaman near Pinjora Crossing, arrested a drug peddler identified as Ab Gani Monchi son of Ab Rehman Monchi resident of Rakh Chedren. During search, 155 grams of Charas was recovered from his possession.

Meanwhile, a party of Police Station Tangmarg at a checkpoint established at Main Market Tangmarg near Hotel Mahajan, arrested a notorious drug peddler identified as Khursheed Ahmad Bakshi son of Mohd Rafiq Bakshi resident of Watalpora Tangmarg. During search, 15 grams of Charas was recovered from his possession.

Moreover in Kulgam, a party of Police Post Mirbazar at a checkpoint established at Furrah, intercepted a suspicious person carrying a nylon bag who after noticing police party tried to flee from the spot but was apprehended tactfully. He has been identified as Arbaaz Ahmad Mir son of Gulzar Ahmad Mir resident of Furrah. During search, 04 Kgs of Cannabis Powder was recovered from his possession.

All the arrested drug peddlers have been shifted to concerned police stations where they remain in custody.

## 6 notorious bovine smugglers arrested, 23 bovines rescued

SAMBA: Police on Saturday arrested six notorious bovine smugglers, foiled bovine smuggling attempts, rescued 23 bovine animals and seized two trucks.

Samba Police has foiled bovine smuggling attempts, regis-

tered FIR No. 135/2023 under section 188 IPC, 11 PCA at Police Station Samba and arrested six notorious bovine smugglers. Further investigation is underway. The bovines were being smuggled to Kashmir valley during odd night hours obviously to escape from police clutches.

Arrested notorious bovine smugglers have been identified as Mohd. Latif, son of Abdul Aziz, resident of Kadma, Pirdatehsil and district Ramban at present P Sumbtehsil and district Samba; Mohd. Farid Ahmed, son of Nawab Din, resident of Nainthar, Modia Barwal tehsil and district Samba; TalibHussain, son of Gugar Din, resident of Ramkot Tehsil Billawar and district Kathua; Mukhtar Ahmed, son of Abdul Rehman, resident of Nihari tehsil and district Samba; Mohd. Yousaf, son of Mohd. Rafiq, resident of Savni, tehsil and district Ramban and Mohd. Maneer, son of Abdul Hamid, resident of Chanoori Taloor tehsil and district Samba.

## 23 vehicles Challaned for violation of traffic rules

DODA: Motor Vehicle Department, Doda on Saturday conducted a major enforcement drive on Doda-Batote stretch of National Highway 244. ## Bootlegger nabbed with 20 bottles of illicit liquor

DODA: Police on Saturday apprehended one bootlegger with huge quantity of illicit liquor from his possession.

Giving details Doda Police said that acting on the specific information, a Police party of Police Post DH Doda led by PSI Aman Sharma IC PP DH Doda rushed on spot and rounded up one Phuleel Singh son of Shanker Singh resident of Bijarni Kaehwa tehsil Bhagwah who was coming from Dessa Chowk towards Old Bus Stand Doda and during checking, (20) bottles of illicit liquor were recovered from his possession which he had carried in the bag for the purpose of selling illegally.
