

### Man arrested with poppy straw

KATHUA: To eradicate the menace of Drugs from the society and take stringent action against Drug Peddlers within district, Kathua Police on Tueday nabbed a drug peddler and recovered approx. 1.2 Kg Poppy Straw (Bhukki) from his possession.

As per details, a police team led by Insp. Jaswinder Singh SHO Police Station Basohli assisted by PSI Kusum under the supervision of SDPO Billawar Arvind Kumar during routine naka/patrolling duty in its jurisdictional area



noticed the movement of one suspicious person who was wandering under suspicious circumstances. During checking 1kg 200 gms Poppy Straw (Bhukki) like narcotics was recovered from the illegal possession of person namely Mukesh, son of Madan Lal, resident of Jandrali Tehsil Basohli District Kathua who was enrouted from Punjab towards Basohli by foot. The accused was arrested and FIR No. 26/2023 under sections 8/15 NDPS Act was registered against him at Police Station Basohli.

# Theft case solved; 2 arrested, stolen items worth Rs 2,50,000 recovered

MIRAN SAHIB: Police on Tuesday solved a theft case by arresting two thieves and recovered stolen items worth Rs 2,50,000.

As per details, a written complaint was lodged at Police Station Miran Sahib by one person namely Inderjeet Singh, son of Pritam Singh, resident of Ward No. 02 Simbal Camp, Miran Sahib regarding theft of Motorcycle (JK02AF-9281) in the area. In this case FIR No. 76/2023 under section 379/IPC Act was



registered at Police Station Miran Sahib and investigation started. During questioning the accused persons confessed their involvement in above said case and on their disclosure stolen motorcycle has been recovered along with other two wheelers Motorcycle bearing registration no JK02AT-1640; Motorcycle bearing registration no JK02AV-7725; Scooty bearing R.No. BB-9872; 6 Water Pump Motors and 2 Iron grills recovered from their possession .

The overall operation was done under the supervision of SP Hqrs Ramnish Gupta.

# 4 notorious drug smugglers booked under PIT NDPS Act; PSA slapped on 2 notorious thieves

SRINAGAR: Continuing its efforts to eradicate the menace of drugs from the society, Police have booked 04 notorious drug peddlers under PIT NDPS Act, besides two (02) notorious thieves have also been booked under PSA for their involvement in many cases, in Baramulla.

The four notorious drug peddlers are identified as Habeel Yaseen Dar alias Rouf son of Mohd Yaseen resident of Tarhama Kunzer, Ab Rehman Malik @ Rehman Military son of Ghulam Mohammad resident of Kalantra Payeen Kreeri, Shahnawaz Ahmad Mir @ Boja son of Matwali Mir resident of Daragutliyan Uri & Hafeez Ahmad Khan son of Mohd Abass resident of Rehsiwari Niloosa Baramulla. They have been booked under PIT NDPS Act after obtaining formal detention orders from the competent authority & subsequently lodged in Central Jail Kot-Balwal Jammu.

It is pertinent to mention that many cases are registered against these drug peddlers and they were involved in promoting drug trade by supplying drugs to local youth of Kunzer, Kreeri Wagoora, Uri, Bijhama and other areas of District Baramulla. Despite their involvement in many FIRs, they did not mend their activities and were again involved in promoting drug abuse trade by supplying drugs to local youth.

The two notorious thieves are identified as Syed Zaffar Shah @ Zaffar son of Mohd Muzaffar Shah & Fida Hussain Khanday @ Fida son of Gh Mohammad Khanday, both residents of Devar Yakhmanpora Baramulla and were detained under Public Safety Act by Police after obtaining formal detention orders from the competent Authority and subsequently lodged in Central Jail Kot Bhalwal Jammu.

It is pertinent to mention here that many cases are registered against these thieves and were involved in theft cases in Pattan area of District Baramulla. Despite their involvement in many FIR's, they did not mend

## 4 drug peddlers arrested; contraband recovered state times news

SRINAGAR: Continuing its unwavering efforts to eradicate the menace of drugs from the society, police on Tuesday arrested 4 drug peddlers in Kulgam & Sopore and recovered contraband substances from their possession

In Kulgam, a police party led by SHO Police Station Yaripora at a check-point established at Kanjikulla Crossing intercepted a suspicious person. During search, 04 grams of Heroin like substance was recovered from his possession. He has been identified as Shabir Ahmad Wani son of Ghulam Rasool Wani resident of Wongipora Harmain, Shopian. Meanwhile, at another checkpoint established at Matibugh, a police party intercepted a suspicious person identified as Mohd Iqbal Shah son of Mohd Amin Shah resident of Munnad. During search, 04 grams of Heroin like substance was recovered from his possession.

Moreover, a police party led by SHO police station DH Pora at a checkpoint established at Village Yaroo intercepted a suspicious person who after noticing police party tried to flee from the spot but was apprehended tactfully. During search, 130 grams of Cannabis Powder like contraband substance was recovered from his possession. He has been identified as Mohd Shafi Sheikh son of Ali Mohammad Sheikh resident of Yaroo.

In Sopore, a police party of Police Post Warpora during patrolling at Dangerpora intercepted a suspicious person at Umerabad who tried to escape while noticing Police Party but was apprehended tactfully. During search, 1Kg 222grams of charas like substance was recovered from his possession. He has been identified as Showkat Ahmad Sofi son of Ab Satar resident of Rajbagh Dangerpora. Pertinent to mention here that the accused is a notorious drug peddler and was carrying the contraband substance for calling it to the reach of Rajbagh Dangerpora.

# Delinquent who attacked fellow students by knife arrested

GANDERBAL: Police arrested a delinquent who attacked fellow students by Knife in Ganderbal on Tuesday.

Yesterday at about 1500hrs, a scuffle broke out between two groups of Dreamland school Beehama, Ganderbal wherein one student namely Zahid Shabir son of Shabir Ahmed resident of Bandybagh, Ganderbal attacked two fellow students by sharp object/knife resulting in injuries to both of them. Both the injured students, identified as Hidayat Ahmed and Ibrahim Ahmed, both the residents of Beehama, Ganderbal were immediately shifted to SKIMS Soura for treatment. Zahid who attacked his fellow students fled away from the spot.

Accordingly, a case FIR No. 116/2023 under relevant sections of law was

registered in Police station Ganderbal and investigation was initiated. During the course of investigation, a team was constituted under the supervision of DySP PC Ganderbal and were deputed to arrest the accused. After strenuous efforts, Police team caught the accused near Baroosa. During further investigation, it came to fore that the incident took place over minor issues and some more students were involved in scuffle. Zahid who is student of class 12th of Dreamland school has been aggressive since the beginning and as per school principal, he was involved in multiple fights with other students in past also.

With all the legal procedures and formalities, the delinquent will be produced before Juvenile Board and other students who were involved in the scuffle will also be brought and produced before the board.

## Theft cases worked out; 2 juveniles among 4 arrested

NOWSHERA: Police on Tuesday has worked out two theft cases of police station Rajouri recovering stolen property worth lakhs of rupees.

Police said to have recovered Gold Ornaments worth rupees one lakh (Approx) with further investigation in the case is going on.

# Mortar shell recovered along LoC in Rajouri state times news

RAJOURI: A 120 mm mortar shell was found along the Line of Control (LoC) in Rajouri district, officials said on Tuesday. Some villagers saw the shell lying at a river bank in Kalal border area and informed the police on Monday night, they said. A bomb disposal squad of the Army was called in and the shell was destroyed through a controlled explosion, they said.
