**Kathua blind robbery case: police team leaves Kota to nab arms supplier**

KATHUA: in blind robbery case which was solved by the Rajbagh police, two arrested accused are being interrogated and police teams have been launched manhunt for the third accused. The two accused who have been arrested were identified as Prince Kapoor resident of Ward No 7 Samba and Rakesh Kumar resident of Pouni. Many things have come to light during the interrogation in which it was learned that after absconding from the court, Prince had absconded with the arms supplier in Kota and stayed with him for a long time. The arms supplier is also the brother-in-law of one of the accused who is currently lodged in jail outside the state. Police will go to Kota to arrest the arms supplier in this case.

As per case, on May 18, FIR Ni 134 was registered at Rajbagh Police Station in which complainant Amit Kumar who is the owner of Krishna Building Material located in Chadval stated that on the night of May 17 at around nine o'clock, his brother Mohit Gupta was robbed by placing a pistol. He told that three people were involved in the robbery after which police arrested two accused with weapons.

Pacea Danga police have registered a case in this context and started investigation.

According to information, there was a scuffle between 3 prisoners over watching TV in Ambphala Jail. In scuffle two prisoners identified as Dilbagh Singh, son of Janak Singh, resident of Simbal Camp and Bhupendra Singh, son of Amrik Singh, resident of Chak Mohammad Yar attacked Pupendra Singh, son of Tirath Singh, resident of Akali Kaur Singh Nagar. At first the matter started with debate and then came to scuffle. After that, both the prisoners caught hold of the third one and hit him on the head with a stick. The jail staff reported the matter to Pacea Danga Police which reached the spot and shifted injured prisoner to the hospital. The police have registered a case regarding this incident.


Pertinent to mention here that, FIR No. 126 was registered in Miran Sahib Police Station in the year 2022 against two prisoners who attacked Pupendra in which a case of snatching along with attempt to murder is registered against him. FIR number 77 of the year 2021 was registered in Arnia against the second accused Bhupendra Singh. A case of attempt to murder has also been registered against him. While a case was registered against injured Pupendra Singh at Gandhi Nagar police station. All three are under trial prisoners.

**Theft case solved; 3 arrested, stolen items recovered**

KATHUA: In continuation to the drive launched by district Police against Thief/Theft cases, Kathua Police on Tuesday solved a theft case by arresting 3 thieves and recovered stolen steel items of "Megha Engineering and Infrastructure Limited" (MEIL) from the offenders who were involved in the offence in the limits of Police Station Kathua.

As per details, on May 25, 2023 a complaint was received at Police Station Kathua through the complainant namely Narinder Singh Jasrotia, son of Anant Singh, resident of Upper Saraswati Vihar Kalibari Kathua reported that three persons namely Billu, son of Roshan Din and Gagi, son of Amu and Alam, son of Shah Din, all residents of Village Tarara Tehsil Kathua has stolen below mentioned steel items from his project "Megha Engineering and Infrastructure Limited" (MEIL) i.e 1. 10 mm Steel = 02 Bundles Full 2. 08 mm Steel=04 Bundles Full 3. 20 mm Steel= 06 Metre(30Number) 4. U Yekh = 40 Number 5. Base Yekh = 65 Number 6. Welding Lead = 04 Metres measuring approximate value of Stolen property Rs. 46,000 for which a case was registered at Police Station Kathua in connection with theft vide FIR No. 229/2023 under section 379/IPC. Acting on the tip off, police party led by Insp. Sudhir Sadhotra SHO Kathua rounded up all three above mentioned suspects for interrogation. During sustained questioning, the said persons confessed their involvement in said crime and police team recovered all the stolen property from them which they concealed at somewhere. Thereafter all the recovered stolen material was seized alongwith three thieves were arrested on spot whereas further investigation of the case is going on.
