JAMMU: Several anti-Pakistan protests against the martyrdom of five elite para commandos by terrorists were staged across Jammu for the second day on Saturday as DPAP chairman Ghulam Nabi Azad called for necessary measures to stamp out terrorism from Jammu and Kashmir.

Shiv Sena Dogra Front, Rashtriya Bajrang Dal and IkkJutt Jammu also staged separate protests in the city, demanding action against Pakistan to avenge the martyrdom of the troopers.

"The latest martyrdom of five soldiers is the third major incident in Rajouri district this year. Though the overall security situation is under control and militancy is almost finished, the incidents in Rajouri and Poonch belt are a cause of concern for all of us," Azad, a former chief minister, told reporters on the

SIA Jammu executes proclamation proceedings against HM terrorist

JAMMU: In a major action by the State Investigation Agency (SIA) Jammu executed proclamation proceedings U/S 82 CrPC against Hizb ul Mujahideen terrorist Mohd Hussain Khateeb by affixing posters of the absconding accused at his residence at Masjid Mohalla and other conspicuous places at Bhadarwah Doda after getting the proclamation orders issued from the Hon'ble court. Absconding accused Mohd Hussain Khateeb, the HM terrorist from Bhaderwah is wanted in case FIR No. 73/2023 in which an Ex Minister Jatinder Singh alias Babu Singh is already facing trail while lodged at Central Jail Kot Bhalwal Jammu.

Accused Mohd Hussain Khateeb has been granted a period of 30 days by the court in its proclamation order to appear before the Hon'ble to face trail. If the accused fails to cause appearance before the court within the period of 30 days proceedings under section 83 CrPC shall be launched against him that is his property will be attached.

This is one of the major actions of the SIA Jammu against the absconding accused in case FIR No. 73/2023 of Police station Gandhi Nagar/SIA Jammu under sections of Unlawful Activities (Prevention) Act. Special drive carried out in Jammu to check illegal supply of psychotropic drugs

JAMMU: To prevent illegal supply of addictive synthetic drugs, a special team of drug controllers on Saturday conducted surprise checks at godowns of various courier service providers in Jammu, officials said.

Officials said Drugs And Food Control Organisation sleuths also cross-checked whether the pharmaceutical consignments were being transported to Jammu and Kashmir as per the rules.

They said drugs worth Rs 90,000 that were being transported in contravention of the rules were seized on the spot. Notices have also been served to the defaulters and licenses of a couple of firms have been cancelled.

The officials said representatives of courier service providers were told to follow the SOPs when handling pharmaceutical products and inform the department regarding suspicious con-

State drugs controller Lotika Khajuria said illegal flow of habit-forming drugs supplied from other states. either manufacturing states or consumer states have emerged as a "big challenge".

The department has issued strict instructions that the purchase, sale and distribution of certain habit-forming drugs could not be done without a written order of the purchaser.

The trade fraternity has once again been impressed upon not to procure lesserknown brands of such drugs directly from outside the Union Territory, Khajuria said.

Drugs Controller Deputy Jammu, M I Palla said the administration has constituted committees to keep a check on trafficking of habitforming drugs so that the public at large could be safeguarded from intoxication.

The field functionaries have been directed to keep strict vigil on movement of such drugs and checks are being conducted randomly in this perspective, he said.

DB dismisses appeal of PDD, directs to pay Rs 10 lakh as compensation to petitioners officials/officers of Power

JAMMU: In an appeal filed by UT of J&K against judgment of writ Court whereby it was held that petitioners are entitled to compensation of Rs 10 lakh on account of death of one Vijay Kumar Gupta, i.e., husband of petitioner 1, father of petitioners 2 and 3 and son of petitioner 4, a Division Bench of Jammu & Kashmir and Ladakh High Court comprising Justice Tashi Rabstan and Justice Puneet Gupta, after hearing both the sides, observed that when writ respondents failed to consider claim of writ petitioners for grant of compensation on account of death of Vijay Kumar Gupta due to electrocution due to negligence of

Development Department (PDD), the writ petitioners had no option but to approach the Court. The writ petition came to be filed in 2008 and during pendency of the petition the Government has issued order No.454-F of 2019 dated October 24, 2019 enhancing the compensation in such cases from Rs 3 lakh to Rs 10 lakh. The writ petitioners have been hankering for getting the compensation for last more than fourteen years and, in these circumstances, the writ petitioners are entitled to the higher amount in terms of order dated October 24, 2019. Further, the writ respondents perhaps have forgotten that the deceased at the

time of his death was only 48 vears old and was an income tax payee. Also, order dated October 24, 2019 is a beneficial order issued by the Government in larger public interest with an objective to provide dignified/sufficient monetary support to the families of such victims so as to save them from living a destitute life. Moreover, from 2008 to 2023, the inflation has raised manifolds. Therefore, the Single Judge was right in allowing interest at the rate of 6 per cent from date of filing of this petition. With these observations, the DB, while upholding judgment of Single Judge, did not find any merit in the appeal and dismissed the same

SRINAGAR: The Jammu and Kashmir Police on Saturday conducted a search at the house of a Hizbul Mujahideen terrorist in Kulgam district, officials said. The search operation was carried out by the Special Investigation Unit (SIU) of the Jammu and Kashmir Police as part of its crackdown on terror elements, they said. SIU Kulgam conducted a search at the residential premises of Abdul Gani Bhat, father of terrorist Farooq Ahmad Bhat alias Nali, at Chek Desen Yaripora, a police spokesperson said. Bhat is

an active terrorist of the proscribed terror outfit HM and is wanted in several terror-related cases, he said. The search was conducted after a special judge of a designated National Investigation Agency (NIA) court in Kulgam issued a search warrant in one of the cases, the spokesperson said. The case pertains to the killing of five non-local labourers at Katrosa Kulgam in 2019. The SIU is investigating the case and has been conducting searches and investigations to bring the perpetrators to justice, he added.

CUTTACK:

CJI DY Chandrachud on Saturday said live streaming of court proceedings has flipside and judges need to be trained as every word they say is in the public realm in the age of social media.

Addressing the National Conference on Digitisation, Paperless Courts and e-initiatives at the Odisha Judicial Academy here, СЛ Chandrachud said courts across the country are likely to become paperless soon.

"We have been using Artificial Intelligence (AI) for transcription of the proceedings of the Constitution Bench of the Supreme Court. The transcript is provided to lawyers to clean up any errors," he said.

"AI is replete with possibilities. How do you expect a judge to digest the evidence in a statutory appeal in a record involving 15,000 pages? AI can prepare the entire record for you," he said, adding that many courts across the world were

experimenting with AI. However, Chandrachud said AI has a flip side as well.

"For instance, it would be very difficult in allowing artificial intelligence to tell us what sentence to hand down following a conviction in a criminal case," he said.

The CJI said most high courts in the country are livestreaming proceedings.

"There are clips on YouTube of a Patna High Court judge asking an IAS officer why he was not appropriately dressed,

or a Gujarat HC judge asking a lawyer why she was not prepared with her case," he said.

In the same vein, he said. "Many funny things are going on in YouTube which need to be controlled, because this is serious stuff and what happens in the court is extremely

The CJI said that live streaming has a flipside as well, and judges need to be trained as every word that they say in court is in the public realm in the age of social

"We realise this when we live stream constitution bench arguments," he said.

Very often citizens don't realise that what judges say in the course of a hearing is to open a dialogue, he added.

The CJI said the purpose of pitch-forking technology is not to place the justice system away from the people but to reach out to the common citizens of the country.

"The digital infrastructure we intend to create is firstly paperless courts. Secondly, virtual courts and Delhi has been leading in virtual courts particularly in the area of traffic challans," he said. The total outlay for phase 3.

No legal system can have scenario where one keeps raking up resolved issue repeatedly: SC

DELHI: Supreme Court has said that no legal system can have a scenario where someone keeps on raking up an issue repeatedly once it is resolved at the highest level and termed it a "complete wastage of the judicial time".

The remarks came as the apex court dismissed with a cost of Rs 10,000 a plea filed by a man noting that he was dismissed from service and the matter stood closed in 2004.

It noted that a review petition in the matter was also rejected. A bench of Justice S K

Kaul and Justice Aravind Kumar said the petitioner has not filed a curative plea but a writ petition under Article 32 of the Constitution claiming that injustice has been done to him and the matter should

Article 32 Constitution gives individuals the right to move the Supreme Court for justice when they feel their fundamental rights have been infringed.

"No legal system can have a scenario where a person keeps on raking up the issue again and again once it is resolved at the highest level. This is a complete waste of judicial time," the

bench said in its order passed on May 1.

We, thus, dismiss this petition with costs, though we limit the amount of cost considering the petitioner is a dismissed person," it said.
