'Operation Trinetra' mountains to flush-out hiding terrorists continues

RAJOURI: Security forces continued 'Operation Trinetra' for fourth consecutive day on Monday to track down terrorists hiding in Kandi forested area in Rajouri district, officials said. A few persons were questioned about suspected movements of terrorists. However, security forces are yet to establish any fresh contact with the ultras, they said. "There was no fresh contact with terrorists hiding in the forested Kandi area. A massive search operation to track down ultras is on," an official said. Five Army personnel were martyred while a major-rank officer was injured in an explosion triggered by the terrorists in the Kesari hill forest area of Rajouri on Friday morning. A terrorist, who is said to be the part of a group that carried out an attack on civilians in Dangri village of Rajouri early this year, was killed the next morning. His associate was believed to have been injured in the exchange of fire with security forces but managed to slip away, the officials said. The operation code named 'Trinetra' is continuing when the last reports were received, they said. he security forces carrying the operation were armed with surveillance equipment, sniffer dogs, drones and metal detectors, the officials said.

8 drug peddlers arrested; psychotropic substances recovered

SRINAGAR: Continuing its efforts to eradicate the menace of drugs from the society, police have arrested 8 drug peddlers in Ganderbal, Sopore & Budgam and recovered psychotropic substances from their possession. In Ganderbal, a police party led by In-charge Police Post Shadipora at a checkpoint established at Waskoora intercepted a vehicle (Scorpio) bearing registration number JK01V-7981 driven by Ajaz Ahmad Malik son of Manzoor Ahmad Malik resident of Waskoora. During search, huge consignment of psychotropic substances including 140 codeine phosphate bottles kept hidden under the window cardboard of the said vehicle were recovered & seized. Vehicle used in the commission of the crime has also been seized.

In Sopore, a police party of Police Station Tarzoo at a checkpoint established at Ningli Bala Nambal intercepted a vehicle (Santro) bearing registration number DL3CAB-3898 with 06 persons on board who tried to flee from the spot but were apprehended tactfully. During search, 888 capsules of SpasmoProxyvon were recovered from the vehicle. They have been identified as Muhammad Ibrahim Sofi son of Muhammad Sultan and Zubair Ahmad Bhat son of Abdul Rashid Bhat, both residents of Aalibagh Hygam, Tanveer Ahmad Sunji @ Pintoo son of Farooq Ahmad Sunji resident of Sher Colony Sopore, Inmran Manzoor Guroo son of Manzoor Ahmad Guroo resident of Khushal Colony Sopore, Arshad Rashid Wani son of Abdul Rashid Wani resident of Izzat Shah Colony Sopore and Shabir Ahmad Bhat son of Ali Mohammad Bhat resident of Amargarh Sopore. Vehicle used in the commission of the crime has also been seized.

In Budgam, a police party of Police Post Soibugh at a checkpoint established at Harran, intercepted a vehicle (Ford Eco-sports) bearing registration number DL10CT-4968 driven by Nisar Ahmad Sheikh son of Ghulam Nabi Sheikh resident of Sector D Hamdaniya Colony Bemina. During search, 330 strips of Tapentadol (3300 tablets) and 25 strips of Spasmo-Proxyvon (200 capsules) were recovered. Vehicle used for commission of crime has also been seized. Preliminary investigation reveals that the said accused person is a chronic drug peddler & he was selling the illegal drugs among the youth of district Budgam. Various FIRs have already been registered against him in different police stations in district Srinagar.

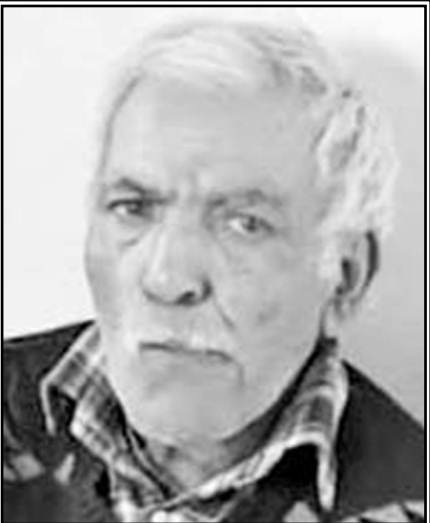
SHRADHANJALI
