and Kashmir over the past couple of days, triggering landslides at many places and raising the level of water bodies. At least two dozen residential houses were also damaged in Kishtwar and Ramban districts.

In the Poonch district, four school children and two women were rescued by locals after they were left stranded due to flash floods in a stream when they were attempting to cross at Kalar Moda village in the Mendhar area on Monday evening, they said. With the improvement in weather conditions on Tuesday, the officials said the restoration work on the Jammu-Srinagar national highway was intensified to ensure its early opening for vehicular traffic.

The traffic on the 270-km highway, the only all-weather road linking Kashmir with the rest of the country, was suspended from both the twin capital cities of Jammu and Srinagar on Monday following landslides, mudslides and shooting stones at several places including Mehar, Panthiyal, Moum Passi and Kishtwari Pather.

The Chief Secretary enquired from the divisional and district administrations about the relief and restoration measures being carried out by them for the affected population. He asked about the status of transit accommodations provided to the families relocated in Pernote area of Ramban district. He asked for making adequate arrangements of bedding, food, drinking water, electricity, medical aid, sanitation and other amenities at the transit accommodations. He called for making joint efforts to bring immediate relief to the affected people as per the norms of the government

He also sought inputs from the divisional and district administrations about the status of services operational in the affected area. He asked the officers to explore the possibility of establishing road link with the cut-off areas on war-footing basis for ensuring smooth supplies besides catering to medical emergencies

The Chief Secretary took stock of the damage caused to power and water infrastructure besides assessing the status of health services and ration distribution through different healthcare facilities and Fair Price shops respectively in the area. He called upon the concerned to take up requisite steps to restore the infrastructure simultaneously making alternative arrangements till its full restoration.

The meeting also held deliberations on rehabilitation of the affected population. The Divisional Commissioner and concerned DC were tasked to prepare a proper rehabilitation plan considering the ground situation. They were even asked to take SDRF and Red Cross on-board for providing instant succor to the displaced people.

The local administration informed about the measures being taken for the affected people. It was informed that around 90 families having nearly 413 souls have been relocated by the administration in safer locations. Besides, transit accommodations were established at three locations including Panchayat Ghar and two community halls situated in village Pernote.

It was also revealed that the arrangements for movement of Light Motor Vehicles (LMVs) to and from Gool Sub-District have been done via Mahore, Reasi besides establishment of a reliable link will also be done at an earliest.

Moreover, it was informed in the meeting that the administration is carrying out study of the area through Indian Institute of Technology (IIT) and Geological Survey of India (GSI), to ascertain the causes behind the land sinking in Ramban and recommend the preventive measures thereof.

Meanwhile, the water level in river Jhelum late at night also crossed the flood declaration mark at Sangam in Anantnag district but when the rains stopped around 11.00 pm, the water level is receding now, officials said.

Incessant rainfall since Friday have caused the water bodies in Kashmir to swell with the Pohru Nallah in the Kupwara district overflowing the banks, resulting in flash floods in the frontier district.

National Conference leader Omar Abdullah visited the flood-affected areas in Kupwara and urged the government to compensate the losses suffered by the victims of the deluge in the area.

"It seems we have not learned any lessons from 2014. The climate is changing. Places like Dubai, which is a desert, received rainfall equivalent to 18 months in just ne day. We will have to change ourselves according to the changing climate

"Besides providing compensation to the victims, the government should take meas-

ures to effectively deal with such eventualities," he said. People's Conference leader Sajad Lone also visited the flood-affected areas of

Kupwara and Handwara.

electromagnetic spectrum and information. Consequent to these developments, onventional force ratios, which was the measure of military strength and superiorty in the past, stand blunted today," he said.

Gen Pande said the growing centrality of cyber domain in critical infrastructure

has resulted in it emerging as a new battleground of digital confrontation. "Information operations today have gained new dimensions," he said.

When we talk about digitisation of the battlefield, we are witness to a manifold

ation of technologies such as artificial intelligence, quantum computing, robotics and nano-technology," he said.

The Army chief said disruptive and dual use technologies and their proliferation at unprecedented scale are transforming the character of modern wars.

"A suite of digital technologies, encompassing electronic warfare, micro-electronics, drones, precision attack systems, loiter munitions and star link terminals are challenging traditional force multipliers," he said.

"Swarming is contesting surging, surveillance and precision are scoring over fire and manoeuvre, and the light and small are prevailing over the large and heavy," he

Gen Pande said his force has been focusing on developing indigenous capabilities. "The Indian Army on its part, stands committed to achieve its capability development and sustenance needs through Atmanirbharta," he said.

"Modernisation and technology infusion forms one of the five pillars of the transformation roadmap, which we had put into effect, almost two years ago," he added. The Army chief, while underscoring the thoughts of Gen Sundarji on transformation, asserted that his force is alive to the imperative of transformation.

"It is with a progressive outlook that we intend to not only change, but to change at a good pace too. The holistic transformation of the Indian Army, that we put into effect two years ago, is part of our efforts to give shape to a modern, agile, adaptive, technology enabled and self-reliant future ready force," he said.

Gen Sundarji was the Army chief from February 1, 1986 to May 31, 1988. He is known for his deep insights and strategic foresights into future warfare and securi-

On the issue of reservation, he pointed out that the provision of quota in jobs and education made in the Constitution for underprivileged sections of society cannot be scrapped.

"Reservation cannot be taken away even if (chief Constitution framer) Babasaheb Ambedkar were to appear in person. But Congress wants to curtail the SC, ST reservation and give it to their vote bank," he alleged.

Speaking at another rally in Dharashiv, the PM said political rivals who are unable to take on the BJP-led government are now misusing technology to circulate fake videos on social media.

"Now their condition is such that as their lies aren't working, they are using my face and with the help of artificial intelligence technology, selling fake videos in their "mohabbat ki dukaan" (shop of love - a slogan given by Rahul Gandhi). This shop of lies must be shut down," Modi said.

"Opponents are using artificial intelligence to distort quotes of leaders like me," he

At his rally in Malshiras town of Solapur district. Modi, a day after termin Sharad Pawar as a "wandering soul", continued his attack on the veteran politician, saying he did not do much for farmers as Union agriculture minister (2004-14), and added it was now time to punish him.

He taunted the opposition Congress, saying it was not able to field even 275 candidates in the ongoing Lok Sabha elections, and appealed to people not to waste their vote by supporting the grand old party.

The first criminal case against Sheikh, who hails from Anantnag district, was reg-

istered in 2015 in Pampore police station of Pulwama district.

One of the criminal cases filed last year against the 37-year-old candidate include charges under section 11 (enticing a child for pornographic purposes or giving gratification there for) and section 12 (committing sexual harassment upon a child) of the POCSO Act.

Sheikh has also been booked in 2022 under section 309 (attempt to commit suicide and any act towards the commission of such offence) of the Indian Penal Code (IPC).

Most of the cases registered against Sheikh are under section 420 (cheating and dishonestly inducing delivery of property) of the IPC but several of these cases have additional charges, including under section 201 (hiding or destroying evidence of a crime, knowing or believing that the offense has been committed, with the intention of protecting the offender from punishment) and section 380 (theft in dwelling house) of the IPC.

The other two cases are booked under sections 454 (offence in respect of lurking house-trespass or house-breaking in order to commit offence) and section 419 (cheating by personation).

Seven of the 20 cases against the Independent candidate have been registered in Saddar police station in Anantnag with six of those filed in 2022.

Sheikh is accused of committing criminal offences in Banihal area of Ramban district, Ram Munshi Bagh area of Srinagar district as well as Qaimoh area of Kulgam According to the affidavit, charges have not been framed in court in any of the

cases against Sheikh so far. The affidavit also showed that both he and his spouse have PAN cards but none of

them has filed income tax returns for the past nine years.

Shiekh has claimed that he works as a labourer and has an income of Rs 12,000 but has not specified whether it is his monthly or annual income. He has declared

Rs 50,000 cash in hand, while his wife holds Rs 10,000. Interestingly, he also owns two vehicles with a cumulative declared value of Rs 4

There are two other candidates - both Independents - who have criminal cases reg istered against them. Sajad Ahmad Dar from Kulgam had a case registered agains for rioting in 2014 but charges have not been framed so far.

Twice PSA was also slapped against him and he was lodged in jail. In 2019, Ravinder Kumar @ Ravinder Gupta @ Gola Shah was arrested by

Crime Branch, Jammu in FIR 19/2011 U/S 420, 467, 468, 471, 120-B/RPC. During the investigation he was summoned several times to cooperate in the inves tigation of the case. But he kept on evading the calls of the Investigating Officers.

In the meanwhile he approached the Court and got bail on August 16, 2019. Despite the Court order, Gola Shah did not bother to come to the Investigating Officer for completing the bail formalities as well as in cooperating the investigation

On 22nd August, 2019, the Investigating Officer submitted report of the case sought by the Court along with past conduct of the accused - Ravinder Kumar @ Ravinder Gupta @ Gola Shah who is a notorious land grabber criminal, having trai of 20 FIRs against him. He is a history sheeter in Police Station Gangyal. In 2006 when land grabbing incidences by Gola Shah started growing out of control, the then District Magistrate Jammu slapped arrest warrants under PSA against him Additional Sessions Judge again directed the accused to immediately cooperate in the investigation of the case. On August 23, 2019, Gola Shah was arrested and put to sustained questioning for conducting the investigation to a logical end.

On May 27, 2022, Notorious land grabber Ravinder Gupta alias Grabber Of Land Association (GOLA) Shah was again arrested by Gangyal Police under Public Safety Act (PSA).

Jammu police, soon after the orders of the District Magistrate Jammu, shifted him to Central Jail Kot Bhalwal.

FIR 53/2022 u/s 420, 467, 468, 504, 506, 379 IPC was registered against Gold Shah following a complaint filed by Kamal Nabh Sharma, son of Late Hans Raj resident of H. No: 123, Peer Mitha, Jammu, wherein he has stated that Gold Shah has allegedly grabbed his plot at Greater Kailash.

Over 22 FIRs related to land grabbing, cheating and fraudulent deals are already registered against Gola Shah in various police stations of Jammu and Kashmir.

Cong MLA's close aide, AAP leader held for sharing fake video of Amit Shah

of money in lieu of fake plots and land grabbing.

AHMEDABAD: The Gujarat police on Tuesday said they have arrested a Congress leader and an Aam Aadmi Party (AAP) functionary for allegedly sharing Union Home Minister Amit Shah's deep fake video, in which he is purportedly seen announcing the curtailment of reservation rights of the SCs, STs and OBCs.

The Ahmedabad Cyber Crime Cell arrested the two persons, identified as Satish Vansola, a resident of Palanpur in Banaskantha and Rakesh Baria from Limkheda town of Dahod district, the police said in a release.

A preliminary probe revealed that Vansola has been working as the Personal Assistant (PA) of Congress MLA Jignesh Meyani since the last six years, while Baria has been serving as the AAP's Dahod district president since the last four years, it said.

Vansola, who belongs to the Dalit community, also serves as the general secretary of Banaskantha district Congress.

The duo was booked under section 153A (promoting enmity between different groups) and 505(2) (statements creating or promoting enmity, hatred or ill-wil between classes) of the Indian Penal Code (IPC).

The release said the duo had uploaded the edited video of Amit Shah's speech with an intention to create enmity between reserved castes and unreserved castes in view of the upcoming Lok Sabha elections.

"Both of them had shared this edited video of Amit Shah on their Facebook pages They received this video on their WhatsApp and investigations are still on to nab the person who had edited this video," said Deputy Commissioner of Police, Cyber Crime, Lavina Sinha
