# NDA needs more than 400 seats in LS elections to implement UCC in country: Himanta

BEGUSARAI (BIHAR) Minister Assam Chief Himanta Biswa Sarma on Saturday said the NDA needs to win more than 400 seats in the Lok Sabha polls to implement the Uniform Civil Code (UCC) in the country and to construct a grand temple at the Krishna Janmasthan in Mathura.

Addressing an election rally in favour of senior BJP leader and Union Minister Giriraj Singh in Begusarai, slammed the Congress and its allies for "raising question mark" on Pakistan-occupied Kashmir (PoK).

He said, "... The NDA under the leadership of Prime Minister Narendra Modi has to win 400 plus seats to implement the UCC in the country, for the construction a grand temple at Krishna Janmasthan in Mathura and also to ensure PoK, which is a part of India, returns to India."

The UCC means having a common law for all citizens



of the country that is not based on religion. Personal laws and laws related to inheritance, adoption and succession are likely to be covered by a common code.

Hitting out at the Congress and its allies, Sarma said, "Congress leader Rahul Gandhi and RJD supremo, Lalu Prasad, did not attend Pran Pratishtha of the Ram Lalla at Ayodhya. Let me make it very clear that neither Rahul nor Lalu will ever be able to visit Ram temple in Ayodhya ..."

The Assam CM accused the Congress of giving religion-based reservation.

"They (INDIA alliance leaders) are indulging in polraise issues that support Pakistan. Congress leader Mani Shankar Aiyar recently said that India should not raise the PoK issue and respect Pakistan as it possesses an atom bomb. Even if Pakistan has a nuclear bomb, I am confident that it must have passed its expiry

"Our government at the Centre has made it clear that PoK belongs to India and no force can snatch it. We have to give a third term to Modi Ji to ensure that PoK returns to India. Since the government has removed article 370 from Jammu and Kashmir, it will

ensure PoK returns to India in the coming days," said

The NDA needs to win more than 400 seats in the Lok Sabha elections to save the quota granted to the OBCs, SCs and STs, he said.

"The Congress gave reser-

vation to Muslims by reducing the quota of OBCs/STs and SCs in Karnataka and other states and it now plans to replicate this across the country. Mamata Banerjee... Congress and RJD are the biggest enemy of OBCs... Religion-based reservation should be given to Muslims in Pakistan, not in India. The NDA will not allow this at any cost," he said.

# Uttarakhand High court asks govt to find suitable site for its relocation out of Nainital

NAINITAL: Uttarakhand High Court has asked the state government to find within a month a suitable place to shift its premises out of Nainital saying its relocation is in larger public interest.

"Considering the larger public interest, it is necessary to shift the High Court from Nainital," a division bench of the high court comprising Chief Justice Ritu Bahri and Justice Rakesh Kumar Thapliyal said on Friday.

The bench asked the Chief Secretary to select a suitable place for the High Court within a month. It also directed the Registrar General to create a portal to take suggestions from advocates and the general public on the issue.

The next hearing in the matter has been scheduled for June 25.

On the state government's earlier proposal for shifting the High Court to Gaulapar in Haldwani, the high court

observed that the land earmarked for the purpose had 75 per cent forest cover and construction in the area would lead to deforestation.

The high court also made a few recommendations for the kind of land required for its relocation and facilities, including proper accommodation for judges, judicial officers, staff and court rooms.

The selected area must have adequate space for facilities such as chambers, canteen, parking and conference hall to accommodate at least 7,000 lawyers, the bench said.

The area should be near

medical facilities and goodconnectivity, it added.

The Uttarakhand High Court had directed the state last week to explore the possibility of moving a bench of it to Indian Drugs

Pharmaceuticals Limited, Rishikesh which is now closed but has a sprawling campus spread over hundreds of acres on which former IDPL employees have their residences.

The high court's decision to shift its premises has drawn a lot of resistance by the bar association.

## SC grants bail to ex-cop Pradeep Sharma in 2006 fake encounter case

NEW DELHI: The Supreme Court has granted bail to for-Pradeep Sharma, awarded life sentence in the 2006 fake encounter killing case of gangster Ramnaravan Gupta alias Lakkhan Bhaiya..

A bench of Justices Hrishikesh Roy and Prashant Kumar Mishra noted the submission of the lawver for the Maharashtra government that the state had no objection to the court granting bail to Sharma.

Senior advocates Mukul Rohatgi and Sidharth Luthra appeared for Sharma, while senior advocate R Basant represented the complainant and opposed the former officer's bail application.

The top court had earlier on April 8 said he need not surrender till further orders to undergo the life sentence awarded to him in the case.

While admitting Sharma's appeal against the March 19 Bombay High Court verdict, the bench had said, "It is a case



of reversal of acquittal by the high court, where the appeal is filed by the appellant. The statutory appeal is admitted for hearing. Issue notice on bail plea. The high court has directed him for surrender in three weeks. Till the next date of hearing, he need not surrender."

Sharma, who along with the likes of Daya Nayak, Vijay Salaskar and Ravindra Angre was part of a dreaded squad of Mumbai police that took on the city's underworld in the 1990s and 2000s and killed scores of alleged criminals, has challenged the Bombay High Court order which sentenced him to life imprisonment in the fake

killing encounter Ramnarayan Gupta, an alleged close aide of gangster Chhota Rajan

On March 19, the high court had upheld the conviction and life sentence imposed on 13 other accused-12 former policemen and a civilian. said

"protectors/guardians of law cannot be permitted to act as criminals in uniform and if this is permitted then it would lead

The court noted that the prosecution has proved beyond reasonable doubt the abduction. wrongful confinement and killing of Gupta in a fake encounter with "credible, cogent and legally admissible evidence".

judgement passed by a sessions court acquitting Sharma due to the lack of evidence and termed it "perverse and unsustainable".

The high court had convicted Sharma of all charges, including criminal conspiracy, murder, kidnapping and wrongful confinement, and sentenced him to life imprisonment.

Sharma is also an accused in the of killing of businessman Mansukh Hiren to whom the SUV used in the Antilia bomb scare case was traced. Hiren had, however, reported to police that the vehicle had been stolen days before the incident. His body was found floating in a creek off a Mumbai suburb a few days after the incident.

On November 11, 2006, a police team picked up Ramnarayan Gupta alias Lakkhan Bhaiya from Vashi in Navi Mumbai along with his friend Anil Bheda, and killed him in a staged encounter near

Versova in western Mumbai the same evening.

Gupta's associate Anil Bheda was released from custody in December 2006.

However, in July 2011, a few days before he was scheduled to depose in court, Bheda was also allegedly abducted and killed. The state CID is probing the

Taking note of Bheda's case, the high court had said till date, the CID has not taken any steps to conclude the investigation and trace the perpetra-

Twenty-two individuals, including 13 policemen, were initially charged in the Ramnarayan Gupta fake encounter killing case.

Following a trial, the sessions court in 2013 found 21 of the accused guilty and sentenced them to life imprisonment. Two of the convicted individuals died while in custody.

Those convicted filed appeals in the high court, while Gupta's brother Ramprasad appealed against Sharma's acquittal.

### hub of Bengaluru, it added. No reason for Muslims to be insecure in India since their population growing, says Anurag Thakur

HAMIRPUR (HP): Citing a new report on India's demographic transition, Information and Broadcasting Minister Anurag Thakur wondered how Muslims can feel insecure in the country, especially when their population has reportedly increased by 45 per cent and they have been equal recipients of government welfare programmes. A working paper on population trends released recently by the Economic Advisory Council to the Prime Minister said the population of majority Hindus declined by 7.82 per cent between 1950 and 2015 while that of Muslims increased by 43.15 per cent, suggesting that there is a conducive environment to foster diversity. It,

however, did not give absolute numbers. In an interview to PTI late Friday, senior BJP leader Thakur said the minorities are clearly thriving and need not worry

He also rubbished the opposition's charge that the BJP would change the Constitution. "On the contrary, the BJP

will ensure that reservation for SCs, STs and OBCs is not diluted or altered by anyone." The four-time MP from Hamirpur in Himachal Pradesh, who is defending his seat against Congress' Satpal Raizada, accused the party of seeking to take away the reservation meant for SCs/STs/OBCs and provide it to Muslims.

He also alleged that the Congress is aiming to grab the wealth of people and provide the same to Muslims to further its appeasement and vote bank politics

The Congress has denied these claims, also made by other BJP leaders, as lies and distortion of their manifesto. Prime Minister Narendra Modi has also said that he will never allow reservation based on religion by taking away quotas meant for SCs, STs and OBCs, Thakur said. Asked if there was a need for policy change on population control or a legislation on the issue in the wake of changing demography, Thakur said the new government will discuss the issue and then take a call after discussion as pop-

ulation figures have just come out in public domain. He said the figures show that the population of Muslims in India has increased by almost 45-47 per cent over 65 years. "What do these figures indicate. On one side the population of Hindus declined by 7.8 per cent and on the other hand the population of Muslims increased by 45-47 per cent. One has to ponder over the reasons behind this. In Pakistan, Afghanistan and Bangladesh, the population of Hindus was 23 per cent in 1947, now they are only 2 per cent left. And still, some people in India say Muslims are insecure. Their population has increased by 45 per cent, still they say they are insecure," he said. "How are they insecure? We never said

vote for us out of compulsions, we have not indulged in any vote bank politics. We freed Muslim women of the scourge of triple talaq, we have also provided Muslims women with pukka houses, toilets and free (cooking gas) cylinders, besides free medical treatment even if they have eight children. They have also benefited from our schemes," the minister said.

On the Constitution, he told PTI, "There will be no change of Constitution.

He said the BJP has been in power for the last 10 years while wielding absolute majority in Parliament. Still, it has not made any Constitutional amendment, Thakur said. "It is the Congress which has amended the Constitution all the time. Besides, the Congress insulted Babasaheb Ambedkar, who gave us this Constitution. and even worked to send him out of politics. The Congress also did not give him honour," he alleged.

Instead, he said, it was Narendra Modi who made 'paanch teerth'" at Nagpur; Mhow, Mumbai, Delhi and England in honour of Babasaheb Ambedkar and began marking Constitution Day on November 26, besides declaring a holiday on Ambedkar Jayanti on April 14.

"I want to tell this country and the youth that it was Indira Gandhi who murdered democracy and if anyone has tried to crush the Constitution, it is Arvind Kejriwal," Thakur said. "Even the creators of the Constitution would have never thought that a chief minister and deputy chief minister would be in jail for corruption and still are reluctant to resign from their posts," Thakur added.

Thakur also reeled out government statistics to support his view that the BJP government has consistently worked during the last 10 years for the poor, especially the backward class and castes.

Out of four crore houses made under the PM Awas Yojna by PM Modi, as many as 58 per cent houses were made for SC/STs. he said

He also cited the Rs 6,000 annual dole given to farmers, of which a majority of the beneficiaries are SC/ST and OBC category people. Thakur noted that four crore houses, 12 crore toilets, 13 crore water connections and 10 crore free cooking gas cylinders were provided to people, as well as free

medical treatment to 60 crore people and free ration to 80 crore people.

"These people (opposition) are spreading fear, misconceptions and rumours that SC/ST reservation will go, but the truth is that wherever the Congress governments came, in Karnataka, Andhra Pradesh, and Telangana, they took away SC/ST quota and gave to Muslims and are creating fear among SC/STs," Thakur said.

The senior BJP MP said Congress leader Rahul Gandhi wants a survey that will lead to wealth redistribution. "This is appeasement politics which the Congress started, not us," he said.

"We have done 'Sabka Vikas' and did not do Hindu-Muslim, and we will carry on doing work like this in future. But when these people say such things for votes that they will give to Muslims, then we raise questions that they try to insult Hindus and talk of crushing Sanatan and talk of giving resources to Muslims," Thakur said.
