A massive joint search operation by the army, police and paramilitary forces is going on in the area to flush out the terrorists, who are believed to have crossed into Udhampur from nearby Kathua district after successfully infiltrating from across the border.

Singh identified the arrested accused as Javed, a resident of Loha-Nathi village of Kathua, and said that he had provided logistic support to the terrorists.

"He is the first person arrested in the case so far and his questioning is still at preiminary stages," Singh said, adding the police has gained some credible information about the movement of suspects and had likewise zeroed in on a few "unscrupulous elements".

The sketchy description of the terrorists, aged between 20 and 42 years, revealed that they are equipped with AK assault rifles, US-made M4 carbine and pistols. The SSP said the identities of the terrorists are not known yet.

"There is no credible information suggesting that they are locals. All our agencies, ncluding the army, police, paramilitary forces and intelligence agencies are working hard with the active support of the locals to deal with them," he said.

Voter turnout in phase 3 of Lok Sabha polls at 65.68 pc: EC

NEW DELHI: The updated voter turnout figures for the third phase of polling in the Lok Sabha elections stood at 65.68 per cent, the Election Commission said on Saturday. The poll panel had given a similar voter turnout figure on May 8, a day after the third phase of voting took place.

In a statement on Saturday, EC said 66.89 per cent of men, 64.4 per cent of women and 25.2 per cent of the registered transgender voters turned up at polling stations. In the third phase, 17.24 crore citizens, including 8.85 crore males and 8.39 crore females, were eligible to vote. Voting for the third phase was held or Tuesday in 93 constituencies spread over 11 states and Union Territories with stray incidents of violence. In phase three of the 2019 parliamentary polls, the turnout of voters was 68.4 per cent.

Specially abled, first time young voters to come forward and exercise their right to vote

Aimed at to facilitate the voters in identification and increase voter turnout ratio, all voters have been provided with voter information slip with all requisite information like Polling Station name, date and time of poll, serial number of voter in the list, his full name, QR code but not the photograph of the voter. Hence, the voter Information Slips will not be allowed as proof of the identity of voters. Also, the citizens can view details of the Polling Station, Parliamentary Constituency and get the contact details of the Booth Level Officer, Electoral Registration Officer among other services, through Voter Helpline App (VHA). This mobile app is available on the Google Play store and Apple App Store.

In addition to Electoral Photo Identity Card (EPIC), 12 types of documents will also be allowed to verify a voter and allow him for voting. EPIC card is not mandatory for voting. The requisite documents included Aadhaar Card, MGNREGA Job Card, Pass books with photograph, Health Insurance Smart Card issued under the scheme of the Ministry of Labour, Driving License, PAN Card, Smart Card issued by RGI under NPR, Indian Passport, Pension document with photograph, Service Identity Cards with photograph issued to employees by Central/StateGovt./PSUs/Public Limited Companies, Official identity cards issued to MPs/MLAs/MLCs and Unique Disability ID (UDID) Card, issued by Union Social Justice and Empowerment Ministry.

With the aim of spreading awareness among the voters, Systematic Voters' Education and Electoral Participation (SVEEP) emerges as a comprehensive programme aimed at reinforcing voter education and promoting active participation in democratic process. During the last few months, through various modes, SVEEP activities were held in every nook and corner.
