Ensure uninterrupted 24-hour power supply to industrial units in Bari Brahmana: BBIA the Gladni Grid Station in such cases

SAMBA: The Bari Brahmana Industries Association (BBIA) convened a meeting to address the issue of unscheduled power cuts affecting industrial units in Bari Brahmana. Led by President Lalit Mahaian, the meeting included senior members such as Tarun Singla, Ajav Langer, Viraaj Malhotra, Rajesh Jain, and Vivek Singhal. Members expressed serious concern over the prolonged and frequent power cuts, which have resulted in signifi-


cant financial losses for industrial units despite the substantial annual revenue collected by the Department from the Bari Brahmana Industrial Complex. It was revealed during discussions that the power supply from the BBI Grid Station was frequently disrupted without prior notice. Although officials cited faults in the 220KV/132KV Hira Nagar-Bishnah-Miran sahib-Bari Brahmana Line as the cause, it was noted that the Department had the option to shift power supply from

Members criticized the lack of coordination between departments responsible for power supply to industrial units, resulting in substantial production and financial losses for businesses. They urged Lt. Governor Manoj Sinha, Principal Secretary H. Rajesh Prasad, and Managing Director Vikas Kundal to intervene and direct concerned Chief Engineers to ensure uninterrupted 24-hour power supply to industrial units in Bari Brahmana.
