Recipes

Jackfruit Biryani



- Ingredients**
- 250 gm jackfruit, 4 onion
 - 1 tablespoon garlic paste, 1/2 teaspoon black pepper
 - 2 tablespoon biryani masala powder
 - salt as required, 6 tablespoon mustard oil
 - 1 teaspoon turmeric, 2 cup basmati rice
 - 1 tablespoon ginger paste, 4 bay leaf
 - 1 teaspoon garam masala powder
 - 1 teaspoon red chilli powder
 - 2 cup water, 1/4 cup yoghurt (curd)
- Method:**

To prepare the delicious jackfruit biryani, place a large pressure cooker on medium flame. Heat 4 tbs oil and add bay leaf and whole black pepper. Add thinly chopped onion. Now, add ginger-garlic paste and saute till onions are golden brown. Add red chilli powder, salt as per taste, and mix well. Put jackfruit in the pressure cooker and saute for a minute. Cover lightly and cook for 3 minutes. Stir occasionally. Add biryani masala, garam masala, turmeric, yoghurt to the cooker and mix well. Cover and let it cook for another 3 minutes. This will help jackfruit to absorb all the flavours and soften. Now, add the rice, stir to mix well and cook for 3 minutes. Add water and close the lid. Pressure cook on high till 3-4 whistles. Turn off the flame and let the pressure cooker cool. Open the lid of the pressure cooker once it is at normal temperature and all the steam is out. Take out the katal biryani and let it cool. Plate the biryani, and garnish with cashews, chopped cilantro and mint leaves. Serve hot with raita.

Two drug peddlers nabbed with 8.30 grams heroin

SAMBA: Continuing its drive against drug smugglers/peddlers, Police has arrested two drug peddlers in the jurisdiction of Police Station Vijaypur and recovered 8.30 grams approximately heroin like substance from their possession.



A Police party of Police Station Vijaypur headed by SHO PS Vijaypur during special vehicle checking Naka established on NHW near Radha Sowami Ashram Tandi Khui Vijaypur, inter-

cepted a car bearing registration No. JK11E-9149 coming from Jammu side for its checking. During checking, 8.30 grams approximately heroin like substance was recovered from the possession of persons sitting in the vehicle.

The arrested drug peddlers have been identified as Ajay Sharma, son of Vijay Sharma, resident of Makot tehsil and District Rajouri and Shakhsham Sasan, son of Gulshan Kumar, resident of Gohlad Mendhar Tehsil Mendhar District Poonch. In this regard, a case FIR No. 68/2024 U/S 8/21/22/25/29 NDPS ACT has been registered at PS Vijaypur. Further investigation of the case is going on.

Police reunites three women with families

Two most wanted drug peddlers booked under PSA

KISHTWAR: Two drug peddlers were booked under the stringent Public Safety Act (PSA) in Kishtwar district on Sunday, a police officer said.

SSP Kishtwar, while divulging the details said that District Police Kishtwar, working on multi-pronged strategy to combat drug abuse, has today booked two most wanted notorious drug peddlers from Kishtwar Town under PSA (PITNDPS) and lodged them in District Jail Kishtwar.

The individuals, Moomin Kamal, son of Asgar Ali Kamal, resident of Kamal

Mohalla and Ajaz Ahmed, son of Khushi M o h a m m a d , resident of S i r g w a r i Thakrie, were identified as the kingpins supplying drugs to the youth in Kishtwar Town. Their involvement in numerous drug peddling cases was uncovered during investigations, necessitating their detention under PSA (PITNDPS) to curb their activities and protect the youth of Kishtwar from drug addiction.



After obtaining the PSA orders, SSP Kishtwar constituted two special teams under the supervision of Dy. SP Hqs Kishtwar to arrest these notorious drugs peddlers from different locations in Kishtwar. They were subsequently lodged in District Jail Kishtwar.

SSP Kishtwar highlighted that District Police Kishtwar is working on a comprehensive strategy to tackle drug abuse, including organizing awareness programs across the district and taking strict legal action against drug peddlers. During the course of investigation, CCIU team, exhibited hectic efforts and advanced technical skills which ultimately led to the successful recovery of defrauded amount of Rs. 10,07,960.

Mentionable here that CCIU Doda came to be established on 07-02-2024 and since then the unit has successfully recovered huge de -frauded money amount Rs.19,97,555 so far.

Forest fire triggers landmine explosions along LoC

MENDHAR: Several landmines, part of the anti-infiltration obstacle system,

exploded following a forest fire along the Line of Control (LoC) in the Mendhar sector of Jammu and Kashmir's Poonch district on Sunday, officials said.

The fire started from across the border around 8 pm and spread to the Balnoi area on the Indian side, triggering nearly half-a-dozen landmine explosions, the officials said. They said there was no report of any casualty.

Efforts are on to control the fire, the cause of which was not known immediately, the officials said, adding that the Army is maintaining a tight vigil along the border to foil any infiltration attempt by terrorists.

Three terror associates detained under PSA

POONCH: Three men alleged to be overground workers (OGWs) of terrorists were detained under the Public Safety Act (PSA) in Poonch district on Sunday.

Termining the action necessary to maintain public order, police said the three men were assessed to be posing a significant threat to the safety and security of the state.

Poonch and adjoining Rajouri district have witnessed some deadly terror attacks over the past two years, resulting in the killing of a number of security personnel and civilians.

Poonch and Rajouri are part of the Anantnag parliamentary constituency which is going to polls in the sixth phase on May 25.

The detainees were identified as Furtar Ahmed alias "Kaka", Khurshid Ahmed and Ghulam Abbass, all residents of Gursai Village of Mendhar, a police spokesperson said.

"All three notorious criminals have demonstrated a pattern of behaviour, characterised by the adoption of various tactics, to spread terror and fear within the peace loving community.

"Their continuous actions have posed a serious risk to public safety and tranquility. To prevent further criminal activities detrimental to security of the state and public order, the district police, Poonch, acting upon a detention order obtained from the district magistrate, Poonch, have taken the necessary steps to detain the three OGWs," the spokesman said.

He said the detention follows a series of meticulously planned operations, reflecting the local police's relentless efforts to combat terrorism and ensure the safety of the public.

Crackdown on illegal mining, 4 vehicles seized
