was rushed to a hospital where he succumbed to injuries, they said.

The areas in Anantnag and Shopian have been cordoned off and search operations have been launched to nab the attackers, the officials said

The back-to-back attacks come at a time when campaigning for the parliamentary oolls in the Anantnag-Rajouri seat is going on. Polling in Baramulla will be held on May 20 in the fifth round of the seven-phase general elections.

The BJP held a protest against the murder of party worker and former sarpanch Aijaz Ahmad Sheikh in Shopian and accused the Jammu and Kashmir civil adminstration of ignoring its requests for security to some key functionaries facing terror

BJP workers gathered outside the 'mini secretariat' in Shopain and raised slogans against the district administration for not providing safe accommodation to vulnerable party leaders and workers

One of the protesters said, "We have been requesting the Deputy Commissioner for a year to provide safe accommodation to our leaders and workers but he has been delaying. Now we have lost one worker."

Altaf Thakur, a party spokesperson, said there was a lapse on part of the district administration at some level.

"Terrorism will not be allowed to raise its ugly head in Kashmir again but there has been a lapse on the administration's part as well. The responsibility for Aijaz's martyrdom lies with the deputy commissioner," he told PTI Videos.

"Sometime ago, we had written to the deputy commissioner that Aijaz was getting threat calls but he ignored it," Thakur added.

The BJP in a statement said, "We strongly condemn the killing of ex-sarpanch Aijaz Ahmad Sheikh in Hirpora, Shopian, South Kashmir, by terrorists today.

"Aijaz Ahmad was a brave soldier of the Bharatiya Janata Party (BJP) in Jammu and Kashmir. The BJP firmly stands with the family of Aijaz Ahmad, who lost his life in this terror attack," it said.

Meanwhile, neighbours and relatives visited Sheikh's family at Hirpora in Shopian and offered their condolences.

Sheikh is survived by his mother, his widow Shabnam Kausar and their three children, including a two-month-old daughter.

Kausar said Sheikh worked for the area's development and made people aware of schemes such as the Pradhan Mantri Awas Yojana and Swachh Bharat Abhiyan. "I want to ask him (the assailant) what my husband had done to him? Did he take his property that he murdered him? He made my three children orphans and me

destitute. May Allah do the same to his (family)," she said. Kausar said the assailant knocked on the door of their home late on Saturday and asked for her husband.

"I was preparing the feeder for my infant daughter when he came to the door. The moment my husband confirmed that he was Aijaz, the assailant fired seven to eight shots before fleeing," she added.

Political parties in Jammu and Kashmir, including the National Conference, PDP and the BJP, condemned the attacks.

Polling for the seat was scheduled to be conducted on May 7 but was deferred after few political parties in Jammu and Kashmir raised concerns over weather conditions. Polling will now being held on May 25.

National Conference president Farooq Abdullah and vice president Omar Abdullah also condemned the terror attacks.

"The accused person namely Ali Mohd Lone @ Advocate Zahid Ali son of Habibullah Lone resident of Nihama Pulwama, who was involved in Case FIR No. 19/2019 under section 13 of UAP Act" surrendered before the police station concerned and was arrested on May 16 in the jailbreak case.

The High Court of Jammu and Kashmir and Ladakh, while ordering his release a month ago, had directed the union territory administration to pay a compensation of Rs five lakh to the former spokesman of banned Jamaat-e-Islami outfit for his

illegal detention under the Public Safety Act. Lone, who was spokesperson of Jamaat-e-Islami for a long time, was first arrested in March 2019 but his preventive detention was quashed by the court in July that year. However, he was detained again under preventive laws within six days but the order was set aside by the court in 2020. Within three months, he was again booked

under preventive laws but the detention was again set aside by the court in 2021. He was booked for the fourth time in 2021 under the PSA which was quashed by

the court last month. "Now if three judgments of this Court quashing preventive detention of the petiioner made three times hereto before have not been spared a passing glance, lest an application of mind, by and on the part of the SSP Pulwama, the respondent No.2-District Magistrate Pulwama and last by the respondent No.1- Govt. of UT of J&K as well, then how can it be claimed by the said three authorities at their respective end that the fourth time preventive detention of the petitioner is an outcome of an open and fair mindset acting upon changed factual scenario," the court had observed its 13-nage order

last year, passed three key legislations -- the Bharatiya Nyaya (Second) Sanhita, the Bharatiya Nagarik Suraksha (Second) Sanhita and the Bharatiya Sakshya (Second) Bill. President Droupadi Murmu gave her assent to the bills on December

These new laws -- the Bharatiya Nyaya Sanhita, the Bharatiya Nagarik Suraksha Sanhita and the Bharatiya Sakshya Act -- will replace the Indian Penal Code (IPC), the Code of Criminal Procedure (CrPC) and the Indian Evidence Act respectively. Seeking a stay on the operation of the three new laws, the PIL filed by advocate Vishal Tiwari has said they were enacted without any parliamentary debate as most of the opposition members were under suspension.

The plea has sought directions from the court for the immediately constitution of an expert committee that will assess the viability of the three new criminal laws.

"The new criminal laws are far more draconian and establish a police state in reality and violate every provision of fundamental rights of the people of India. If the British laws were considered colonial and draconian, then the Indian laws stand now far more draconian as, in the British period, you could keep a person in police custody for a maximum of 15 days. Extending 15 days to 90 days and more is a shockng provision enabling police torture," the plea has said.

throttle against each other and even bringing in the BJP to target each other despite the saffron party not contesting from any of the three parliamentary seats of Srinagar, Baramulla and Anantnag-Rajouri in the Valley.

However, it is the presence of jailed Awami Ittehad Party leader and former MLA Abdul Rashid Sheikh alias Engineer Rashid that has spiced up the contest.

The People's Democratic Party has fielded former Rajya Sabha member Mir Mohammad Fayaz while Muneer Khan, the brother of jailed separatist leader Nayeem Ahmad Khan, is contesting as an Independent.

Most observers, however, expect a triangular contest among Abdullah, Lone and Rashid. The Ghulam Nabi Azad-led Democratic Progressive Azad Party has backed Rashid's candidature while the April Party, led by Altaf Bukhari, has thrown its weight behind Lone.

Given the huge turnout at the rallies and roadshows, political observers expect Baramulla to break turnout records in Kashmir.

The election authorities gave permission for 1,859 rallies, meetings and roadshows while 300 applications were rejected.

In 2019, the constituency recorded 34.17 per cent polling with Kupwara district registering the highest turnout at 51.7 per cent, followed by Bandipora at 31.8 per cent and Baramulla at 24 per cent.

The constituency is spread over 18 assembly segments in the three districts of Kupwara, Baramulla and Bandipora and also includes two segments of Budgam that were included on the recommendations of the delimitation commission two

According to Election Commission officials, 17.37 lakh people are eligible to cast their votes at 2,103 polling stations.

"There are 527 persons above the age of 100 who are eligible to exercise their franchise. There are 8,75,831 (8.75 lakh) male and 8,62,000 (8.62 lakh) female voters, besides 34 from the third gender. More than 17,000 voters are persons with disabilities," they said.

More than 8,000 polling staff, including reserves, have been deployed at the polling stations to ensure smooth conduct of the polls, the officials said and added that 28 polling stations are located in the border areas of Kupwara and Baramulla districts. Voting will be held from 7:00 am to 6:00 pm.

There are 18 polling booths managed by women, 17 manned by specially-abled persons and 18 by youngsters. To spread messages on the environment, the authorities have also set up 21 green polling booths.

lakh polling officials have been deployed across 94,732 polling stations. Farooq demands probe into twin terror attacks in J&K, asks Pakistan to stop terrorism

MENDHAR: National Conference president Farooq Abdullah on Sunday urged the Centre to order a probe into the twin terror attacks in Jammu and Kashmir a day earlier and also asked Pakistan to stop supporting terrorism in the region.

The former chief minister said if a probe is not ordered into the two gruesome inci dents, his party would "invite an international committee" to conduct an investiga tion to find out the culprits behind such attacks.

"I have been repeatedly saying that those sitting in Delhi are misleading the peo ple by saying Article 370 was responsible for terrorism. How many years have passed since the abrogation of the Article? Has terrorism stopped?" Abdullah told reporters on the sidelines of an election rally in the Mendhar area of Poonch district

Referring to the killing of Sheikh, he said an innocent former sarpanch of BJF lost his life in the attack. "Had he not the right to live? This is a free country and any party can propagate their ideology. Who killed him should be probed and that too soon," the NC chief said. He also demanded an investigation into the attack on the tourists in Anantnag. "If they (Centre) do not go for the probe, we should invite an international committee to investigate who is responsible for such attacks, Abdullah said. He said peace will elude the region till the terrorism is completely stopped. "I want to tell our neighbour Pakistan to stop terrorism (in J-K). After the terror activities are stopped, both countries can sit together and resolve their issues," he said
