NEW DELHI: Former RBI GovernorDuvvuri Subbarao has opined that only enlightened leadership at Centre and state levels can resolve the complex north-south divide in deciding on the distribution of the tax pool among states, saying it is beyond the remit of the Finance Commission.

Subbarao, who held various positions including the finance secretary of Andhra Pradesh and Union finance secretary, and wrote extensively on issues in fiscal federalism in his new book titled 'Just A Mercenary?: Notes from My Life and Career' further said that horizontal sharing of the divisible pool of taxes has always been a contentious issue but will be even more so in this round.

"This (north-south divide in deciding on the distribution of the tax pool among states) is a complex political challenge beyond the remit of the Finance

"Resolving it will demand enlightened leadership at central and state levels that can look beyond politics and build a consensus around an optimal way forward," he told PTI. He pointed out that for every

rupee they contribute to the centre's taxes, richer states like Tamil Nadu and Maharashtra get back less than a rupee while poorer states like Bihar and Jharkhand receive more than a rupee.

"Such cross subsidization of poorer states by richer ones is inevitable in a large and diverse country like ours and has, in fact, been an accepted principle," Subbarao said.

Finance Commission (16th FC) has been set up and the debate of economically and socially better-off southern and western states 'subsidising' the northern and eastern states has begun again

"As you say, there is already an emerging north-south divide on the economy front. The question is, are we hitting the limits of such cross subsidization?," he asked.

According to Subbarao, many headline numbers suggest that the southern states are doing better in terms of infrastructure, private investment, social indicators and rule of law which has put them on a virtuous cycle of growth prosperity widened the north-south

Subbarao noted that if the Reserve Bank were to step in every time the exchange rate moved, they would happily outsource their external management to the Reserve Bank.

"That would be a costly moral hazard," he said. Subbarao was at the helm of RBI during the taper tantrums in 2012-13 when the rupee crashed by 20 per cent peak to trough.

Responding to a question on freebies, Subbarao said in a poor country where millions struggle to make a decent livelihood, transfer payments to the most vulnerable segments are necessary, indeed even manda-

"But that has to be within limits especially as these freebies are financed by borrowing," he pointed

On the other hand, Subbarao said, competitive populism like what is unfolding -- political parties outdoing each other in wooing voters with freebies -- is fiscally perilous.

"I believe all political parties are guilty of this and trying to apportion blame will be a wrong start," he said.

Strong leaders, agencies come back to bite very citizens they vow to protect: Court

STATE TIMES NEWS NEW DELHI: A Delhi court has pulled up the Enforcement Directorate for using the stringent PMLA law to record the statements of doctors treating an accused in a money laundering case, observing that history teaches that strong leaders, laws and agencies generally come back to bite the very citizens they yow to protect.

Special Judge Vishal Gogne made the observation while deciding an application moved by Amit Katval, seeking extension of his interim bail granted on February 5 on medical grounds in a money laundering case linked to the railways land-for-jobs scam. The judge declined the extension of the interim bail on April 30, noting that Katyal was "manifestly on the road to recovery and can follow the prescribed lifestyle within jail premis-

However, the judge noted that the objection raised by senior advocate Vikas Pahwa. appearing for Katyal, to the use of section PMLA $_{
m the}$ (Prevention of Money Laundering Act) by the ED in recording the statements of doctors whom the accused was consulting at Apollo Hospital, Delhi, and

Hospital, Medanta Gurugram, after getting interim bail.

The judge said there was absolutely no justification for the ED to subject an ordinary citizen to the "stringent process of section 50" without an iota of allegation of nexus of the doctors with the accused.

"If there are any lessons to be learnt from history, it would be observed that strong leaders, laws and agencies generally come back to bite the very citizens they vow to protect. After the masculinity of the law has been expressed against the stated targets, such laws are invariably alleged to have been employed against average citizens. The use of section 50 by the ED against the law abiding doctors of private hospitals is a contemporary contribution to this perception," the judge said.

He said such negation of the intended purpose of legislations was required to be avoided by probe agencies and consciously monitored

During the proceedings, Pahwa said the process was not only a violation of permissible action under section 50 but also an intrusion into the privacy of medical treatment which was a fundamental right. He claimed "concerted

effort" by the ED to bring the weight of its authority upon medical practitioners resulted in reticence on part of the doctors at the Apollo Hospital in treating the accused. The accused was ultimately treated Medanta Hospital.

Accepting Pahwa's submission, the judge said, "By no stretch of interpretation can the expanded ambit of section 50 be considered to include recording of statements of citizens, including doctors who may have been associated with the accused 'de hors' (not including) criminal activity relating to the proceeds of crime".

The judge said the powers of the ED under section 50 PMLA does not extend to private (including health) affairs of the accused or his vocation in life as long as these do not have incriminatory connect with the allegations under section 3 read with section 4 PMLA.

It also does not extend to the performance of vocational functions or duties by private persons or professionals like doctors who have not been alleged to have been involved in any activity linked to the

accused, the judge said. The court termed as "impermissible" the ED using section 50 to record statements of doctors at Apollo and Medanta Hospitals who were treating the accused.

"The ED, as an investigative agency, is bound by the rule of law and cannot be seen as acting mighty against the ordinary citizen who is not even a suspect," the judge said.

He said it was a startling proposition for any citizen and that too doctors who are mostly in aid of the courts in various litigations. "The citizens possess

rights while the state has certain duties. This fundamental relationship cannot be inverted to invoke an authoritarian argument that the State has certain rights against citizens who are expected to reciprocate by submission through their duties," the judge said.

He said not only would the acceptance of such an argument be an inversion of the social contract on which every liberal democracy is based but also a violation of the constitutional scheme and constitutional morality.

"As an agency answerable to the law and the courts, the ED cannot arrogate powers unto itself. While a government agency too is expected to be a votary of civil rights, the court will certainly not remain amiss

in highlighting and rejecting an entirely high handed act of the ED," the judge said.

He said the rights of the citizens against being subjected to invalid processes completely trump the over reach of the law by ED.

Katval had sought extension of interim bail by two more months, claiming he had recently undergone a surgery and the jail infrastructure and environment would not permit the optimum recuperation.

"Moreover, interim bail is not a substitute for regular bail and cannot be extended indefinitely. The accused must, therefore, be required to surrender to judicial custody," the judge said.

According to the ED, the accused operated companies as a front for purchasing immovable properties at under valued rates on behalf of other accused persons, including RJD leader Lalu Prasad Yadav, his family members and associates in lieu of wrongful appointment of various persons to Group D posts in the Indian Railways during Yadav's tenure as Railway Minister.

These companies were then transferred to the family members of Lalu Prasad Yadav at undervalued shares, the ED alleged.

Eight-year-old girl raped at private school's hostel in Bhopal, three booked; MP CM orders SIT probe

BHOPAL: An eight-year-old girl studying in Class 2 at a private school in Madhya Pradesh capital Bhopal was allegedly raped in its hostel, following which the police have registered a case against three unidentified persons, officials said on Wednesday.

Madhya Pradesh Chief Minister Mohan Yaday ordered a probe by the Special Investigation Team (SIT) into the case, while the opposition Congress targeted his government over the incident and demanded harshest punishment for the culprits.

The police said they were trying to ascertain when the incident exactly took place. "An eight-year-old girl was

allegedly raped at the girls' hostel of a city-based private school. Following a complaint in this regard, the police registered a case on Tuesday night against three persons under Indian Penal Code (IPC) section 376 (rape) and provisions of the Protection of Children from Sexual Offences (POCSO) Act," Misrod police station in-charge Manish Raj

The case was registered based on a complaint lodged by the girl's mother, he said.

Deputy Commissioner of Police (DCP) Shraddha Tiwari told PTI over phone that the

accused are yet to be unidentified as the girl is not able to tell the police properly.

"We are moving forward carefully into the case considering the victim's age as she is mentioning some name and identifying the accused like dadhiwala (bearded man), etc. We will establish the identity of the accused after talking to the victim again. We will first carry out her medical examination and record the statement," she said. Bhadoria said that although the physical appearance of the accused was mentioned in the FIR, their identity

When asked about the allegation that the girl was drugged before the crime, he said all these things will be clear once the investigation gets over.

is not yet to be established.

"The process of carrying out the medical examination of the victim and recording her statement is underway," he said, adding that several police teams have been formed to collect the evidence related to the case. On whether the clinical examination confirmed that the girl was raped, Bhadoria said a comprehensive report is awaited. Replying to a query that injuries and swelling were found in the girl's private part during a medical examination conducted by doctors as per the request by the victim's mother, the police official said the com-

plainant has made this allegation, but things will be clear after receiving a detailed medical examination.

Nath said the Bhopal incident should be investigated with sincerity and the culprits be given the strictest punishment.
