Hitting back at the Congress for claiming the BJP will change the Constitution in its third term in office, Modi said the opposition party could not implement the statute book in the entire country during its decades-long rule.

The PM asserted he was committed to the Constitution and ensured its implementation in Jammu and Kashmir by removing Article 370 which provided spe-

eial status to the erstwhile state. "Congress leaders are now claiming the Constitution is in danger and reservation will be abolished. In reality, the Congress could not implement the Constitution in the entire country during its 70-year rule. Our Constitution was not implemented in Kashmir...It was Modi who did it because Modi is committed

to the Constitution," emphasised the BJP stalwart. The PM hit back at the opposition INDIA bloc over its "BJP will change the Constitution" narrative and referred to the then-Congress government's decision to overturn the Supreme Court's ruling in the Shah Bano Case of 1985

He said Muslim women have suffered under the Congress rule due to the party's ote-bank politics.

"Congress shehzada (referring to Rahul Gandhi) is now roaming with (copy of) the Constitution book. In the Shah Bano case, it was your party's government which overturned the judgement of the Supreme Court, which works as per the Constitution. Where was your respect for the Constitution then? You changed the SC ruling and deprived Muslim women of any security," said Modi.

In 1985, the SC had ruled in favour of Shah Bano, a Muslim woman from Indore who had sought maintenance from her husband after divorce, but the then-Congress government under PM Rajiv Gandhi overturned the judgement through

Modi said his government's 2019 decision to abolish the practice of instant triple alaq has given security to not only Muslim women, but their families too, as they used to remain tense about what will happen to their daughter if the husband gives her instant divorce.

"You never dared to stop triple talaq due to vote-bank politics. But, I am not worried about the vote bank. I don't run the country on the basis of victory or defeat in elections. I just wanted to give security to my Muslim daughters. I was able to save the lives of lakhs of women and their families with that decision," said Modi. On the decades-long issue of Ram Temple, the BJP's star campaigner maintained its construction in Ayodhya should have started the very next day India got its independence in 1947.

"But, our country had to fight for the temple for 75 years. The Congress tried to even change laws to ensure it (temple) never comes up. It was finally built after an SC verdict. But, when the temple trust invited them (Congress) for 'Pran Pratishtha' (consecration ceremony), they did not honour the invitation just to appease their vote-bank," claimed Modi.

Give in writing...

nor will it allow the Congress to do so.

In his first public address in Gujarat as part of the third phase of Lok Sabha elections in his home state, Prime Minister Modi said that as long as the BJP and he remain, the reservation granted to SC/ST/OBC and economically weaker sections will be safeguarded and not harmed.

"I challenge the shahzada(a reference to Rahul Gandhi) of Congress, as well as Congress party and its supporters to announce that they will never misuse reservation in the name of religion, nor will they play with the Constitution or give reservation in the name of religion.

"Let the Congress and INDI alliance give a guarantee in writing -- because they cannot be trusted -- that they will never give reservation in the name of religion. They should also give a second guarantee that they will never touch reservation given to SC, ST, OBC and general category. They will never do so, will never give it in writing," Modi said.

"I challenge Congress and its ecosystem to declare they would not give reservation to minorities by altering Constitution.

He said in 2024, the Congress and the INDIA bloc have come out with a lie, and are flashing the Constitution to spread fear that it will be changed and reservation given to the SC, ST, OBC and EWS will be taken away if the NDA comes to

"A completely fabricated gossip," Modi said, as he accused the Congress of spreading a false narrative.

"Congress and its people should listen carefully that this is Modi. As long as Modi is alive, I will never let you play the game of reservation in the name of the Constitution.

Modi said the SC, ST, OBC and the poor from the general category have got reservation under Constitution, with the blessings of Babasaheb Ambedkar, and nobody can take away even a part of it.

"Your (Congress) intention is to give reservation to the Muslims in the name of

"I can say this with confidence -- and I say this on record in front of the world that as long as the BJP and Modi remain, the reservation given by Babasaheb Ambedkar's Constitution to the SC, ST, OBC and common man (EWS) will be safeguarded and will not be harmed," he said.

"Nothing objectionable" was found during searches by authorities which later declared it a hoax

Officials said that the initial probe suspected a "deeper conspiracy" by a terror group during the Lok Sabha elections, adding that there is suspicion that the threat mail was sent by an ISIS module

The Delhi Police's anti-terror unit special cell has traced the domain of emails to Russia and it is suspected to have been formed with the help of the dark web - an encrypted online content that allows individuals to hide their identity and location from others.

The National Investigation Agency may also take up the probe since the role of a terror group is suspected and the "conspiracy" angle may lead to a pan-India

nvestigation, an official said. Law enforcement authorities went into a tizzy as police and fire services started

receiving a flurry of calls from schools at 6 am on Wednesday. Delhi Public School (Mathura Road), DPS (Saket), Sanskriti School, Amity

School (Saket), DAV (Model Town), DPS (Dwarka) and St. Mary School (Mayur Vihar) were among the education institutions that received the threat email on Wednesday

A senior Noida Police official told PTI that the email threat was received in seven schools in the satellite city.

It was only an hour or so since parents had dropped off their children when they received messages from the school authorities informing them about an e-mail threatening the safety and security of the students. Parents rushed to pick up their children and school authorities scampered to

bring the students to safety, moving them outside the buildings, while police personnel with sniffer does sanitised the premises. With over 130 schools receiving the bomb threat via email, Delhi Police faced a

daunting task as it rushed its dog and bomb squads from one school to another and there was no time to be wasted. The city police went into an overdrive and the situation lasted till evening.

Police said that the number of schools that received the threat may go up as they vere compiling the list.

According to a police officer, the email ID from which the threat was sent is sawariim@mail.ru'. Sawarim is an Arabic word extensively used by the terror outfit Islamic State (IS) in their propaganda videos over the past several years, the official said. "Kill them wherever you meet and drive them out of the places from which they drove you. There are many explosive devices in the school..., reads the identical email sent to all schools.

The officer said that the email also contained "aayate (verses) of the holy

"The main agenda of sending such threat emails in bulk is to create panic and wage a cyber war by some terror group," an officer, who did not wish to be named, said.

A case has been registered under relevant sections of law for offences like conspiracy and threat by the Special Cell and a dedicated team formed to conduct the investigation, an official said.

Meanwhile, security agencies have widened the ambit of the search operation to Kathua district to track down two groups of terrorists involved in the killing of a village defence guard in Udhampur district.

A Village Defence Guard (VDG) was killed in a brief encounter with terrorists in remote Panara village in Chochru Gala heights early Sunday, following which a hunt was launched jointly by the police, army, and CRPF.

The search operation, which entered the fourth day on Wednesday, is ongoing in Basantgarh, Bani and Seoj areas of Udhampur and Kathua districts, officials said, adding there has been no fresh contact with the fleeing terrorists

As per sources, the movement of one group has been reported in the upper reaches of Udhampur district while the other group is seen to have moved towards Bani, Daggar and Kindli areas of Kathua district.

The movement of one of the groups was picked up from Allo Top and Seoj high altitude dense forested areas in Udhampur, they said.

More security personnel have deployed in these areas to strengthen the cordon in the large high-altitude forest belt between Udhampur and Kathua, they said. Apart from the use of choppers, UAVs, and drones for surveillance, additional forces have been moved into these areas to intensify the efforts to track down and

neutralise the terrorists, they said. Several persons have been detained and are being questioned, they said.

On Monday, Additional Director General of Police (Jammu zone) Anand Jain said two groups of terrorists are believed to be present in the area after they recently infiltrated from across the border

He said the strength of the two groups, as per preliminary investigation, is between four and six and the security forces are working on various inputs to flush them out. According to official sources, the terrorists had reached Basantgarh from adjoining Kathua district after managing to sneak into this side from across the border and were heading for Chenab Valley when they were confronted by the police and VDG members. The Bani-Basantgarh route from Kathua used to be a well-defined route for terrorists to Doda and Kashmir after their infiltration along the International Border (IB) until two decades ago.

The opening of the 270-km highway, the only all-weather road linking Kashmir with the rest of the country, provided relief to hundreds of people, including tourists, who were stranded in the twin capital cities following its closure.

Multiple landslides, mudslides and shooting stones from the hillocks blocked the highway at nearly a dozen places between Nashri and Banihal tunnels during the intervening night of Sunday and Monday, prompting suspension of the traffic, the officials said. Meanwhile, the Mughal road -- an alternate road linking Poonch and Rajouri in Jammu region with south Kashmir's Shopian district -- remained closed for the fifth day on Tuesday owing to snowfall in Peer Ki Gali and adjoin ing areas, they said. The traffic on the road usually remains closed during winter months due to snow accumulation. The road was recently cleared for one-way traffic but fresh snowfall between Friday and Monday again closed it.
