"We must be able to distill the best of each service, and incorporate the highest common factor, rather than settle for the least common denominator," said the Chief of Defence Staff.

He mentioned various initiatives of symbology that being processed towards fostering the joint culture, including tri-services participation in national

Under the theaterisation model, the government seeks to integrate the capabilities of the army, air force and navy and optimally utilise their resources for wars and operations

According to the theaterisation plan, each of the theatre commands will have units of the Army, the Navy and the Air Force and all of them will work as a single entity lookin a specified geographical territory.

At present, the Army, Navy and the Air Force have separate commands.

The theatre commands are being planned to integrate the capabilities of the three services and to ensure optimal utilisation of their

In his address, the Chief of Defence Staff termed jointness and integration as prerequisites to the creation of functional integrated theatre commands, and explained the significance of such com-"The creation of such com-

MoS Ajay Bhatt hails Project Udbhav, says it focuses on making Army 'future-ready'

NEW DELHI: Union minister Ajay Bhatt said Tuesday the strength of a country resides not only in its military might but also in its ability to adapt to changing circumstances and leverage its cultural heritage as a source of power

The minister of state for defence was addressing an event at the National Museum here to mark the Udbhav, which aims to promote indigenous discourse in the Army by integrating India's ancient strategic acumen into a contemporary military domain with a focus on making the force "future-

The project is a collaboration of the Indian Army and Delhi-based think-tank United Service Institution of

Praising the Army and USI, Bhatt said, "The aim of this project envisioned by USI is to find invaluable insights into our strategic culture by finding ancient texts and oral traditions... The geopolitical landscape is continuously evolving and it is necessary for our armed forces to be adaptive and innovative in their thinking."

In his address, the minister also praised the ancient Indian philosophy of 'Vasudhaiva Kutumbakam', which was part of the tagline used by India during its year-long presidency of the

"The ancient principle of 'Vasudhaiva Kutambakam'... has transcended cultural boundaries and become a guiding light in international diplomacy," Bhatt said.

The Union minister said that in the last decade, the government of India has started a significant journey towards promoting indigenisation initiatives in various

From health to manufacturing and from basic infrastructure to defence, solid efforts have been made for a

strong national commitment towards indigenisation, he added.

"There is a need to honestly make efforts to imbibe Indian thoughts and values even in our works and decisions. The dream of 'Viksit Bharat' can only be realised when we fully understand the priceless wisdom of our ancient past and implement it contextually in shaping modern ambitions and policies," he said.

The event was also attended by Army Chief Gen Manoj Pande and other senior officials of the force.

Bhatt further said that by delving into India's ancient texts and traditions, Project Udbhav "not only enriches our understanding of strategic culture but also lends a valuable discerning thinking on unconventional war strategies, diplomatic traditions, and moral thoughts in

"As we delve into our history and understand it deeply, it is essential to identify that historical narratives are not limited to buildings and objects alone, there is a sea of knowledge beyond that.

"In our ancient texts, there is a rich history, historians are well aware of this and it is a subject of continuous research, which the defence minister has earlier done, Bhatt said.

Therefore, the minister said, it is important that "we continuously discuss our history, and reevaluate it so that we can ensure that our

past is neither distorted nor oversimplified". The Army chief said in his address that the project was launched at the maiden edition of the Indian Military Heritage Festival last October by Defence Minister

Rainath Singh. Bhatt also said that India's history is an amalgamation of different thoughts and accomplishments which is a source of inspiration not only for Indians but also for people around the world.

Today, through social media and other digital platforms, the dissemination of information has connected the world together, due to which curiosity towards India's ancient knowledge systems is growing in the world, the Union minister added.

Bhatt also inaugurated an exhibition themed on the Evolution of Indian Military Systems, Warfighting, and Strategic Thought -- from Antiquity to Independence', which showcases the evolution of India's military systems and strategy.

Can court examine legality of arrest after cognisance of ED's complaint taken: SC to Hemant Soren ing to "subvert" the probe in



NEW DELHI: The Supreme Court on Tuesday asked former Jharkhand chief minister Hemant Soren whether a writ court can examine the legality of his arrest after the trial court has taken cognisance of the prosecution complaint filed by the Enforcement Directorate (ED) in the money laundering case against him related to an

A vacation bench of Justices Dipankar Datta and Satish Chandra Sharma, which posted the matter for further hearing on Wednesday, asked Soren's counsel to first satisfy the court as to how interim bail can be granted to him for campaigning in the Lok Sabha poll when his application for regular bail has been dismissed.

"The trial court, after taking a prima facie view that offence has been committed. has passed a judicial order taking cognisance of prosecution complaint. What will happen to that judicial order especially when it has not been challenged? You have to satisfy us, can a writ court examine the legality of arrest after the judicial order taking cognisance has been passed," the bench told senior advocates Kapil Sibal and Arunabh Chowdhury, who appeared for Soren.

Both the lawyers sought time till Wednesday to respond to the court's queries



Additional Solicitor General SV Raju, appearing for the ED, opposed Soren's interim bail plea, contending his case was different from that of Delhi Chief Minister Arvind Kejriwal, who was granted interim bail on May 10 for campaigning in the general

He said the trial court had on April 4 taken cognisance of the prosecution complaint, ED's equivalent of a charge sheet, upon finding that a prima facie case was made out against Soren.

Sibal said no offence of illegal possession of land is made out against Soren under the Prevention of Money Laundering Act (PMLA),

predicate/scheduled offence. "I am raising a question of constitutional infirmity. It relates to my freedom. It relates to taking away of my right to liberty under Article 21. Why can't I challenge my arrest under the PMLA, when no offence is made out. The writ court can interfere, if my rights are affected." he

that if the court is not inclined to grant interim relief to Soren, then it will have to hold that the moment an accused moves a regular bail application, his right to challenge section 19 of the PMLA (power of arrest) stands extin-

"We need assistance on the issue from both the sides," the bench said while referring to the subsequent developments following Soren's arrest like dismissal by the high court of his plea challenging his arrest, cognisance of the prosecution complaint (charge sheet), and dismissal of his regular bail application.

Sibal said the trial court has only taken a prima facie view that an offence has been committed but the petitioner's case is that his arrest itself is bad in law.

"This is totally different. The material before the trial court does not disclose commission of offence under the PMLA and hence arrest is have some intense debate on the issue and need assistance from both sides. We are keeping our mind open and have not formed our opinion. Satisfy us."

Sibal said the high court had reserved its order on Soren's plea challenging his arrest on February 28, and on May 3, the court pronounced the ver-

"Yes, I have moved for regular bail before the trial court on April 15 but what else could I have done," he said, adding that the bail application was moved without any prejudice to Soren's rights and contentions

Raju intervened and said that Soren simultaneously pursuing bail while challenging his arrest in the high court was akin to "riding two horses

Raju, who raised preliminary objections to the maintainability of Soren's petition, told the bench, "This case cannot be compared with the other case (Kejriwal's case). Else, every day someone will come challenging arrest and criminal proceedings will go for a toss. It will open a pandora's box.

He added that unlike Kejriwal's case, Soren was arrested on January 31, long before the schedule for the Lok Sabha election was announced on March 16.

The ED has, in its affidavit, aid Soren is actively attempt

the money laundering case against him by "misusing state machinery". It has opposed his "special prayer" for interim bail to campaign in the Lok Sabha polls.

The agency said Soren's arrest on January 31 has upheld by the Jharkhand High Court and his regular bail application dismissed by the trial court on

On May 13, Soren referred to the top court's order granting interim bail to Kejriwal in the money laundering case against him linked to the alleged Delhi excise scam and sought identical relief for him-

The ED has alleged that "huge amounts of proceeds of crime" were generated by Soren through manipulation of official records by showing dummy sellers and purchasers in the guise of forged/bogus documents to acquire huge parcels of land having value in crores of

The probe against Soren pertains to an 8.86-acre plot of land in Ranchi that the ED has alleged was illegally acquired by him.

Soren is currently lodged in judicial custody in Ranchi's Birsa Munda Central Jail

290 cases of COVID-19 variant KP.2, 34 cases of KP.1 detected in India: INSACOG data

NEW DELHI: As many as 290 cases of KP.2 and 34 cases of KP.1, both sub-lineages of COVID-19 that are responsible for surge in cases in Singapore, have been found in India, according to official data.

However, a source in the Union health ministry told PTI that they are all sub variants of JN1 and there is no associated increase in hospitalization and severe "So there is no reason for

concern or panic. The mutations will keep happening at a rapid pace and this is the natural behaviour of viruses like SARS-CoV2," source said.

The source further said that the INSACOG surveillance is sensitive and is able to pick up the emergence of

any new variant and sam-

ples are also picked from hospitals in a structured manner to detect any change in the severity of disease due to virus. Data compiled by the

SARS-CoV-2

Genomics Consortium (INSACOG) showed that 34 cases of KP.1 have been found across seven states and UTs with 23 cases registered from West Bengal. The other states are Goa

KP.2 have been registered with Maharashtra reporting the highest number at 148, according to the data.

Odisha (17), Rajasthan (21), Uttar Pradesh (8), Uttarakhand (16) and West Bengal (36).

Globally, the predominant COVID-19 variants are still JN.1 and its sub-lineages, including KP.1 and KP.2.

KP.1 and KP.2 belong to a group of COVID-19 variants scientists have nicknamed 'FLiRT', after the technical names of their mutations.

The strains in FLiRT are all descendants of the JN.1 variant, an offshoot of the Omicron variant. KP.2 was classified by the World Health Organization as a Variant Under Monitoring

According to HDFC Securities, gold prices were impacted by hawkish comments from one of the US Fed Reserve members, who suggested that interest rates will need to continue at current levels for a longer period to bring inflation back to tar-

Gold prices declined by Rs 550 to Rs 74,650 per 10

It had settled at Rs 75,200 per 10 grams in the previous session.

Silver prices also declined Rs 1,600 to Rs 94,500 per In the previous session, it

had settled at Rs 96,100 per

"Spot gold prices (24 carats) in the Delhi markets were trading at Rs 74,650 per 10 grams, down by Rs 550 against the previous Saumil Gandhi, close,"

Commodities at HDFC Securities, said.

In the international markets, spot gold at Comex was trading at USD 2,420 per ounce, down USD 22

from the previous close. Silver was quoting lower at USD 31.60 per ounce.

"Gold is trading slightly lower on profit-booking, after hitting an all-time high in early trades.

"The underlying momentum remains positive amid rising bets for an early rate cut by the Federal Reserve after the incoming data has shown signs of a slowdown in economic activity as well as cooling inflation," Pranav VP - Research (Commodity & Currency) at BlinkX and JM Financial Services, said.

NIA conducts multi-state raids in Bengaluru's Ramshwaram Cafe blast case

DELHI: The National Investigation Agency (NIA) on Tuesday carried out multi-state raids in connection with its probe in Bengaluru's Ramshwaram Cafe blast case, officials

Several customers and hotel staff members were injured, some of them griev-

ously, in the blast that caused extensive damage to the cafe in the IT city on

"Multi-states raids were underway in different locations," a senior NIA official

said, without sharing further details. The probe agency, that took over the case on March 3, had on April 12 arrested two key accused, including the mastermind Adbul Matheen Ahmed Taahaa, in the matter.

Taahaa and the other accused, Mussavir Hussain Shazib, who had allegedly placed the Improvised Explosive Device (IED) at the cafe, were arrested from a lodge near Kolkata, where they were staying under the assumed identities.
