The campaigning has now gathered steam especially after the Srinagar and Baramulla Lok Sabha seats witnessed record-breaking turnout on May 13 and 20, espectively, as voters put behind separatist-sponsored boycott calls of the past.

While the Srinagar constituency recorded nearly 38 per cent polling -- its secondnighest in the past three decades -- Baramulla registered its all-time high voter turnout of 58.17 per cent.

Spread across 18 assembly segments - seven in Anantnag district, four in Rajouri, hree each in Kulgam and Poonch and one in Shopian - the Anantnag-Rajouri constituency is witnessing a high-pitched campaign with leaders such as National Conference president Farooq Abdullah, his son Omar, Mehbooba Mufti, DPAP chairman Ghulam Nabi Azad and Apni Party president Altaf Bukhari making allout efforts to garner support.

Officials said there has been just one untoward incident so far that happened during an election rally of the National Conference in which three of its workers suffered injuries in a knife attack in the Mendhar area of Poonch on Sunday.

They said a total of 2,338 polling stations, 2,113 in rural areas and 225 in urban areas, are being set up across the constituency. Campaigning is scheduled to end Thursday evening.

Multi-layered security arrangements have been put in place in the poll-bound districts, the officials said, expressing confidence that the trend of record-breaking votng set by central and north Kashmir will continue in south Kashmir as well.

COVID-19 crisis, with the prime minister of the day, the government of the day taking a "serious, sober view" of the challenge.

Jaishankar also cited the example of the eastern Ladakh situation that started four years ago and the way India responded to it.

"While Covid was going on, China decided, end of April, early May, to move a very, very large number of forces to our border. This was in violation of multiple agreements that we were not supposed to bring such a large number of forces the border. And, we were not supposed to bring weapons to the border. Now at that time. April-May, do remember, we were all under a lockdown.

"All of you were sitting in your houses. Nothing was moving in the streets, the airines were shut down, the railways, the roads. In this situation, Prime Minister Modi took the decision that we will send our forces, I don't care what we have to do, they are coming, we will be there, right there...," he said.

The Union minister, a former foreign secretary who has previously been India's envoy in Beijing, termed the China situation back in 2020 a "crisis within a crisis", as it happened when the lockdown was at its peak.

"In this crisis, to have someone determined and resolute saying no, every part of the system has to do, whatever it has to do, but those multiple tens of thousands of troops with their tanks, artilleries, whatever they have to do, will be out there, because there will be no compromise in the defence of India. That to me was also an experience. And, I asked myself that time, had there been someone less resolute...someone less nationalistic, someone less clear in their definition, in their response to our national security needs, what would have happened," Jaishankar added.

He said there is one thing which people often say to him, that "governments change out foreign policy doesn't change".

"All foreign ministers have to hear this. It's like we don't count. We are doing it on auto-pilot. And, I tell people...it's actually not true. The sharpest example I can give you... It matters when I say, it matters who is in power, it matters what is their gut astinct, what is their belief," he said, adding, "look at our response to 26/11 (ten attack) in Mumbai and look at out our response to Uri and Balakot".

He said he thought that nothing could tell one "more clearly, more sharply", because at the end of the day, the armed forces are the same, the bureaucracy is the same, the intelligence is the same.

Something as big as 26/11 happened "without a strong response" on our side, he said, adding, that in "many ways led to a feeling that this country can be repeatedly punched and pushed, something happens and they will keep absorbing it and they will keep reacting to it, they will protest and the world will say yes, yes, very bad...and life will go on".

"Now, Uri and Balakot, was meant to demonstrate that no, life will not go on, and that there will be a price," the minister added.

"Don't think that because you have done something... and run away to that side, you are safe there, you will not be safe there. You will not be safe across the Line of Control and you will not be safe across the International Border. So, there was a very clear direct message out there, and I think the people to whom that message was intended to be sent, hopefully got it," he said.

During the interactive session, Jaishankar was also asked about India's bid for a permanent seat in the UNSC.

"My sense is things are moving in a positive direction. There will be people who will esist it. Because everybody competes, nobody wants anybody else to get ahead. But if you ask me a sense, which way is it moving. I think it is moving favourably. I think more and more countries recognise today what a strong case India has and more and more countries accept the UN itself needs to be reformed, there is no Africa, no Latin America there, very few developing countries out there, I think that also is a fact." he said.

"So, I feel as part of a Viksit Bharat.. the Viksit Bharat will have many, many faces, and many many expressions, and UN Security Council will be one of them,

UNSC has 15 members. There are five permanent members -- China, France, Russia, the UK, and the US, and 10 non-permanent members elected for two-year terms by the General Assembly (with end of term year).

"...As a nation, we must grow for today and leapfrog for tomorrow to realize our goals and aspirations," Jaishankar later posted on X.

In his address, he also said, "So, I tell people that and for those of us who live in Delhi, many of whom will be pressing a button in the next few days, and the button is not just for the next five years, that button is for Viksit Bharat. So, please keep that very much in your mind."

been granted by the high court. However it is equally well settled that if such order of granting bail is found to be illegal and perverse, it must be set aside, it said.

"This court has often interpreted the counter terrorism enactments to strike a balance between the civil liberties of the accused, human rights of the victims and compelling interest of the state," the bench said. "It cannot be denied that national security is always of paramount importance and

any act in aid to any terrorist act - violent or non-violent is liable to be restricted, The bench said the UAPA was one of those Acts that have been enacted to provide

for effective prevention of certain unlawful activities of individuals and associations, and to deal with terrorist activities, as also to impose reasonable restrictions on the civil liberties of persons in the interest of sovereignty and integrity of India. It said there was sufficient material in the form of statements of witnesses and

other incriminating evidence in the form of digital devices, books, photographs etc collected during the investigation and relied upon by the NIA to form an opinion that there were reasonable grounds for believing that accusations against the accused were prima facie true.

"Considering the nature and gravity of the alleged offences and considering their criminal antecedents, in our opinion high court should not have taken a lenient view, more particularly when there was sufficient material to show their prima facie involvement in the alleged offences under the UAPA," the bench said.

"In the instant case, we are satisfied from the charge sheet as also the other material/documents relied upon by the appellant (NIA) that there are reasonable grounds for believing that the accusations against the respondents are prima facie true and that the mandate contained in the proviso to section 43(D)(5) would be applicable for not releasing the respondents on bail," it said.

While setting aside the high court verdict, the top court said these eight accused shall forthwith surrender themselves before the NIA.

Noting that charge sheet has already been filed before the trial court, the bench directed that the special court shall proceed with the trial as expeditiously as possible and in accordance with law, without being influenced by any of the observations made by the apex court in this order.

It noted that the eight accused -- Barakathullah, Idris, Mohamed Abuthahir, Khalid Mohammed, Syed Ishaq, Khaja Mohaideen, Yasar Arafath and Fayaz Ahmed -- were arrested on September 22, 2022 and were in custody hardly for 1.5

On October 20 last year, the apex court had posted the NIA's plea challenging the high court order for hearing after advocate Rajat Nair, appearing for the antiterror agency, mentioned it for urgent listing

In its plea, the NIA had claimed that the PFI is a fundamentalist Islamic organisation and it was formed only to achieve the "dangerous goal" of establishing Muslim rule in India governed by Sharia law.

# Omar questions PDP's allegiance to INDIA bloc, accuses Mufti of targeting only NC not BJP

PAHALGAM: Former Jammu and Kashmir chief minister Omar Abdullah has crit icised the PDP chief Mehbooba Mufti, questioning her allegiance to the INDIA block and the PAGD, and alleging she never campaigned against the Bharatiya Janata Party (BJP), solely targeting his National Conference.

Reiterating the unity of the Peoples Alliance for Gupkar Declaration (PAGD) and its joint efforts during elections, Abdullah said the People's Democratic Party's decision to distance itself from the grouping was driven by self-interest rather than any ideological issue.

"There was a method that they did. As far as the PAGD is concerned, the PAGD is intact. The PAGD fought this election together, whether it was the Awam National Conference, CPI(M) and the NC, it was only the PDP that moved away, the NC vice president told PTI.

The PAGD was formed by six parties which also included the CPI and Sajac Lone's People's Conference. However, Lone's party moved away after defeat in the local body elections.

Abdullah, who kickstarted the final round of campaign in Anantnag-Rajouri seat questioned the PDP's stance on the BJP, highlighting the absence of any active canvassing by Mehbooba Mufti in favour of the Congress or the INDIA bloc, and against the BJP in places like Udhampur and Jammu.

"She didn't campaign against the BJP in Udhampur, nor did she campaign in Jammu. So how can she claim to be part of the INDIA bloc? How can she claim to be against the BJP? She is only against the NC, she is not against the BJP,"

The Anantnag-Rajouri seat goes to poll in the sixth phase on May 25.

Abdullah accused the PDP of fostering animosity against the NC, saying the party had been consistently criticising the NC for the past two years.

Without directly naming the PDP's Srinagar Lok Sabha candidate Wahid Para Abdullah pointed out that as he resumed political activities after being released from jail, his initial speeches were aimed against the National Conference, indicating a deliberate PDP strategy.

"So clearly, the PDP did that by design. There was a method that they did...For the PDP, this alliance was not about ideology, it was self-interest. They wanted a seat from the NC which they did not get. For us and for other constituents of PAGD even INDIA bloc, this was ideological.
