Whereas, the Board advertised these 217 posts, vide Notification Nos. 04, 05, 06 and 07 of 2020 and 01, 02 & 03 of 2021, for seeking applications from the eligible candidates and the Computer Based Written Test (CBT) for these posts was held on 29.11.2022; and Whereas, the selection committee framed the Final Selection List for these posts of Junior Stenographer/ Junior Scale Stenographer/ Steno Typist, which was subsequently approved in the 227th Board Meeting and notified vide No. JKSSB/23/2023-03 (E-7164134) dated 30.05.2023, and

Whereas, the Waiting List for these posts was not forwarded with the main Selection List as it was a Combined Selection and as per the Board Regulations, the Waiting List for such selections shall be forwarded only upon the receipt of such requests from the concerned departments.
