rate online cyber crime complaints. A complaint was received regarding financial fraud of Rs.33,333. The complainant lost his phone while traveling in train, and when he reached home after one day he got to know that someone has withdrawn an amount of

One complaint was received regarding financial fraud of Rs.71,800/- in which complainant saw a post on telegram about investment . The victim invested Rs 71,800. Later complainant come to know that its a

A complaint of financial fraud of Rs 31,000/ in which victim received a call from fraudster posing himself as a Police officer and asked him for money on the pretext that complainants relative is in Police custody. Victim send him an amount of RS.31,000.

During the investigation, the Cyber Cell DPO Jammu, acted swiftly and exhibited hectic efforts which ultimately led to put on hold an amount of Rs 1,06,533 out of 1,36,133 in these three separate online cyber crime complaints. Further investigation is underway.

District Police Jammu, equipped with advanced technology and skilled personnel, remains at the forefront in the fight against cybercriminals.

In another instance, A complaint was received regarding financial fraud of Rs 20,000/. The victim is a owner of sugarcane Rehari at jewel chowk and on May 25, 2024, one person comes to him and asked him that he is in urgent need of Rs 20000 and he will send him Rs 20,000 online and in return he gave him Rs 20,000 in

The fraudster send him a fake credit message of Rs 20,000 and also later on deleted the message. The fraudster received Rs 20,000 from sugarcane Rehari owner and left the spot. When the victim checked his account found no money received. The complainant lodged a written complaint to Cyber Cell DPO Jammu. The cyber cell team acted swiftly and obtained the CDR details from the concerned TSP. Analysed how many messages landed on mobile number of complainant during that period. After hectic efforts the Cyber Cell team apprehended the fraudster and defrauded amount of ?20,000 recovered. Further investigation is underway.

Two drug peddlers arrested with heroin state times news

Fire engulfs forest areas of Kathua, Rajouri

JAMMU: The forest areas in Kathua and Rajouri districts have been engulfed by fire, causing significant damage to forest wealth, officials on Tuesday said.

The officials said the fire started in Dhara Dogano area of Basholi belt in Kathua district and soon spread to nearby regions. The forest department officials and local residents launched an operation to extinguish the flames, successfully bringing the fire under control after

several hours today, they said. The officials said that a fire broke out in Sawni Sassalkote area in Rajouri district and spread to adjacent areas due to strong winds.

The forest department and Forest Protection Force have initiated a large-scale firefighting operation, which is still ongoing as efforts continue to control the blaze. The officials said that some areas in Rajouri have been

experiencing forest fires for the past three days, with continuous efforts being made to contain them. Despite the severity of the fires, no human casualties

have been reported. According to the fire service department, there are cur rently 10 to 13 fire incidents occurring daily, attributed to the rising temperatures.
