"Such forces were responsible for Jungle Raj in Bihar and are now active in Jharkhand," he added.

He said Jharkhand is land of Birsa Munda and revolutionaries, who sacrificed their lives for the nation.

"Your affection and blessings are Modi's strength. BJP and Jharkhand's relationship is of heart's bond. If anyone understands the sentiments of Jharkhand and solves its issues, it is the BJP. We know what is in your mind. What do you want? BJP and Atal Ji created Jharkhand. Congress opposed its creation. It put a brake on Jharkhand's development. It wants to give credit of Independence to only one family," Modi said.

BJP not only acknowledged the great contribution of tribals but ensured Janjatiya Gaurav Divas' to pay tribute to great tribal icon Birsa Munda.

The Prime Minister said the BJP-led Centre is building tribal museums across the country whereas Congress and INDIA bloc opposed even making a tribal woman

"JMM and Congress consider Jharkhand's 'jal, jungle, jameen' (water, forest, land), which are the natural rights of tribals, as their property. A huge amount of over Rs 300 crore was recovered from the premises linked to a Congress MP from Jharkhand. If Congress forms the government at the Centre, it will indulge in unrestricted loot," Modi said.

Congress put a brake on Jharkhand's development as it was accustomed to planning sitting in AC rooms in Delhi whereas BJP planned from the grassroots, he added.

He sought votes for party candidates in two Scheduled Tribe reserved Lok Sabha constituencies - Singhbhum and Khunti. The party has fielded sitting MP Geeta Kora, who recently switched to BJP from Congress, from Singhbhum and Union Minister Arjun Munda from Khunti. Modi is on a two-day visit to Jharkhand beginning Friday, during which he will also address two election rallies in Palamu and Gumla on Saturday.

Notorious gang of truck robbers busted; 3 arrested so far

SRINAGAR: Police in Srinagar have busted a notorious gang of robbers by arresting three accused persons involved in the commission of crime besides, recovered stolen items from their possession.

On 29/04/2024, Police Station Shalteng received a written complaint from one person namely Hakam Khan (driver) son of Anwar Khan from Rajasthan, stating therein that during the night of April 28/29, around 2:30 am, while driving his truck bearing registration No. RJ19GJ3179 at Maloora, a group of men stopped the truck and forcefully took control of his truck and decamped with cash amount of 215,000, 02 cell phones including truck cleaner's cell phone, a gas cylinder, 02 vatches and the truck's music system. The driver was also physically assaulted during the incident

Regarding the incident, a case vide FIR No 28/2024 under relevant sections of law vas registered at Police Station Shalteng and investigation was initiated.

During the course of investigation, the investigating teams raided various locations in Srinagar and after strenuous efforts of territorial officers and with the help of technical data analysis, zeroed in on three accused persons identified as Mohd Amir Keenu son of Mushtaq Ahmed resident of Palpora A/P Puran Teng Maloora, Adnan Ahmed Shah son of Mohd Aslam Shah resident of Kanipora Nowgam A/P Padshaha Bagh and Imran Ahmed Shah son of Gh Mohd resident of Kanipora Nowgam.

During preliminary investigation, it surfaced that these criminals operated a wellorganized gang with a modus operandi of targeting vehicles plying on the NHW through Srinagar. Stolen goods including gas cylinder, mobile phones etc. have been recovered from the accused persons. They have been arrested and shifted to police

station where they remain in custody. Pertinent to mention here that these accused persons are also involved in robbery of trucks along Lasjan Highway on 23/04/2024 & decamped with cash Rs 8000, m ATM cards, DL and mobile phone of the truck drivers. To this context, FIR 44/2024stands registered under relevant sections of law in PS Nowgam. Search for other accused persons involved in the crime is underway.
