JAMMU: Divisional Jammu, Commissioner Ramesh Kumar, on Saturday chaired a meeting to discuss issues pertaining to traffic management and its regulation in Jammu Division. He laid stress on meticulous road planning, better maintenance and effective traffic regulation in cities, towns and National Highways

The meeting was attended by DIG Traffic Jammu, Deputy Commissioner of Jammu, Samba, Udhampur, SSP Jammu, SSP Traffic Jammu City, SSP Traffic Rural, SSP Traffic NHW Ramban, Director School Education Jammu, Joint Transport Commissioner, Jammu, Joint Commissioner JMC, senior officers from PWD, NHAI, NHIDCL, Sampark, District Administration and other concerned officials.

During the meeting, threadbare discussions were

held on improving the overall traffic scenario in Towns, National Cities and Highways inJammu Division. Directions were issued to the concerned authorities to ensure proper maintenance of roads with quality blacktopping and installation of crash barriers, view cutters wherever construction of National Highways and other roads is

Reviewing the traffic scenario of Jammu City, the Div Com directed authorities to ensure pothole free roads and eviction of encroachments from connecting and city roads in Jammu. The Div Com instructed PWD and BRO to improve R S Pura-Satwari road, Manda-Nagrota TCP road while NHIDCL was directed to leveling of the riding/driving surface at Bhagwati Nagar at the earli-

For better traffic movement in Jammu City, directions were issued for identification of spots where roads get damroads, clearing footpaths of encroachments, removal of wreckage, debris or building material that may block roads, installation of road sigshowing 'Nearest Parking', identification of new vending zones by JMC, and close check on roadside parking of School buses outside schools and proper functioning of Integrated Traffic Management System in Jammu city.

RTO Jammu was asked to launch an awareness drive to educate the buyers and sellers of motor vehicles regarding re-registration of the vehicles after sale-purchase and for what types of vehicles and conditions it is not allowed by Motor Department.

Reviewing the traffic management on Lakhanpur to Udhampur Banihal and Jammu-Poonch National Highway stretches, the Div Com inquired from observations and challenges in smooth traffic flow.

The Div Com directed stakeholders to share the observations with the concerned road authorities for improving the traffic. He called for concerted efforts from all concerney for smooth traffic movement on the NH. He further asked the Traffic Department to share data of hotspots of traffic on Rajouri-Poonch NH and for Ramban-Batote-Doda NH to PWD.

Directions were also issued to NHAI to ensure proper maintenance of Lakhanpur to Sidhra and Udhampur to Banihal road where road construction works are going on. ## Power supply maintained in Kashmir despite numerous challenges: PDD

SRINAGAR: A spokesperson for Jammu & Kashmir Power Development Department (JKPDD) provided an update on the damage to region's power infrastructure and its consequent effect on the power supply, following the catastrophic incident of land subsidence in district Ramban on the evening of April 25th, 2024. The severity of the situation was significant, rendering the affected areas inaccessible. Despite the challenges posed

by the incident, emergency restoration works were promptly initiated by both PDD's and PGCIL's restoration teams. As per the initial reports, four vital links involving two Double Circuit (D/C) transmission lines, owned by PGCIL, connecting the Kashmir Valley to the Northern Grid through Peer Top route (Jawahar Tunnel) suffered outage - one of the transmission lines had sustained substantial damage while the other transmission line running parallelly in the same locality, was kept under shutdown as a precautionary measure. However, the department's prior planning and timely action executed in the past, by laying of another 400 kV Samba (Jammu)-Amargarh (Kashmir) Transmission line. following an entirely different route via Mughal Road, proved helpful during this catastrophe. Consequently, the power flow to the valley was conveniently maintained through the  $400\,\mathrm{kV}$ Samba (Jammu)-Amargarh (Kashmir) Transmission line. without any disruption in power supply. Besides, the power being generated from locally situated powerhouses of Kashmir (both NHPC & JKPDC) is also being utilized to meet the load demand of the Kashmir valley.

It's worth noting that more than a decade ago, similar damage occurred to the Transmission line passing through Peer Top route which had plunged the Kashmir valley into darkness for over 13 days, as the 400 kV Samba (Jammu)-Amargarh (Kashmir) Transmission line was not existing at that time. As per the latest reports, one Double circuit Transmission

charged on 30th April, 2024 while one of the circuits of the other D/C Transmission line is expected to be charged on Emergency Restoration Systems (ERS) by 15th May 2024. During the same period when the land subsidence occurred, heavy rainfall and wind storm outside the sinking zone of same district, caused damage to one of the towers of 132 kV Chenani-Srinagar (CSTL) line. The said line feeds Tathar Grid, which caters power supply to Banihal and adjoining areas. However, the disruption was momentary as power supply to the Tathar Grid was promptly restored from the alternate Mir Bazar Grid. Thus, the damage did not affect the power supply in the area. Likewise, the underlying distribution infrastructure also got damaged due to the land subsidence, primarily damaging the 33/11 kV Receiving Station Kanga besides uprooting of many poles, affecting around 10,000 consumers. However, various alternate/ temporary makeshift arrangements were swiftly made to ensure smooth power supply to about 2500 consumers the very

consumers was also restored in two-day period. The department's spokesperson further informed that as the high demand winter season has just concluded in Kashmir and the load/ demand in the valley has started to reduce gradually with the rising temperature, the department has prudently ensured providing around 1400-1450 MW (average) of power supply in the valley despite the fact that hydro power has not fully come up as the water level in J&K rivers is still low. As such, power is being sourced through the Central Generating stations, with major share coming from Thermal Power Plants A comprehensive schedule of power supply has been devised and is diligently adhered to. However, the spokesperson expressed his deep concern over the incidents of rampant power theft, particularly mid-span hooking, being reported in several areas, which

render the system vulnerable to damage and in turn, inevitable power disruptions. Accordingly, besides taking technical measures by replacing bare conductors with Aerial Bunched Cables to deter hooking, concerted efforts are being made to eliminate power pilferage.

The department has initiated massive enforcement drive against power theft, which will be substantially scaled up, and it will be ensured that stringent action under law is taken against those indulging in power theft. It was further informed that instances of power theft have also been reported in the smart metered areas. The department is taking a very strict view of such cases and Legal action under Section 135 of the Electricity Act is being pursued vigorously to combat such violations and uphold the integrity of the system. The department remains committed towards providing best of services to the legitimate consumers. Besides a 24x7 call centre is fully functional, which facilitates complete end-to-end disposal of complaints, which are monitored at the highest levels. In addition, a separate mechanism is also in place for monitoring the damages to distribution transformers, regardless of their location including the most remote or inaccessible

It was reiterated that in today's modern era, where ondemand services have become a practice, the power sector is no exception. The payments to different generators towards procurement of power for its further distribution to the consumers is to be timely made, which is being monitored through an online portal in realtime. Any delays in payments results in power regulation by the Gencos. Similarly, consumers are expected to promptly make payments on the same lines for their electricity usage and any violations/ breaches whether in making payments or resorting to any illegal methods of drawing electricity are not acceptable. The modern interventions are intended to facilitate better services to the consumers, ultimately aiming to provide 24x7 power supply

## Court frames charges against Ex-Chairman BOSE, others in ETT

JAMMU: Special Judge Anticorruption Jammu Tahir Khurshid Raina on Saturday framed charges, in much publicized ETT Scam, against Mohd Abdullah Charoo Ex-Chairman BOSE, Bashir Ahmed Dar the then Director Academics and owner of ETT colleges. The gravamen of the charge-sheet against the accused is grant of alleged illegal permissions by the accused-public servants (the then J&K Board of School education authorities) to the accused-beneficiaries/owners and many others for establishing of Elementary Teachers Training (ETT) Institutes in the private sector of the erstwhile State of Jammu and Kashmir in the year, 2000 onwards. Unfortunately, this illegal

cum unthoughtful act laid the foundation of an unprecedented scam in the history of educational sector of the State, as described in the charge-sheet. The case set up by the pros-

ecution in the main as well as in the supplementary chargesheets is that the accusedpublic servants have granted 22 illegal permissions in the first instance for establishing ETT institutes which later on led to opening of floodgates of said institutions in the length and breadth of the State of J&K. However, out of the said 22 institutes, the owners/settlers of only five stand charge-sheeted by the investigating agency and rest of owners seem to have managed their escape from the clutches of law. It was in context of this

uneven, unjust and unfair dealing with the case by the Investigating Officer (IO) in the earlier investigation that this court, while giving various directions for further investigation, also directed the I.O to look into this issue afresh so that no similarly circumstanced can manage to go scot-free from the writ of law. Though the SIT has brought on record illegal permission letters issued in favour of all said institutes by the accused-public servants with other details of their working, but failed to array the owners of said institutes as the accused in the supplementary charge-sheet for the reasons but known to it.

Court observed that the material on record in the form of main and supplementary charge-sheets primafacie reflects the criminality committed by them as like that of the charge- sheeted accused. Therefore, the said left out owners cannot claim different treatment and watch these all proceedings in the court as spectators. They

are similarly circumstanced in context of managing the illegal permissions from the accused-public servants and based thereon they established their illegal institutes to simply earn the money by illegal means. Therefore, once their very foundation for establishing these institutes is ex-facie similar to that of already arraigned accused, they cannot be treated differently but have to face the writ of law. How to catch them now through the process of law is the next question

> before the court. Court further observed that law is not helpless to deal with such a situation where the IO has either on extraneous consideration or inadvertently given clean chit to the real accused in the case during the course of investigation. Fact remains that the criminal court, while not acting as the post office or the spokes person of the prosecution, if finds the complicity of any such person in the commission of offence, is very well empowered under the Code of Criminal Procedure (for short "the Code") to catch him to face the writ of the

> There are two stages anticipated under the Code when the criminal court can deal with such a lapse in the investigation/charge-sheet to bring

to book the unexposed faces who are the part of the crime. One at the stage of charge when the court has to take cognizance of the case and second during the course of trial, when the incriminating evidence comes before the court against such persons. and based thereon, the court, by invoking the provision of Section-351 of the Code, corresponding to Sec-319 of the Central Code, can array such persons as accused and summon them to face the trial. Court further observed that

however, in the instant case. here is the stage when this court has to take cognizance of this case as it is fixed on charge. Here it is apposite to mention that this court is also a court of Magistrate and has trappings of both as a court of Magistrate and the court of Sessions (For ref- Diwan Singh V/s State & Anr. Once this court is also a court of Magistrate, it can follow the mandate of Sec-190 of the Code, read with Sections 173 & 204 of the Code. As per the mandate of Sec-190, Cr.P.C, the Magistrate is empowered to take cognizance of the offence on the basis of three sources as put in the said provision. If the Magistrate. while exercising said power, has taken cognizance of the offence based on the police

report, filed U/Sec 173,

other person as an additional accused, who from the facts stated in the charge-sheet, may appear to have committed the offence. Thus, the Magistrate can ignore the conclusion drawn by the investigating officer in the charge-sheet so far as arraying of the new accused is concerned. It is by virtue of said legal position, Court propose to catch the left out offenders, who have managed to escape the clutches of law. My appreciation of the law on the point draws a full legal strength
