On April 28, a village defence guard (VDG) was killed in a brief encounter with terrorsts in the remote Panara village in Udhampur district.

Security agencies have expanded the scope of the search operation to various areas of Doda, Udhampur, and Kathua districts to track down the terrorists.

The ongoing search operation, which entered its 10th day on Tuesday, has been extended to the Bhalessa areas of Doda district, while operations continue in Basantgarh, Dudu,

Bani, and Seoj areas of Udhampur and Kathua districts, officials said. However, there has been no breakthrough in the search so far, they said.

Additional Director General of Police (Jammu zone) Anand Jain had earlier said that the wo groups of terrorists are believed to be present in the area after recently infiltrating from across the border, with each group consisting of four and six members, respectively. The twin districts have witnessed several major terrorist attacks in the past two years, indicatng a resurgence of terror activities in the region, which was once declared terrorism-free and remained peaceful between 2003 and 2021.

to spoil the game and put a Babri lock on the Ram temple in Ayodhya, he said. The PM said that about 14 days back, he challenged Congress to give in writing to the country's 140 crore people that it will not give reservation based on religion.

"Secondly, I asked them to give in writing that they will never snatch reservations being given to SCs, STs and OBC and thirdly, to give in writing that they will never give reservations to Muslims through dacoity on the existing OBC quota, but they are not responding and put a lock on their mouths," he said.

Modi claimed the Congress has also talked about giving priority to minorities in sports. "I wanted to ask Congress, if it wanted to do so, why it divided the country in three parts after 1947. At the same time, the entire country would have been made Pakistan and at the same time, India would have been erased," he said.

The PM said he wants 400 Lok Sabha seats to prevent Congress from "dacoity" of the OBC quota to benefit its vote bank.

Lashing out at Congress for claiming that BJP will alter the Constitution in the third term, Modi said, "We have also used these 400 plus seats to extend SC/ST quota for 10 years, appoint a tribal woman as the country's President for the first time and to provide eservation to women, Modi said.

"Modi is asking for 400 seats so that the Congress does not hand over the country's vacant and and islands to other countries, it does not take away reservation given to SC/ST/OBCs and give it to its vote bank and does not declare all castes of its vote bank as OBC overnight," he said.

Without naming Lalu Prasad, Modi said a big alliance partner of the INDIA bloc has endorsed what he used to say about their plan to end the reservations for SC, ST and

He said if Congress has its way, it will say its vote bank has the first right to live in India and asserted "till Modi is alive, he will foil attempts to erase India's identity in the name of fake and pseudo-secularism".

Briefly stating the facts in the instant petition are that a civil miscellaneous appeal came to be preferred against the order dated 02.01.2024 passed by learned Sub Judge (CJM), Jammu, whereby and where-under, the status quo has been directed to be maintained with respect to the service status of the petitioner herein (respondent No.1 therein) with the prayer for setting aside the same. The leave application arises out of a civil miscellaneous appeal which has been filed by the respondent no.5 herein against the order dated 02.01.2024 passed by the learned Sub Judge, Jammu, whereby the said court has proceeded to pass orders of status quo as regards functioning of the plaintiff (petitioner herein) as Managing Director of Jammu Tehsil, Cooperative Marketing Society Ltd. Government undertaking who had since completed his service tenure on 15.07.2020 in terms of the Resolution dated 16.07.2020.

A suit came to be preferred by the plaintiff (petitioner herein) before the court of Jammu on 14.12.2023 restraining the defendants from terminating the services of the plaintiff or interfering into the working of the plaintiff as Managing Director of Jammu Tehsil Cooperative Marketing Society Ltd on the strength of a resolution adopted on 16.07.2020. The plaintiff did not array the respondent no.5 as a party in the suit before the Trial Court and obtained exparte order, whereas, the fact remains that the respondent no.5 happens to be a proper and necessary party to the proceeding as directly affected by the order impugned dated 02.01.2024.

The petitioner herein filed a suit for permanent prohibitory injunction restraining defendants from terminating the services of the plaintiff or interfering into the working of the plaintiff claiming to be the Managing Director of Jammu Tehsil Cooperative Marketing Society Ltd in view of the resolution adopted in general body meeting.

The Trial Court vide order dated January 2, 2024 directed the parties to maintain status quo with respect to the service status of the plaintiff till next date of hearing and feeling aggrieved of the aforesaid order, an appeal came to be preferred by the respondent no.5 before the appellate court.

The appellant (respondent no.5 herein) claimed to be Chairman of the Jammu Tehsil Cooperative Marketing Society Ltd was aggrieved of the order impugned and sought leave of the Court to file the appeal on the ground that the plaintiff had proceeded to file suit without arraying the appellant as a necessary party in the suit and obtained ex parte order which if allowed to sustain, the plaintiff would perpetuate his stay in the organization, when the fact remains that the same was not legally permissible on any count and thus, the appellant was directly affected by the said order dated January 2, 2024 and hence leave was sought to file an appeal.

The specific objection was taken before the appellate court by the petitioner that the appeal was time barred because the order which was impugned in the appeal was passed on January 2, 2024, whereas, appeal along with application for leave to appeal was filed on February 23, 2024, which was barred by limitation.

Justice Wasim Sadiq Nargal after hearing both the sides observed that the law has been settled that suppression of any material fact amounts to abuse of the process of law and amounts to fraud and would deprive an unscrupulous litigant from availing equitable or discretionary remedies. In the present case, the petitioner has not approached the trial court with clean hands and has suppressed the material facts by way of misrepresentation and playing fraud on the court by deliberately omitting the affected party from the array of the respondents knowing fully well that he is the aggrieved party and the issue stands already clinched by this court.

Court observed that since the appellant has raised substantial issue that whether the trial court could have passed such order having regard to the nature of the material placed by the respondent and also in the light of the law laid down by a coordinate bench of this court and the circular issued by the Government governing the said policy, the appellate court has rightly overruled the objection raised by the petitioner herein in granting leave to file appeal. Thus, the order of the appellate court, which is impugned in the present petition, wherein, various issues of legal as well as factual importance have been raised, cannot be faulted and the same is accordingly upheld.

As a necessary corollary, the challenge thrown by the petitioner to the same by invoking the powers of this court under Article 227 of the Constitution of India is ill founded and thus, the writ petition deserves dismissal being devoid of any merit and accordingly, the same is dismissed in limine for the reasons stated hereinabove, Court ordered.

The petitioner has not come to this court with clean hands by playing mischief before the Trial Court, wherein, the petitioner was aware that respondent no.5 was a necessary party and vet, deliberately omitted him from the array of respondents and obtained interim direction against him. Thus, the act of petitioner falls within the realm of playing fraud with the court and such unscrupulous litigants, who play mischief with the court, cannot go scotfree and thus, this court deems it proper to burden the petitioner with costs to the tune of Rs.20,000/- to deprecate such practice of suppression of material facts and playing mischief with the court, which shall be payable by the petitioner to the Advocates' Welfare Fund within a period of four weeks from today, Court ordered.

According to state election officials, Murshidabad registered the highest voter turnout of 76.49 per cent followed by Maldaha Dakshin (73.68 pc), Maldaha Uttar (73.30 pc), and Jangipur (72.13 pc).

The TMC, BJP, and the Congress-CPI(M) alliance lodged separate complaints related to poll violence, voter intimidation, and assaults on poll agents. The EC received 182 complaints by 9 am, most of which were from Murshidabad and
