

JAMMU: Chief Election Commissioner (CEC) of India Gyanesh Kumar inaugurated a two-day capacitybuilding training programme for Booth Level Officers (BLOs), BLO Supervisors, Registration (EROs) from Haryana and NCT of Delhi at the India International Institute of Management (IIIDEM),
