- Date of Birth Certificate.
- Category Certificate (SC/ST/Ex-serviceman/OBC/Physically Handicapped/EWS) if any.
- Aadhar Card.
- Domicile Certificate should be produced at the time of admission in the ITI.

After completing the online application, candidates must submit a printout of the system-generated application form along with self-attested photocopies of the aforementioned documents to the office of Govt. Women ITI Jammu. Additionally, a **non-refundable application fee of Rs. 100/- (One Hundred Rupees only)** must be paid in cash for **upto three trades**, against a proper cash receipt issued by the institute.

- Selection will be made purely on the basis of academic merit obtained by the applicants in their qualifying examination (both for free and self financing seats separately)
- On successful completion of training in trades running under NCVT Scheme, certificate will be awarded by National Council for Vocational Training.
