Show Cause Notice

1. Whereas, it has come to notice that number of vehicles registered as Taxi/Maxi cabs at dealer's end by the individual owners as per S.O 653 of dated 5-12-2022 have not paid online requisite fee of Rs. 1.5 lac and plying their vehicles without attachment of permits.

2. Whereas, the enforcement team of this office has launched several drives to seize such vehicles and number of vehicles were seized and released after deposit of requisite fee by the owners for attachment of permit and accordingly were permit issued.

3. Whereas number of such vehicles traced out from vahan software, which have been registered as Taxi/Maxi cab at dealer's end and have not paid online fee of Rs. 1.5 lac for attachment of permit and have been plying without permit, which is against mandatory requirement as per section 66 of MV Act 1988.

4. Whereas, as per section 53 of CMV Act 1988, if any registering authority or other prescribed authority has reason to believe that any Motor vehicle within its jurisdiction....

a) is in such a condition that its use in a public place would constitute a danger to the public, that is fails to comply with the requirements of this act or of the rules made there under

b) has been, or is being used for hire or reward without a valid permit for being used as such.

The authority may, after giving the owner an opportunity of being heard, may suspend the registration certificate of the vehicle.

In view of above, the following vehicles are plying without permit as per the vahan software record. The registered owner of the such Taxi/Maxi cab are hereby issued show cause notice through the medium of this notice in the leading newspaper in (English, Urdu, Hindi) of the UT of J&K.

Why the Registration certificate of your vehicle plying without permit should not be cancelled/suspended for your failure to comply with the requirements of Act, or of the rules made their under, your reply must be given personally or through your authorized representative within 15 days. Failing which, it shall be presumed that you have nothing to say in your defence and the action as warranted under Motor vehicles laws shall be initiated.
