For the Town Planning Organisation (TPO), the focus is on strengthening town planning functions to meet the growing demands of modern urban development. The restructuring includes creation of specialised units, establishment of policy cells, and realignment of field offices for better coordination and project execution, the meeting was informed.

The Architects Organisation, established in 1971 and responsible for high-value infrastructure projects across J&K, will also undergo structural changes to revitalise its functioning and align with present-day infrastructural needs.

The Srinagar Municipal Corporation (SMC), which has seen a significant expansion in functions following the 74th Constitutional Amendment, currently faces manpower and budgetary constraints. The proposed reorganisation aims to redefine ts administrative setup for better efficiency and service delivery.

In the Directorate of Urban Local Bodies (ULBs) for Jammu and Kashmir, the proposed restructuring addresses staffing gaps, administrative overlaps, and urban sanitation issues. The proposals discussed place particular emphasis on the creation of posts relating to environmental protection and rationalisation of enforcement and

Jammu Development Authority (JDA) has already received approval from its Board for its restructuring proposal, which has been forwarded to the Administrative Department for further consideration.

Srinagar Development Authority (SDA) shall see a detailed comparative restructuring of both gazetted and non-gazetted posts to enhance project execution capapilities and improve policy implementation across expanding urban areas

The meeting was also told about the Urban Environmental Engineering Department (UEED) reorganisation which focuses on strengthening technical manpower and introducing reforms to improve scientific waste management, drainage, and sanitation systems.

The meeting also reviewed the newly framed recruitment rules of the Jammu Municipal Corporation, formulated in light of the reorganisation.

Speaking on the occasion, the Chief Minister said that the implementation of these proposals would significantly enhance the operational capabilities of the Housing and Urban Development Department, generate substantial financial savings, and streamline urban governance across Jammu and Kashmir.

He affirmed that the reforms are aligned with the broader vision of sustainable urban development, transparency and administrative efficiency.

India had launched Operation Sindoor on May 7, targeting nine terror hubs in Pakistan and Pakistan-Occupied Kashmir, in retaliation to the April 22 terror attack that killed 26 people in south Kashmir's Pahalgam.

The heavy cross-border shelling and air strikes that followed had pushed both the countries to the brink of war, triggering widespread fear and precautionary shutlowns. The two countries agreed for a pause in hostilities on May 10.

While most schools in Jammu region reopened by May 15, those in close proximity to the borders had remained closed to ensure students' safety as India continued

oday," said an official on Monday. Zonal education officers have been instructed to ensure that safety and security guidelines are strictly adhered to in their respective jurisdictions, he said.

Replying to queries from members, Misri said the conflict between India and Pakistan was always in the conventional domain, and there was no nuclear signalling by the neighbouring country.

Tharoor told reporters after the three-hour meeting, which he said was attended by a record 24 members, that the committee unanimously expressed solidarity with Misri in the face of "unwarranted attacks" he had faced online after the two sides agreed to stop military actions

As Misri and his family had been at the receiving end of trolls' vitriol, the committee expressed support for his good service to the nation. The committee wanted to ss a formal resolution but the IFS officer requested against it

Some MPs, the sources said, asked if Pakistan used Chinese platforms in the con-

Misri said it did not matter as India hammered Pakistani air bases. To a question about Pakistan managing to secure a loan from the IMF, he said India opposed it but different countries are guided by their own interests, sources said.

To questions about Turkiye's adversarial stand against India, he said the country had traditionally not been a supporter of India and added that he did not foresee any chance of improvement in Indo-Pak ties due to the neighbouring country's continuous display of hostility.

The ministry said in its presentation that India witnessed last year alone at least 24 terrorist attacks linked to Pakistan-based terror organisations, leading to the death of 24 security personnel and 30 civilians.

"Terrorists are found to be using military grade weapons, assistance through drones, secure communication equipment, navigational aids, steel-coated bullets and assistance in infiltration through coordinated ceasefire violations by Pakistani troops," it said, seeking to establish the help provided by the Pakistani state in ter-

Misri was also dismissive of the opposition's criticism of External Affairs Minister S Jaishankar, with Congress leader Rahul Gandhi citing a comment by him to claim that Pakistan was informed about Operation Sindoor and asking how many planes India lost due to this.

The minister is being quoted in wrong context, he said, adding that a contact was made with Pakistan at the DGMO level only after the strikes on terror sites on May

The meeting was attended by a number of lawmakers, including the TMC's Abhishek Banerjee, the Congress' Rajeev Shukla and Deepender Hooda, AIMIM chief Asaduddin Owaisi, and the BJP's Aparajita Sarangi and Arun Govil.

The meeting's agenda was the "current foreign policy developments regarding India and Pakistan", which comes against the backdrop of the Indian armed forces carrying out Operation Sindoor to avenge the Pahalgam attack and the subsequent

military actions between the two countries. India and Pakistan reached an understanding on halting all military actions on May 10.

As part of Operation Sindoor, the Indian Army undertook rapid deployment of surveillance assets and air defence systems, in close coordination with the IAF and BSF, a senior official said.

On the western front, the desert stretching from Jaisalmer to the Kutch region witnessed a "swift and coordinated operational response" from the three forces.

"These joint actions not only blunted enemy intent, but also established a new nor mal in maintaining operational dominance along the western front. The calibrated positioning of weapon systems and other operational enablers, aligned with civil administration support, ensured effective area domination and neutralisation of potential threats," the senior official added.

During his interaction with soldiers of the Konark Corps, the Army chief acknowledged their valour, unwavering commitment, and dogged determination in defending the international boundary

Gen Dwivedi praised the troops for their vigilant actions, including the "successful neutralisation of enemy drone incursions", which effectively prevented any misadventure by the adversary in the desert theatre, the senior official said.

He highlighted the Indian Army's tradition of honour and its unflinching readiness to "meet future challenges with decisive force", reaffirming the force's commitment to safeguarding national sovereignty and ensuring high operational preparedness amid a dynamic security environment, the official said.

Appreciating the fortitude of men and women serving in the harsh desert terrain amid peak summer conditions, Gen Dwivedi conveyed his and the nation's admiration for their unrelenting service in defence of national objectives, the official said.

Under Operation Sindoor, India on early May 7 destroyed nine terror infrastructures in Pakistan and Pakistan-Occupied Kashmir (PoK). Following the Indian action, Pakistan attempted to attack Indian military bases on May 8, 9 and 10.

The two sides reached an understanding on cessation of hostilities on May 10 after four days of confrontations.

There is "no expiry date" to the understanding reached between Indian and Pakistani Directors General of Military Operations (DGMOs) on cessation of hostilities nearly a week back, the Indian Army said on Sunday.

The clarification came following reports that the arrangement between the two militaries on stopping the hostilities was ending on May 18 evening.

"temporarily" extending CISF's cover to these processes in "direct response" to the terrorist attack in Pahalgam and the subsequent security scenario in the country. The CISF, according to the mandate, is only entrusted to frisk passengers and their cabin baggage

The cargo and in-line hold baggage screening system (ILHBSS) checking is done by private security staff engaged by the airlines and airport operators.

The force is "hard pressed" for manpower while securing the 69 airports under its cover. A number of leaves have been cancelled and reserve staff has been brought onboard to undertake this temporary duty of supervising checks for cargo and inline hold baggage screening, a senior officer said.

The spokesperson had said the enhancement of CISF's mandate was "essential" to "reinforce" security arrangements at all civil airports.

The May 9 directive also authorised CISF personnel to perform random checks and oversee access control to these "critical" facilities (airports).

About two lakh personnel strong CISF under the Union Ministry of Home Affairs is the national civil aviation security force and it has deployed around 45,000 personnel to guard 69 airports as part of its aviation security group (ASG).

## New e-Zero...

Cybercrime Reporting Portal and the National Cybercrime Helpline 1930 have enabled easy reporting and prompt action on complaints related to cyber financial

The newly introduced process involves integration of I4C's NCRP system, Delhi Police's e-FIR system and National Crime Record Bureau's (NCRB) Crime and Criminal Tracking Network & Systems (CCTNS).

Now, complaints related to financial losses above the threshold limit of Rs 10 lakh made to NCRP and 1930 will automatically lead to registration of a Zero FIR with the e-crime police station of Delhi. This will be immediately routed to the territorial cybercrime police stations

Complainants can visit the cybercrime police station within three days and get the Zero FIR converted into a regular FIR.

The Delhi Police and the I4C have worked together to put in place a process for registration of cases in accordance with the new provisions of Section 173 (1) and 1(ii) of Bhartiya Nagrik Suraksha Sanhita (BNSS).

This process of issuing FIRs electronically irrespective of territorial jurisdiction (e-Zero FIR) will initially start in Delhi as a pilot. Subsequently, it will be extended to other states and UTs.

The e-Crime Police Station of Delhi has been notified for the registration of e-FIRs and transferring them to jurisdictional police stations in Cybercrime complaints of a specified nature reported on NCRP, the statement said.

In addition to the arrests made from Punjab and Haryana, an alleged agent of Pakistan's intelligence agency Inter-Services Intelligence (ISI) was arrested from Uttar Pradesh's Rampur on Sunday by the state's Special Task Force.

On May 4, Punjab Police arrested Falaksher Masih and Suraj Masih -- both residents of Ajnala in Amritsar -- for their alleged role in leaking sensitive information and photographs of Army cantonment areas and air bases in the border district to

Both were allegedly involved in collecting and transmitting crucial information such as the Army's movements, locations of BSF camps and airports, photographs, and other sensitive data to their handlers in Pakistan, police had said.

Two more persons, including a woman, were arrested by the Punjab Police on May 11 for their alleged involvement in espionage activities linked to Pakistani official Danish posted at the High Commission in Delhi.

The accused were identified as 31-year-old Guzala and Yameen Mohamad, both residents of Malerkotla. They were receiving payments through online transactions in exchange for sharing classified information, as per police investigation.

During questioning, Guzala allegedly confessed to having shared the confidential information about activities of the Indian Army with the Pakistani official posted at Pakistan High Commission in New Delhi. Guzala further revealed that she was doing it for money and the accused official

had sent her Rs 30,000 in two transactions -- "Rs 10,000 and Rs 20,000 -- "via UPI (unified payment interface), he added. Meanwhile, Punjab Police DGP Gaurav Yadav on Monday said that two persons

were arrested for allegedly sharing sensitive military information with Pakistan's intelligence agency ISI. "On 15th May 2025, credible intelligence inputs indicated that Sukhpreet Singh &

Karanbir Singh were engaged in sharing classified details related to #OperationSindoor, including troop movements and key strategic locations in #Punjab, #HimachalPradesh, & #JammuAndKashmir - with #Pakistan's intelligence agency, #ISI," DGP said in a post on X. The Haryana Police, on May 15, arrested 24-year-old Nauman Ilahi from the

Panipat district for allegedly supplying sensitive information to some individuals in

Pakistan. Ilahi from Kairana in Uttar Pradesh was also in touch with a Pak-based ISI handler, as per police investigation. Ilahi worked as a factory security guard and is accused of supplying sensitive information to Pakistan. He was staying with his sister and brother-in-law at Hali

A day after his arrest, Haryana Police arrested a 25-year-old post-graduate student in Kaithal for allegedly having links with PIOs. Devender Singh, from Kaithal district's Guhla area, was arrested for allegedly uploading photos on social media

During further investigation, it was learnt that Singh, who was pursuing a mas ter's degree in political science from a college in Punjab, had gone to Pakistan on pil grimage in November last year.

During the visit, he allegedly came in contact with Pakistani intelligence operatives and remained in touch with them even after his return. Police have said that Singh has allegedly admitted to sending some photos of Patiala cantonment by clicking

Haryana Police on May 16 arrested Hisar-based YouTuber Jyoti Malhotra on the charge of passing on sensitive information to PIOs.

Malhotra, who runs a YouTube channel 'Travel with JO', was arrested from Nev Aggarsain Extension in Hisar. She has been booked under the relevant sections of the Official Secrets Act and the Bharatiya Nyaya Sanhita, Haryana Police said. Jyoti, whose YouTube channel and Instagram accounts have 3.77 lakh subscribers

and 1.33 lakh followers respectively, allegedly was in contact with Pakistani staffer Danish. Her YouTube channel account shows some videos on her visit to Pakistan - "Indian

Girl in Pakistan', 'Indian Girl Exploring Lahore', 'Indian Girl at Katas Raj Temple and 'Indian Girl Rides Luxury Bus in Pakistan'. In 2023, Jyoti came in contact with Danish at the Pakistan High Commission

where she went to seek a visa to visit the neighbouring nation, according to an FIR lodged at the Civil Lines police station, Hisar. Hisar Superintendent of Police Shashank Kumar Sawan on Sunday said PIOs were developing Malhotra as an asset. She was allegedly in touch with Danish dur ing the four-day military conflict between India and Pakistan following Operation

Malhotra, who has been taken on a five-day police remand, was directly in touch with PIOs, he said.

"This is also (a kind of) warfare, in which they try to push their narrative by recruiting influencers," Sawan said. Malhotra was in touch with PIOs, and she vis ited Pakistan "multiple times" and China once, according to the police.

Her financial transactions and travel details are being investigated.

On Sunday, Haryana Police said it has arrested a 26-year-old man from the Nul district on charges of spying for Pakistan. Armaan was arrested on Saturday for sharing information related to the Indian Army and other military activities with Pakistan through an employee posted at the

High Commission of Pakistan in Delhi, police said. Armaan, who is on a six-day police remand, was allegedly sharing the information

for a long time through WhatsApp and social media platforms. Nuh Police, in a joint operation with a central agency, on Monday arrested a local

quack for allegedly spying for Pakistan. Shahzad was apprehended by the STF Moradabad unit from Uttar Pradesh's Rampur on Sunday following inputs about his alleged involvement in cross-border smuggling and espionage activities for the ISI. The STF said that Shahzad was allegedly passing sensitive information related to national security to his handlers.

He travelled to Pakistan several times over the years and was allegedly smuggling cosmetics, clothes, spices, and other items across the border, the agency alleged.
