India. Whenever there is a direct fight, Pakistan has to face defeat again and again. That is why Pakistan has made terrorism a weapon to fight against India,

Modi recalled his public rally in Rajasthan's Churu after the 2019 Balakot airstrike, and said he had then stated that, "Saugandh mujhe is mitti ki, mein desh nahi jhukne dunga, mein desh nahi mitne dunga (he had taken a vow that he would not let the country down)".

"Today, from the land of Rajasthan, I want to say to the countrymen that those who had set out to erase sindoor have been wiped out. Those who shed the blood of Hindustan have paid for every drop of it. Those who were proud of their weapons are now buried under a pile of rubble," he said.

"This is not a game of vengeance, but this is a new form of justice, this is Operation Sindoor. This is not just anger, this is the fierce form of a capable India. This is the new form of India," he said.

Referring to the 2016 surgical strikes and the Balakote air strike, Modi said earlier India carried out attacks by entering into their houses but now the attack was

He said Pakistan used to spread terror, kill innocent people and create an atmosohere of fear in India.

"Now, Modi, the servant of 'Maa Bharti', is standing here with his head held high.

Modi's mind remains cool but his blood is hot," he said. He said there will be no trade or talk with Pakistan, there will be talk only about

Pakistan-occupied Kashmir. "And if Pakistan continues to export terrorists, it will have to beg for every penny. Pakistan will not get India's rightful share of water. Playing with the blood of Indians will cost Pakistan dearly. This is India's resolve and no power in the world

can shake us from this resolve," he said. The prime minister observed that security and prosperity both are necessary for the creation of a developed India.

"This is possible only when every corner of India becomes strong," he added. Modi also spoke about the multi-party delegations being sent abroad to to highlight India's resolve to confront state-sponsored terrorism emanating from Pakistan

and assert its right to self-defence following Operation Sindoor. "To expose the truth, our all party delegations are reaching all over the world. The real face of Pakistan will be shown to the whole world," he said.

### SC reserves interim...

comprising Chief Justice B R Gavai and Justice Augustine George Masih heard senior advocates Kapil Sibal, Rajeev Dhavan and Abhishek Singhvi on behalf of those opposed to the amended Waqf law and Solicitor General Tushar Mehta, representing the Centre, for about three consecutive days.

The Centre strongly defended the Act, saying Waqf by its very nature is a "secular concept" and can't be stayed given the "presumption of constitutionality" in its

Sibal, leading the petitioners, described the law as a "complete departure from hisorical legal and constitutional principles" and a means to "capture waqf through a

non-judicial process". "This is a case about the systematic capture of waqf properties. The government cannot dictate what issues can be raised," Sibal said.

The petitioners at the present stage sought interim orders on three key issues. One of the issues related to the power to denotify properties declared as Waqf by courts, Waqf-by-user or Waqf by deed.

The second issue was over the composition of state waqf boards and the Central Waqf Council, where they contend only Muslims should operate except ex-officio members whereas the last one is over the provision stipulating a Waqf property won't be treated as a waqf when the collector conducts an inquiry to ascertain if the property is government land.

On April 25, the Union Ministry of Minority Affairs filed a preliminary 1,332-page affidavit defending the amended Waqf Act of 2025 and opposed any "blanket stay" by the court on a "law having presumption of constitutionality passed by Parliament".

The Centre notified the Waqf (Amendment) Act, 2025 last month after it got President Droupadi Murmu's assent on April 5.

The bill was cleared by Lok Sabha with the support of 288 members while 232 MPs were against it. The Rajya Sabha saw 128 members voting in its favour and 95 against it.

A wave of artillery shelling, and missiles and drone strikes by Pakistan in the Jammu region -- particularly in Poonch -- killed 27 people and injured more than 70 between May 8 and 10 after India launched Operation Sindoor to target terror infrastructure in the neighbouring country and PoK.

Thousands have fled from the Line of Control (LoC) and International Border areas to seek refuge in government-run relief camps. India carried out precision strikes under Operation Sindoor on terror infrastructure early on May 7 in r to the Pahalgam attack.

Following the Indian action, Pakistan attempted to attack Indian military bases on May 8, 9 and 10. The Indian forces launched a fierce counter-attack on several Pakistani military installations.

India and Pakistan reached an understanding on May 10 to end the military confrontation after four days of intense cross-border drone and missile strikes.

#### J&K admin directs Govt Deptts to deactivate official websites on private domains ■ STATE TIMES NEWS

JAMMU: The Jammu and Kashmir administration has issued a comprehensive advisory to all government departments, directing them to deactivate official websites on private domains immediately.

It called for the enforcement of a secure, standardised and policy-compliant digital and Information Technology (IT) environment across government establishments in J-K.

The decision follows a high-level meeting chaired by the J-K chief secretary, during which growing concerns over unauthorised digital platforms, outdated hardware and software, and rising incidents of data breaches and phishing attacks were discussed.

"Departments operating official websites on private domains have been ordered to deactivate them immediately. The National Informatics Centre (NIC) in J&K will assist in migrating these to secure government domains such as '.gov.in' or '.ik.gov.in'," General Administration Department Commissioner Secretary M Raju said in a circular here.

He further said, "No new websites are to be created or hosted without IT Department approval". The circular said in view of the growing risks associated with unauthorised digital platforms, outdated hardware, software infrastructure and increasing incidents of data compromise and phishing, a comprehensive set of instructions is hereby issued for immediate implementation and strict compliance.

Referring to compliance with the IT Act and guidelines, the circular said all departments must nominate officers for cybersecurity training sessions and ensure adherence to national cybersecurity protocols.

Laying focus on the standardisation of IT hardware and software, it said government offices must only procure IT equipment that meets specifications set by the IT Department. "The use of pirated or obsolete software, including unlicensed office suites or design tools, must be stopped. Departments must also plan updates and upgrades for all software nearing end-of-support.

The government has made reporting and monitoring mandatory and directed departments to submit detailed compliance reports within 15 days. "These must include website domain status, email compliance, IT audit results and plans for rectifying use of outdated or pirated software." The circular warns that any failure to implement these directions will be taken seriously and can lead to disciplinary action under official conduct and IT governance rules. The guidelines take immediate effect and are aimed at ensuring secure, accountable and modern digital governance across the Union Territory

The administration has also made it mandatory for all officials to use NIC-provided government email IDs for all official communication. "As per fresh directions issued to all departments, no communication should be made or responded to if sent from private email services like Gmail, Yahoo or Rediffmail in order to ensure data confidentiality and pre-

vent leaks of sensitive information", the circular said. It further directed the heads of departments (HoDs) to ensure immediate issuance and activation of official NIC email IDs for all staff involved in administrative or public-facing roles. "Any email received from a non-government domain will be treated as unofficial and may not be acted upon," it said.
