the interest rate of 8.25 per cent on employees' provident fund (EPF) deposits for the financial year 2024-25, equal to the rate provided in the preceding fiscal. The approved rate of interest for 2024-25 was sent for concurrence of the Ministry of

"Ministry of Finance has given concurrence to 8.25 per cent rate of interest on the EPF for 2024-25 fiscal year and labour ministry sent a communication regarding this to the EPFO on Thursday," a labour ministry official told PTI.

Now the interest amount as per the rate ratified for FY25 will be credited into the accounts of over seven crore subscribers of EPFO.

The decision on interest rate was taken at the 237th meeting of the central board of trustees of the EPFO chaired by Union Minister for Labour & Employment Mansukh Mandaviya in New Delhi on February 28.

Compared to many fixed-income instruments, EPF offers relatively higher and stable returns, ensuring steady growth on post-retirement savings. In February 2024, the EPFO had increased the interest rate marginally to 8.25

per cent for 2023-24, from 8.15 per cent in 2022-23. In March 2022, EPFO had lowered the interest on EPF for 2021-22 to an over

four-decade low of 8.1 per cent, from 8.5 per cent in 2020-21. The 8.10 per cent rate of interest on EPF for 2020-21 was the lowest since 1977-78, when it stood at 8 per cent.

irrigation works in the DPRs so that the water reaches up to the last fields in these areas. He also suggested measures to make the execution of works more transparent and beneficial for the public at large.

The meeting reviewed the progress and approved the proposals under the centrally sponsored flagship programme aimed at enhancing the water conservation, climate resilience and sustainable agriculture in the UT.

While highlighting broad contours of the scheme, Secretary RD& PR Department, Aijaz Asad, informed that WDC-PMKSY is continuation of the earlier Integrated Watershed Management Programme (IWMP), which had been subsumed into PMKSY in 2015-16.

He revealed that under WDC-PMKSY 2.0, several initiatives and infrastructure projects had been implemented to boost watershed-based development. Besides, physical and financial progress has been recorded across various districts, with special emphasis on construction of water harvesting structures, ponds and irrigation channels.

Additionally, the rainwater harvesting tanks and bunds for soil and moisture conservation, beautification and rejuvenation of water bodies including springs and streams also constitutes the actions being taken under this programme.

A significant highlight of the year has been the Watershed Yatra Campaign 2025, launched on 5th February in Kathua district by the Union Cabinet Minister for Agriculture and the UT Minister for Rural Development. The campaign underscored the integrated watershed governance and community participation for which $\ensuremath{\mathrm{J\&K}}$ secured the 2nd rank nationally for strategic planning and participatory implementation of WDC-PMKSY 2.0.

In alignment with the theme of public engagement, the Janbhagidhari Watershed Cup is set to recognize 2-3 districts demonstrating exceptional community involvement in project execution, the meeting was informed.

Moreover, it was divulged that as part of a new initiative under WDC-PMKSY 2.0, 300 springs have been allocated to J&K for rejuvenation as pilot projects. Further, under the national initiative to rejuvenate 50,000 springs, 3,100 more have been tentatively assigned to the UT for which the final project guidelines are awaited from DoLR.

The SLSC also reviewed and approved the Annual Action Plan (AAP) for 2025-26 with a proposed budget of Rs 75.80 crore, focusing primarily on Natural Resource Management (Rs 42.70 crore), Production Systems (Rs 15.03 crore), Consolidation & Withdrawal Phase (Rs 2.15 Cr), Work done claims from AAP 2024-25 (Rs 8.14 crore) and Administrative Expenses of Rs 4.15 crore to be utilised over the ensuing financial year.

The committee also approved the revision of Detailed Project Reports (DPRs) to include the newly allocated 300 springs and asked for creation of DPR in consultation with the Jal Shakti Department.

the other hand, we are of the view that the number of posts earmarked for deputation in the cadres of the CAPFs up to the level of Senior Administrative Grade (SAG) should be progressively reduced over a period of time, say within an outer limit of two years.

"This will bring in a sense of participation of the cadre officers belonging to the CAPFs in the decision-making process within the administrative framework of the CAPFs thereby removing the long-standing grievances of the cadre officers," the bench said.

The court said the role of CAPFs is crucial for maintaining security at the borders of the country as well as for discharging internal security duties.

There are various issues connected with the deployment of CAPFs, including coordinating with the state governments and the state police force, it said,

The court said the Centre has taken the view that presence of IPS officers in each of the CAPFs is vital to maintain the character of each of them as a unique central armed force.

"This is a policy decision. Of course, individual officers belonging to the IPS or the association of IPS officers cannot have a say as to how much the deputation quota should be and how long the deputation should continue. They are there on deputation by virtue of the policy decision of the central government manifest through the

service rules/recruitment rules of the CAPFs. "Having said that, we cannot also be oblivious of the grievance expressed by officers of the CAPFs as highlighted supra. Their dedicated service upholding the security integrity and sovereignty of the nation while safeguarding our borders and maintaining internal security within the country cannot be ignored or overlooked," the bench said.

Noting that CAPFs discharge their duties under very demanding conditions, the court said they have a grievance that because of lateral entry into the higher grades of the respective CAPFs, they are unable to get timely promotion.

"Consequently, there is a great deal of stagnation. Such stagnation can adversely impact the morale of the forces. This also needs to be factored in while considering review of such policy decision," the bench said.

Alleged fraudster Angad... officials had cheated the Union Bank of India causing wrongful loss to the bank,"

the CBI said in a statement. They were declared proclaimed offenders and open-ended arrest warrants were

issued against them by the court, it said.

In 2017, the CBI got the Interpol Red Notice against him which alerts all the member countries to locate and detain the wanted person.

"Efforts are continuing for return of family members of the subject, who are other wanted accused in this case. The return of the subject, main co-conspirator in the fraud, will help in starting the trial," the agency said.

Chandhok was sentenced in 2022 to six years imprisonment by a Rhode Island court on money laundering charges.

The justice department said Chandhok, who had at least five others (mostly Indian students in the US) working at his direction, was in direct contact with high-ranking international members of the scheme.

Chandhok had pleaded guilty in the case.

"According to information presented to the court, Chandhok's criminal activity spanned two years, during which time he 'cleaned' at least than 1.5 million dollars The government's evidence showed that in just one month he laundered nearly USD 930,000," the justice department said.

The CBI as the national central bureau for Interpol in India coordinates closely with all law enforcement agencies in the world for cooperation and assistance via Interpol channels. "Since, 2021, over 100 wanted criminals have been returned to India through coordination via Interpol channel," CBI's spokesperson said.
