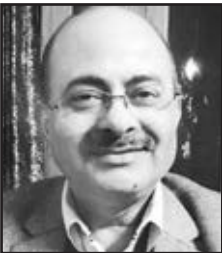

Bovine smuggler detained under PSA

KATHUA: A bovine smuggler has been detained under the stringent Public Safety Act (PSA) in Kathua district, police said on Wednesday.

Abdul Gani was taken into custody from the Maggar Khad area in Lakhanpur; they said. He has been lodged at Central Kot Bhalwal Jail here under the PSA to curtail his illegal activities, a police spokesperson said. He said 10 FIRs have been registered against Gani at three different police stations under various sections of the Prevention of Cruelty to Animals (PCA) Act in Kathua since 2008.

To prevent Gani's illegal activities, police prepared a dossier against him and sent it to the Kathua district magistrate, who issued a detention warrant against the accused under the PSA, the spokesperson said.

Two drug peddlers - Sham of Kotli Pain and Simraan Khan of Jakhani - were arrested along with 5.7 grams of heroin from Chak Magjote in the Rehanbal area of Udhampur district on Wednesday, police said.

A case has been registered against the two under the Narcotic Drugs and Psychotropic Substances Act, the spokesperson said. He said Sham was also wanted by police in multiple cases related to drug peddling and theft.

Three mortar shells found in Jammu, safely destroyed

JAMMU: Three mortar shells were found abandoned on the roadside and were later destroyed in a controlled explosion by a team of Bomb Disposal Squad (BDS) here on Wednesday, officials said.

The mortar shells were noticed by police in the Transport Nagar locality of Narwal in the outskirts of the city late this afternoon, the officials said.

They said the area was immediately cordoned off and shells containing high explosive were removed from the scene by the BDS which was summoned to the spot.

The BDS later destroyed the mortar shells in a controlled explosion in a nearby forest area without causing any damage, the officials said.

13 bovines rescued, vehicle seized, smuggler arrested

2 most wanted drug peddlers arrested with heroin

Upon conducting a thorough frisking of both persons, police team recovered 5.7 grams of heroin (chitta) like Contraband substance from their possession. Both were arrested on the spot.

The arrested individuals have been identified as Simraan Khan S/O Bashir Khan R/O Jakhani, Udhampur and Sham S/O Shankar Dass R/O Kotli Pain District Udhampur.

On this, a case vide FIR No. 70/2025 U/S 8/21/22/ NDPS Act stands registered in P/S Rehambal

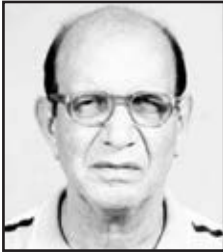
