

Narco smuggler nabbed with heroin

RAMBAN: Under the ongoing drive against drug menace and in line with the directions and supervision of SSP Ramban, Kulbir Singh, Ramban Police achieved a significant breakthrough with the recovery of 07 grams of heroin-like substance (Chitta) at Kala Passi on Link Road Karol to

Maitra. During a routine Patrolling and traffic regulation duty at Kala Passi link Road Karol to Maitra, a suspicious pedestrian approaching from Jaiswal Bridge to Maitra Ramban attempted to flee upon noticing the police party. The alert officers promptly chased and apprehended the individual after a brief pursuit. The individual was identified as Basharat Ahmed, son of Abdul Gani, resident of Daehan Gool, Tehsil Gool District Ramban. Upon personal search, 07 grams of heroin-like substance (Chitta) was recovered from his possession. Accordingly, a Case under FIR No. 104/2025 under sections 8/21/22 of the NDPS Act has been registered at Police Station Ramban. Investigation into the case is currently underway.
