



DCs visit NEET exam centers, inspect arrangements

SRINAGAR: Deputy Commissioner (DC) Srinagar, Dr. Bilal Mohi-Ud-Din Bhat on Sunday undertook a visit to NEET (National Eligibility cum Entrance Test) Centers in the District to have firsthand appraisal about the facilities made available at these Centers for smooth conduct of the examination.
