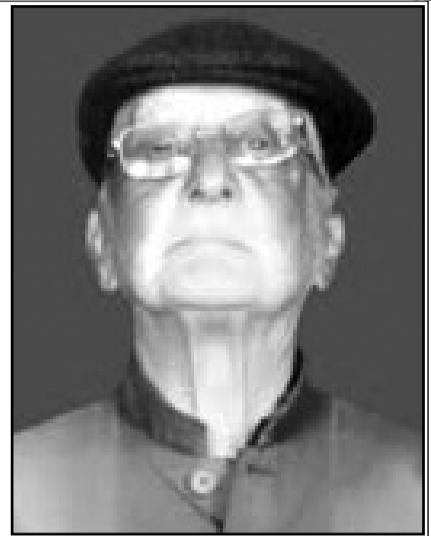

Centurion Choudhary Chaggar Singh, son of Late Shri Jodh Singh was born on March 8, 1921 at Kathua. He had three sisters and three brothers. After completing B.Sc, Choudhary Chaggar Singh joined transport sector and remained as President of Kathua & Jammu Transport Groups. He got married to Smt Shanti Devi, daughter of Maharaja's Wazir Shri Chet Ram and was blessed with two sons and three daughters, who are all married and well settled. Unfortunately, he lost his wife in 2002.

Choudhary Chaggar Singh was a great politician and remained active member of Praja Parishad, Janasang and BJP. He was an associate of Pt Prem Nath Dogra and also remained in Srinagar Jail for one and a half year with Dr Syama Prasad Mukherjee. He was quite close to former Prime Minister, Atal Behari Vajpaee and other senior BJP leaders. He carried out a lot of development works in Kathua. Choudhary Chaggar Singh breathed his last on May 24, 2021 due to cardiac arrest. He is survived by two sons and three daughters.
