# CRIME REPORT

## Two bootleggers held with 35 lts illicit liquor

**JOURIAN:** In a major action against consumption/production of illegal liquor, arrested two bootleggers and seized 60 lts illicit liquor.

As per details, on receiving information that illicit liquor is being manufactured near Jadh village and adjoining areas, a team from Police Post Jourian, under the overall supervision of SSP Jammu Chandan Kohli, led by PSI Karnail Singh Parihar and under the supervision of SDPO Akhnoor Varun Jandial and SHO Akhnoor Insp Hilal Azhar during special checking, intercepted a suspect indulged in trade of preparing/selling illicit liquor. On checking, approximately 35 lts illicit liquor was recovered from the possession of accused, identified as Chain Singh, son of Khajan Singh, resident of Jadh. The consignment of illicit liquor was seized and accused was arrested. FIR No. 164/2022 under section 48(a) of Excise Act was registered at Police Station Akhnoor.

Meanwhile, another bootlegger was arrested by Bishnah Police and 25 lts illicit liquor was recovered from his possession. As per details, acting on information regarding sale and manufacturing of illicit liquor, a team from Police Station Bishnah under the supervision of SDPO R S Pura Surinder Singh and led by SHO Insp Pawan Kumar laid a special Naka near Peer Baba Bishnah and rounded up a suspect, from whom possession 25 lts illicit liquor was recovered. Identified as Babu, son of Manohar Lal, resident of Ward- 13, Bishnah, the accused was arrested and FIR No.98/2022 under section 48 (a) of Excise Act was registered.

## 25 bovines rescued, 5 smugglers arrested

**JHAJJAR KOTLI:** Continuing efforts to eradicate menace of bovine smuggling, Jhajjar Kotli Police rescued 25 bovines and arrested 5 smugglers.

As per details, during checking at a Naka point near village Chhurma, Tehsil Dansal, a team from Police Station Jhajjar Kotli intercepted a vehicle and found 25 bovines, which were rescued. Five smugglers were also arrested who were identified as Mohd Younis, son of Mohd Musa, resident of Nandini; Kaku Khan, son of Chhatu, resident of Mandal Satwari; Shabir Khan, son of Rashid Mohd, resident of Urlani Badsoo, Mohd Ashiq Ali, son of Noor, resident of Kuddal Badhota and Mohd Mirza, son of Mohd Mussa, resident of Satwari. A motorcycle bearing registration number JKo2CJ/2831 along with the vehicle was also seized. Accordingly FIR No 139/2022 under sections 188, 295-A of IPC, 11 of PCA Act, 11/12/13 of Prevention of Cruelty to Animals Rules 2001 was registered at Police Station Jhajjar Kotli. The modus operandi of bovine smugglers was that they first used to reece the area on motorcycle before proceeding ahead to know about any upcoming Nakas. The overall arrests and recoveries were made by SHO Jhajjar Kotli Insp Vikram Sharma under the supervision of SDPO Nagrota Pardeep Kumar.

## Scooty snatcher nabbed

## 270 Kg banned polythene seized

**LAKHANPUR:** In a major success against banned polythene and its smuggling in J&K, the Forest Department has recovered 270 Kg banned polythene from a bus at Lakhampur. On checking, the smuggler managed to flee from the spot but driver was arrested and bus has been seized. The seized consignment will be handed-over to Pollution Control Board for further legal action as per rules.
