  - ii) The tenders shall be accompanied with an earnest money of 2 % of quoted rates in the shape of CDR/FDR, from a scheduled Bank payable in JAMMU. The CDR/FDR shall be pledged to Executive Engineer Jal Shakti (M) GWD Division Jammu, valid for a period of 12 months from the last date of submission of bids. The earnest money deposit shall be refunded in favour of unsuccessful tenderer immediately after finalization of the tender, whereas it shall be retained in case of successful tenderer till signing of agreement and furnishing of performance security.
