CRIME REPORT

Fire breaks out in mysterious circumstances

KATRA: Under mysterious circumstances a fire broke out in mountains of Kadmal area on Katra-Jammu road and due to strong wind, it got spread over an area of 200 to 300 meters.

Immediately on receipt of information, officials of Forest Department with assistance of locals, launched an operation to douse the flames and after hectic efforts brought it under control. Meanwhile, in another case, fire broke out in the forest areas of Panchayat Akhli-Butan and immediately on receipt of information, Forest Officer Manohar Anand and his team rushed to the spot and extinguished fire. The forest officials have urged locals to be careful and vigilant against fire incidents, as due to scorching heat and winds, same can happen.

One nabbed with heroin

UDHAMPUR: Continuing its anti-drug drive, Police has arrested a drug-peddler and recovered 10.40 gram contraband heroin from his possession. According to information, a team under the supervision of Addl SP Anwar-ul-Haq and Dy SP Sahil Mahajan, during checking at a Naka in Salora, Tikri, signalled a motorcycle bearing registration number JK14H-6721 to stop but it fled away. Acting swiftly, the team chased bike and intercepted it at a distance from Naka. The rider was identified as Rakesh Kumar, son of Chuni Lal, resident of Neeli Nallah, Udhampur and

10.40 gm Heroin was recovered from his possession. The accused was arrested and a case under relevant sections of law was registered at Police Station Rehambal for investigation.

6 vehicles seized for illegal mining

JAMMU: In a quest to stern menace of illegal mining, a multi-pronged strategy was devised by Jammu Police in which teams from Police Station Akhnoor, Police Post Chatha and Police Post Phallain Mandal acted stringently on the specific inputs and raided at different locations and seized 6 vehicles involved in illegal mining. The seized vehicles included 2 tractor-trolleys and a tipper without registration number seized by Police Station Akhnoor, a tractor-trolley bearing registration number JK02BK 3675 seized by Police Post Chatha, 2 JCBs, one bearing registration number JK08C-3209 and other bearing chassis number TEP745NSCM8018156 seized by Police Post Phallain Mandal. The recoveries were made SHO Akhnoor Insprr Hilal Azhar, Incharge Police Post Chatha Inspector Ranjit Singh and Incharge Police Post Phallain Mandal PSI Ajesh Singh Jamwal in their respective jurisdictions. DMO Jammu was also intimated about the same.

Elderly man attacked over land dispute

BISHNAH: An elderly man was assaulted by some persons of same village over an old land dispute between two families in Laswada of Bishnah area on Friday.

As per details, 95-years old Baisakhi Ram was attacked by family members of Kaku Ram with sharp-edged weapons, due to which he got seriously injured.

The assaulters fled from the spot after attack and injured was shifted to Bishnah hospital by villagers, from where he was further referred to GMC&H Jammu for advanced treatment. On complaint of family members of Baisakhi Ram, Police has registered a case and arrested a Panch Rakesh Kumar for provoking assaulters. Manhunt also has been launched to trace and arrest all other accused persons.

Two injured in road mishap

LAKHANPUR: Two brothers got injured in a road accident on Friday morning. As per details, two brothers were on their way from Jammu to Pathankot in a car bearing registration number CH01-BB-2515, which hit a standing truck bearing registration number JK02AD-8917 near Golden Gate, due to which both got injured. They were immediately shifted to Government Medical College Hospital Kathua for treatment and were identified as Aman Sharma (27) and Jatin Sharma (28), sons of Bharat Bhushan, resident of Hiranagar, Kathua.

2 gamblers arrested, stake money seized

SOPORE: Acting tough against social crimes, Police in Sopore arrested 02 gamblers and seized stake money from their possession. Acting on specific information about gambling activities in orchards of village Batsuma, a police party from Police Station Dangiwaicha raided the spot and arrested two gamblers, who were identified as Irshad Ahmad Shah, son of Mohammad Yousuf Shah and Javaid Ahmad Shah, son of Abdul Razak Shah, both residents of Batsuma, Rafiabab. Stake money amounting to Rs 15,000, playing cards and a mobile phone were also recovered from gamblers. FIR No. 67/2022 under relevant sections of law was registered at Police Station Dangiwaicha and investigation started.
