

## DC Jammu chairs meeting for setting-up animal shelters

JAMMU: Deputy Commissioner Jammu, Avny Lavasa on Friday chaired a meeting to discuss arrangements for establishment of animal shelters to be managed by Society for Prevention of Cruelty on Animals (SPCA).

Threadbare discussions held regarding notification of per day rates for feeding animals and their maintenance charges, empanelment of two lawyers with District SPCA Jammu, status regarding SPCA land in Chowadi and plantation in the shelter were discussed in the meeting.

It was decided that the per day expenditure rate would be increased from rupees 250 to 265 per animal as per Animal Rule 2017 for feeding and maintenance.

Deputy Commissioner also directed the concerned officer from Forest Department to launch plantation drive at animal shelter places. Besides the status of land in Chowadi, matters regarding fencing, power and water supply

and plantation around animal shelters were also discussed.

CPO Yoginder Katoch, ACG Rakesh Dubey, Vice President SPCA Devinder Kour besides senior officers from Animal Husbandry, Forest, PHE, PDD and other concerned departments were present in the meeting.

### NOTIFICATION

Under Section 11(1) of RECLAR & R Act 2013

Whereas the formal land indent has been placed by the Inspector General HQs Frontier Plourn Camp Jammu vide his office No. I701/Engg/Land/Acq/BSF/2021/95-101 dated 08.01.2021.

Whereas it appears to the Government of UT of Jammu and Kashmir that the land measuring 50K-03M is required for Defence purposes for construction of Border Fencing (135ft wide strip) situated at Village Makwal Tehsil Mandal District Jammu, by the Border Security Force. It is as such hereby notified that land in the area specified is required for the above purpose. The notification is made under the provisions of Section 11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, to all whom it may concern.

The social impact assessment study was exempted by the Government vide Order No 24-JK-(Rev) of 2022 dated 10.02.2022 issued under endorsement No. Rev-Sett/37/2022 (121864) dated 10.02.2022 and Deputy Commissioner, Jammu vide his letter No. DCJ/LHS/BSF/BOP/ACQ/ NA/M/M-1068/19/83-84/2493-94 dated 16.03.2022

In exercise of power vested in me under Section 11 Sub Section (I) of the Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation and Resettlement Act 2013. I. Abhishek Abrol JKAS. Collector Land Acquisition Jammu South do hereby notify that the land whose particular arc given herein below is required for Construction of Border fencing (135ft wide strip) at Village Makwal Tehsil Mandal District Jammu by the Border Security Force.

Further under Section 11(4) of the Act no person shall make any transaction of land or cause an transaction of land i.e. sale/purchase etc. or create any encumbrance on such land from the date of publication of this notification without prior approval of the Collector.

Objections to the acquisition if any, may be filed by the person(s) interested within 60 days from the date of publication of the notification as provided under section 15 of the Act before the Collector Land Acquisition Jammu South.

An objection statement which is received after the due date or which does not clearly explain the nature of the senders interested in the land is liable to be summarily rejected.

Objection received within the due date if any, will be enquired into where the objection will be at liberty to appear in person or by advocate and to adduce any oral or documentary evidence in support of their objections.

##### NOTICE FOR RE-AUCTION OF RETAIL LIQUOR VENDS (JKEL-2) LICENSES

- This notice is for re-auction for allotment of 16 vends for off-premises retail sale of liquor (JKEL-2 License) for the year 2022-23 in the Union Territory of Jammu and Kashmir. The detail of the locations and the number of vends at each location is given in Annexure "A".
- The vends shall be allotted during the Policy year 2022-23, subject to fulfillment of requisite conditions. These vends shall sell, in retail, to the consuming public under one roof JK-Special Whisky and Indian made foreign liquor including imported foreign liquor/beer/wine/cider/RTD which are permitted to be sold by the Excise Department, J&K.
- E-auction for allotment of vends shall be done through J&K Bank on e-auction portal i.e. <https://jkexcisedept.auctiontiger.net> in a completely secure and transparent manner. The detailed procedure for e-auction/instructions to the bidders shall be available on the e auction portal and on the official website of the department i.e. [www.jkexcise.nic.in](http://www.jkexcise.nic.in). The schedule of starting and closing of online bids for each location is given in the Annexure "A" to this notice. All licenses issued through e-auction shall terminate on 31-03-2023 as per clause XXI of bid document, irrespective of date of issuance.
- The Minimum Reserve Price to bid for each vend shall be Rupees Ten lacs as given in the Excise Policy. The bidders can bid in increments of Rs. 5000/- (Max 4 lacs) beyond the Reserve Price. In case a fresh Highest H1 bid is received within 5 minutes before the scheduled closing time of bidding, the time for re-auction shall be automatically extended by another 5 minutes beyond the scheduled closing of the particular bid. A maximum of three such extensions shall be allowed, during which the bid increment shall be Rs. 1,00,000/- (Max Rs. 08 lacs)..
- To ascertain the location and the number of vends permitted there at, bidders are advised to read the Annexure "A" to this notice for location and ascertain the time of start and end of bidding for that location.
- Prospective participants may visit the website/e-auction Portal i.e. <https://jkexcisedept.auctiontiger.net> for information and detailed/step-by-step procedure for re-auction and online submission of participation fee, earnest money deposit (EMD), and uploading of required documents in accordance with the Excise Policy 2022-23.
- In order to submit e-bid, every prospective bidder is required to get himself/herself registered at <https://jkexcisedept.auctiontiger.net>. Registration of prospective bidders shall start from 11-06-2022 on the portal. The bidders are advised in their own interest to complete their registration well in time.
- For detailed terms and conditions including the conditions of eligibility, the conditions to be fulfilled before participation in the bid and those to be fulfilled by the successful bidder before issuance of license, the time allowed for completion of these formalities, the detailed list mentioning locations in which the vends are to be opened and the number of vends in each such location, the conditions governing bidding for more than one vend, the Minimum Guaranteed Revenue (MGR) per vend, Minimum Guaranteed Quota (MGQ) of JK Special Whisky per vend, are given in the Excise Policy 2022-23 issued under SO 71 dated 22.02.2022 and the bid document. These can be downloaded from official website of the Excise Department i.e. [www.jkexcise.nic.in](http://www.jkexcise.nic.in). However, these are to be read with corrections as given in Annexure-B (Corrigendum).
- A bidder can participate in auction for any number of locations. However, only one location shall be allotted as per clause 2.4.4 of Excise Policy and clause V of bid document. A bidder shall have to pay online EMD of Rs. 7 lacs and participation fee of Rs. 25000/ separately for each bid.
- Prospective bidders are advised, in their own interest, to familiarize themselves thoroughly with the provisions of the J&K Excise Act and the Rules made there under, the provisions of the Excise Policy for the year 2022-23 issued under notification SO 71 dated 22-02-2022, and with the area/location for which they intend to bid. This would enable them to bid effectively and with full knowledge of their business prospects as also their obligations/responsibilities. They may visit the official website of the department i.e. [www.jkexcise.nic.in](http://www.jkexcise.nic.in) for information related to Excise Act & Rules.
- Defaulters of e-Auction 2021-22 & 2022-23 are not eligible to participate in the current re-Auction process for policy year 2022-23.
- A telephonic help line number 0191-2475686 has been set up for providing assistance to the participants regarding re-auction. For any doubts/clarifications, prospective bidders may contact this number between 10.00 AM to 7.00 PM.
- Prospective bidders are advised to make transactions on account of Participation fee/EMD amount/Bid amount from their own PAN linked/KYC bank accounts. Any default on this account shall make them ineligible and the EMD/Bid amount shall be cancelled and forfeited without any further notice. In case the prospective bidders have registered with different PAN card, they are advised to create a new user with the correct PAN card.
- The prospective bidders are advised to familiarize themselves with the relevant provisions of J&K Liquor License and Sale Rules 1984 and Excise Policy 2022-23.
