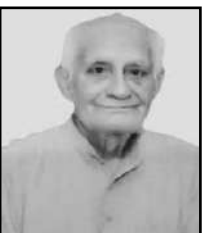

Man held with sharp-edged weapon, Rs 84,000 cash

AKHNOOR: Police on Saturday nabbed a man with a sharp-edged weapon and Rs 84,000 cash at Gharota.

As per details, a team of Police Station Gharota while on Naka duty at Thathi Bridge Naka, rounded-up a suspect on Scooty (JK02CW-7387). The suspect tried to flee on seeing police, but was overpowered by alert personnel. During search, a sharp-edged weapon along with Rs 84,000 cash was recovered from his possession. The accused, identified as Amardeep Singh, son of Amar Singh, resident of Bardal, Akhnoor was arrested and cognizance of the matter was taken by Police Station Gharota. The recovery and arrest was made by SHO Gharota Insp Rajesh Khajuria under the supervision of SDPO Akhnoor Varun Jandial.

Trucker nabbed with 81 Kg poppy straw

RAJOURI: Police on Saturday foiled narcotics smuggling bid and recovered 81 Kg poppy straw from a truck on national highway.

In an official statement, police said that a team led by Incharge Police Post Chingus Chatyar, PSI Sahil Chowdhary under supervision of SHO Rajouri Fareed Ahmed and Deputy SP HQ Vinod Sharma, while in vehicle checking duty at Kallar Naka, intercepted a truck (PB10HT-3747). During checking, three bags containing 81 Kg poppy straw was recovered from vehicle which was seized and accused namely Sajid Iqbal, son of Zaffar Iqbal, resident of ward-6, Galthuta Poonch was arrested. A case under relevant sections of law was registered at Police Station Rajouri and further investigation started.

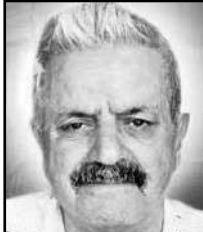
