## Theft case solved; accused arrested, stolen property worth Rs 3.2 lakh recovered

## ■ STATE TIMES NEWS

KATRA: Police on Sunday solved a theft case by arresting an accused arrested and recovered stolen property worth Rs 3.2 lakh from his possession.

As per the details, an FIR no. 09/2022 under section 379 IPC was registered at Police Station Bhawan after a complaint from one woman namely Anubha Sikhi, wife of Deepak Sikhi, resident of 1/5 Pratap Nagar, Tehsil Beawar District Ajmer Rajasthan of theft at the Adhkuwari.

Multiple teams of Police Post Adhkuwari led by In-charge Police Post SI Amit Singh & Suman Sharma SHO Bhawan constituted to work out the theft case. Police teams under the supervision of Nikhil Rasgotra DySP Bhawan & Amit Bhasin SP Katra scanned CCTV footage from the areas, a number suspects were rounded up during investigations, after strenuous efforts police teams zeroed upon one suspect namely Karan Sharma alias Kanu, son of Rattan Lal, resident of Seward, Akhli Bhutan Tehsil Katra District Reasi. Kanu was arrested and put under sustained questioning who during interrogation Confessed about commission of crime.

On his disclosure one apple mobile phone (13 Pro Max) approx worth rupees 14,000, 2 gold rings, 01 Bichi set and cash worth rupees 40,000 was recovered in case FIR No. 09/2022 and during investigation 13 more mobile phones worth rupees 1,20,000 also recovered from the possession of the accused person.

Amit Gupta-JKPS Senior Superintendent of Police Reasi while sharing the details conjectured that further investigations to unearth his linkages with other theft cases
