Near Thanger Pully, Channi Himmat, Jammu is hereby engaged as Registrar against the available vacancy in the Department of Oral and Maxillofacial Surgery, Indira Gandhi Govt, Dental College/ Hospital. Jammu for a period of one years subject to satisfactory work and conduct certificate from the concerned HOD as per S.O 364 dated:- 27-11-2020.

The Doctor shall be paid consolidated pay equal to the post of Dental Surgeon in the Health Department as per the SRO-193 Dated:- 24-04-2018 plus DA.

The Engagement of above said doctor as Registrar in the Department of Oral and Maxillofacial Surgery shall be subject to the following terms & Conditions:-

1. The engagement shall be subject to work and conduct of the doctor in the College / Hospital remaining satisfactory during her tenure, In case of misconduct or negligence in duties or indulging in indiscipline/ Strike or any other activities which many affect the hospital service/ patient care, the engagement of doctor shall be terminated immediately without any Notice .
2. The engagement of the doctor shall be whole time basis and shall not engage herself in private practice and in lieu of the loss of private practice she shall be entitled to non Practicing Allowance (NPA) as admissible under rules, in the event of doctor forund resorting to private Practice, her tenure of engagement shall be terminated without any notice.
3. The doctor shall not be allowed to apply for any job during the engagement period of Registrarship except for J&K PSC and Any application forwarded by the HOD concerned before completing the job of Registrarship shall be treated as cancelled.
4. During tenure of Registrar shall not be entitled to any kind of leave except casual leave for 15 days only. The HOD concerned shall also ensure that if the Registrar remain absent unauthorized, her engagement shall be cancelled forthwith.
5. The Doctor shall submit an undertaking duly authenticated from 1st class judicial Magistrar to the effect that all the documents/ certificates submitted are genuine in all respect and if any document found fake after verification from respective quarters, the engagement shall be cancelled after verification from respective quarters, the engagement shall be cancelled and the selected doctor shall also furnish an undertaking that she has read all the terms and conditions of advertisement notice and shall abide by the same before she is allowed to join.

J&K Football Association Elections NOTICE

In compliance to the directions of Hon'ble Court of 4th Additional District Judge Srinagar, passed in file No. 66 of 21-12-2020, in the civil suit title, as Nazir Ahmad Andabi v/s J&K Football Association and another dated 28-3-2022, election notice dated 18-5-2022 was published in daily newspaper inviting objections to the voter list submitted by Jammu and Kashmir Football Association.

In response to the election notice, number of objections were received challenging the legality, authenticity and validity of the voter list by various Football clubs, District Football Associations and former Office bearers of J&K Football Association.

On scrutiny of the objections, the voter list submitted and published in the election notice dated 18-5-2022 was not found consistent with the relevant provisions of the constitution of J&K Football Association. On this disability the election which was due to be held on 12th of June 2022 will not be conducted.

The matter shall be submitted before the Hon'ble High Court of J&K for appropriate orders as may be deemed fit.
