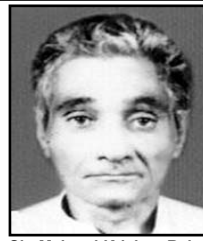

CRIME REPORT

9 vehicles seized for illegal mining

JAMMU: In a quest to stern menace of illegal mining, a multi-pronged strategy was devised by Jammu Police in which police teams of Police Station Akhnor, Police Posts Phallian Mandal, Talab Tillo, Chatha and Border Police Posts Garkhal acted stringently on specific inputs and raided at different locations in their respective areas and seized 9 vehicles involved in illegal mining. The seized vehicles included 2 dumpers and 1 JCB without registration number seized by Akhnor Police; a tractor without registration number seized by Gharota Police; a dumper (JK02BX-3802) and a JCB bearing chassis number HAR4DX4V02879581 seized by Phallian Mandal Police; a tipper (JK02BX 9021) seized by Talab Tillo Police; a Tractor Trolley without Registration number and bearing Chassis no. MBNAAK49ADLTK50477 seized by Chatha Police and a dumper (JK2VC-6120) seized by Border Police Post Garkhal. The recoveries were made by SHO Akhnor Insp Hilal Azhar, SHO Gharota Insp Rajesh Khajuria, Incharge Police Post Phallian Mandal PSI Ajesh Singh Jamwal, In-Charge Police Post Talab Tillo PSI Rajesh Kumar, Incharge Police Post Chatha SI Ranjit Singh Chib and Incharge Border Police Post Garkhal ASI Rajinder Singh in their respective jurisdictions.

Husband-wife arrested with heroin

KATHUA: Intensifying action against drug dealings, Kathua Police under the overall supervision of SSP R C Kotwal on Saturday recovered approximately 23 gm heroin (Chitta) like narcotics near Keeriyam Gandiyal Naka point and arrested 2 drug pedlers besides seizing a scooter.

As per details, a team of Police Station Lakhnampur led by Insp Vijay Kotwal SHO Lakhnampur under the supervision of DySP DAR Kathua Sukhdev Singh during patrolling/checking duty noticed a scooter which was signaled to stop for checking. On thorough checking, approximately 23 gm of heroin (Chitta) like narcotics was recovered from two accused identified as Ashok Kumar, son of Rasal Chand and his wife Preety Devi, both residents of Chak Drab Khan



Tehsil. Duo was arrested and FIR No. 54/2022 under sections 8/21/22 of NDPS Act was registered against them at Police Station Lakhnampur.

15 bovines rescued, vehicle seized

UDHAMPUR: Police on Saturday foiled a bovine smuggling bid under the jurisdiction of Police Station Chennai and rescued 15 bovines.

Two narco smugglers nabbed with heroin & Charas

JAMMU: Continuing its drive against drug trafficking and narcotics substance, R S Pura Police achieved major success by arresting two narco smugglers and recovered 7 gm heroin & 13 Challis of Charas like substance weighing approximately 150 gm from their possession.

As per details, a team from Police Station R S Pura constituted under the supervision of SDPO R S Pura Surinder Singh and led by SHO Insp Rajesh Sharma while on Naka duty, rounded two suspects & on search, recovered 7 gm heroin & 150 gm Charas from their possession.

The duo, identified as Rakesh Gupta alias Raka, son of Jameet Raj Gupta, resident of Purana Pind, R S Pura & Deepak Gupta alias Monu, son of Vijay Gupta, resident of Ward-5 R S Pura were arrested and FIR no 114/2022 under sections 8/20/21/22/29 of NDPS Act was registered against them.

Abducted minor from MP recovered in Ramban

BANIHAL/JAMMU: An abducted minor girl, hailing from Madhya Pradesh, was recovered and her abductor was arrested in Ramban district, police said on Saturday. The girl was rescued in a joint operation by J&K police and Madhya Pradesh police from Sangaldan area of Gool within 24 hours of receiving of complaint, a police official said. He said that a team from Police Station Sarni in Betul district of Madhya Pradesh reached Police Post Sangaldan on Friday to search for a minor who had allegedly been kidnapped by one Bijinder Singh alias Ravi Rajput, also a resident of Madhya Pradesh. The local police immediately swung into action and rounded several suspects and finally recovered the minor besides arresting accused, the spokesman said, adding that both the girl and accused were handed over to team of Madhya Pradesh Police.

Man killed after getting hit by train
