





CRIME REPORT

18 bovines rescued in Rajouri

SUNDERBANI: Acting tough against bovine smuggling, Rajouri police has rescued 18 bovines by foiling bovine smuggling bids in Kalakote area of district Rajouri.
Police said that teams led by SHO Kalakote Deepak Pathania along with PSI Amit Radhay and H/C Rajesh Sharma laid a Naka and intercepted bovine smuggling movement on foot. The bovine smugglers although managed to escape from the spot avoiding arrest, but team successfully rescued eighteen bovines. Cognizance under relevant sections of law has been taken.
Drug peddler arrested; contraband recovered

BUDGAM: Continuing its efforts to curb menace of drugs from the society, Police on Wednesday arrested a drug peddler in Budgam and recovered contraband substance from his possession. As per details, Police Post Hardippanzo received specific information through reliable sources that one Parvez Ahmed Ganie, son of Abdul Salam Ganie, resident of Hardulatina, Beerwah has indulged in drug peddling and hoarded huge quantity of narcotics in his house. On receipt of this information, a party from Police Station Beerwah & Police Post Hardippanzo along with concerned Executive Magistrate raided specific location



and recover 12 Kg Poppy straw. The accused was arrested and shifted to Police Station where he remained in custody. FIR No. 63/2022 under relevant sections of law was registered at Police Station Beerwah and further investigation initiated.

22 live shells recovered from Nowshera, 2 more arrested

NOWSHERA: Army and police, in a joint operation, recovered 22 live shells from a house and arrested two more persons in this connection.
As per details, on Tuesday joint team of army and police, acting on an input conducted a raid and recovered empty shells of 105 mm of Indian Field Gun from a man, who was arrested while two others were also detained for questioning. Trio during questioning disclosed the names of two other persons, who were also arrested. On this, army and police conducted a joint raid in Nonihal village and recovered 22 live shells from a house. Till now 5 persons have been detained in the case.

Narco smuggler nabbed with heroin

RAJOURI: In drive against drug menace, police in Nowshera sub division of Rajouri arrested a narcotic-peddler and recovered a consignment of drugs from him.
In an official statement, Police said that a patrolling party of Police Post Lamberi while checking duty at Bagnoti area apprehended one Mukesh Kumar alias Billu, son of Raj Kumar, resident of Ward-6 in Bagnoti Nala. During checking, 12 gm heroin like psychotropic substance and cash amounting to Rs 20,520 was recovered from his possession. The accused was arrested and FIR No 118/2022 under sections 8/21/22 of NDPS Act was registered at Police Station Nowshera. The arrest and recovery took place by special efforts of PSI Vishal, SHO Nowshera Insp Rajesh Jasrotia and SDPO Nowshera Tussif Ahmed under supervision of Additional SP Nowshera Amit Verma under overall supervision of

SSP Rajouri Mohd Aslam.
Pertinent to mention here that accused is a notorious criminal against whom 4 FIRs have already been registered at Police Station Nowshera. The accused was also lodged in District Jail Srinagar from 2017 to 2021 under NDPS Act.

Speeding bus hits scooter, bike; 1 killed, 3 injured

JAMMU: A speeding bus hit a scooter and a bike in Bikram Chowk due to which a person was killed while three others got injured. As per details, a bus hit a bike (JK02AX-0685) and a scooter near Bikram Chowk as a result three persons on two-wheelers got injured. They were immediately shifted to hospital where doctors declared one of them as brought dead. The deceased was identified as Raj Magotra, resident of Talab Tillo while injured revealed their identities as Naresh, Rubina and Amarjeet Singh.
Meanwhile, a pedestrian also got injured after hit by an unknown vehicle near village Gazipur village of Miran Sahib. The injured was shifted to hospital and was identified as Suram Singh, resident of Makhanpur.

J&K woman hangs self in Hyderabad

HYDERABAD: A 27-year-old woman from Jammu & Kashmir working with an e-commerce major; died by allegedly hanging herself on Wednesday, police said.
The woman, a native of Samba district, was found hanging in her flat around 12 PM at Nanakramguda under Gachibowli Police Station, they said. She was taken to a hospital by her friend and medical officer declared her as brought dead, police said.
The woman was residing in flat on sharing basis along with two other women for last one-and-half-years. Her parents are in J&K. The reason behind her death is yet to be ascertained, while a case has been registered, police said.
