# CRIME REPORT

## House, shops burgled; jewellery, cash stolen

**BISHNAH:** A house and two shops were burgled in Bishnah and R S Pura areas respectively from where thieves decamped with jewellery and cash.

As per details, Shamsher Singh, son of Laxman Singh, resident of Sethi Kothe lodged a complaint with police that thieves targeted his house when he was out for some work and decamped with jewellery and cash amounting to Rs 15,000. Police has registered a case and started investigation.

Meanwhile, thieves also burgled two grocery stores in R S Pura and decamped with cash and goods. As per details, the first theft was reported at Ashok Karyana Store situated at Ward-11 while another case was reported at Sahil Karyana Store from where thieves decamped with cash and goods. Both the owners have lodged complaint with police, which has registered cases and started investigation.

## Man attacks mother-in-law, arrested

## Two missing women traced, reunited with families

After this, a team of Police Station Jhajjar Kotli under the supervision of SDPO Nagrota Pardeep Kumar led by SHO Jhajjar Kotli Inspr Vikram Sharma, after putting in strenuous efforts, traced missing woman within 12 hours. Subsequently, families of missing women were informed and they were handed over to their family members after completing all the legal formalities.

## Three arrested with sharp-edged weapons

**JAMMU:** Police on Monday nabbed three persons with sharp-edged weapons at Satwari.

As per details, on June 10, 2022 one Tarsem Lal, son of Krishan Lal, resident of Hakkal Satwari, lodged a complaint with police that his son namely Anil Kumar and nephew namely Ragu alias Nonni, son of Romesh Chander, resident of Hakkal were attacked with sharp-edged weapons (Toka) by some persons.

On this, FIR No. 105/2022 under sections 307/341/147 of IPC and 4/25 of Arms Act was registered and investigation started. After this, a team from Police Station Satwari under supervision of SDPO South Sachit Sharma led by SHO Satwari

Inspr Sameer Jeelani, after putting in strenuous efforts and connecting various leads, arrested three accused namely Abhishek Kumar, son of Ashok Kumar, resident of Raipur Satwari; Deepak Singh, son of Narinder Singh, resident of Raipur Satwari and Govind Choudhary alias Bindu, son of Ashok Kumar, resident of R S Pura Jammu. During intensive questioning, all three accused persons confessed their involvement in crime and weapons of offence were also recovered from their possession.

## 3 drug peddlers arrested; 52.3 Kg poppy straw recovered

**ANANTNAG:** Continuing its efforts to eradicate menace of drugs, Police on Monday arrested three drug peddlers in Anantnag and recovered contraband substance from their possession.

As per details, a party led by SHO Police Station Utrasoo at a checkpoint established at Cheerpura Utrasoo intercepted a Load Carrier (JK02CH-2707) with two persons onboard. During search, 40 Kg poppy straw was recovered from the vehicle. The accused were identified as Nazir Ahmad Bhat, son of Hameedulla Bhat, resident of Magam Kokernag and Shabir Ahmad Khan, son of Dula Khan, resident of Wanigham, Kokernag. They were arrested and shifted to police station where they remained in custody. The vehicle used in the commission of crime was also seized.

Moreover, a party from Police Station Achabal arrested a drug peddler identified as Nissar Ahmad Bhat, son of Mohd Ahsan Bhat, resident of Khoshi Pora Achabal along with about 12.3 Kg Poppy Straw. He was shifted to police station where he remained in custody. Accordingly, cases under relevant sections of law were registered in respective police stations and investigation started.

## One killed, 2 injured in bike-army vehicle collision
