# 'Aadhaar linked birth...

Secretary directed concerned officials to make coordinated efforts for full implenentation of Aadhaar linked birth registration (ALBR) and civil registration system (CRS) in Jammu and Kashmir.

He stressed on completion of all the technical formalities for successful implementation of the program and directed them to follow the case with the Registrar General of India for making the portal available and accessible in JK at an earliest. He enquired about the status and progress of constituent programs like training of staff, empanelment of Registrar of Births, procurement of necessary equipment and identification of staff to be trained for the task.

He advised the officials to start training the manpower so as the entire process becomes fully operational in Jammu and Kashmir within the set timelines. He directed the officers to ensure that the required infrastructure is put in place and any gaps should be projected before the UIDAI. He also directed the officers to cover all associated hospitals, district hospitals, CHCs, PHCs and private hospitals under the scheme. During the meeting Deputy Director General, Unique Identification Authority of India gave a brief about the process and benefits of the ALBR and CRS, saying the programs will quickly provide a unique identification to newborns. She elaborated that ALBR is the Aadhar linked birth registration at the time of child birth and its integration with the national platform of Civil Registration System (CRS) would make the process of birth registration instant and hassle free. The meeting further deliberated upon the ways and means of making this process effective besides discussing about maximising the benefits by identifying all the commonly utilised delivery points. It also discussed smooth and speedy implementation of CRS here which would eventually help in successfully implementing this programme.

# No successful infiltration...

"We have to be alert, and the boys are all up and about. We are maintaining our vigil," Misra said.

Protests had erupted in various parts of the country after the Centre unveiled the Agnipath scheme last Tuesday to recruit youngsters aged between 17-and-a-half and 21 years in the army, navy and air force, largely on a four-year contractual basis. It later relaxed the upper age limit for this year's recruitment to 23.

"How many people can one LG and his three advisors listen to? " he asked. Hitting out at critics of the People's Alliance foe Gupkar Declaration (PAGD), Omar said this was not unusual.

# Traffic on Jammu...

all-weather road linking Kashmir with the rest of the country -- and partial restoration of vehicular movement can be expected by Friday afternoon. Jammu Divisional Commissioner Ramesh Kumar, along with other senior officers, including Udhampur Deputy Commissioner Krittika Jyotsna and Senior Superintendent of Police Vinod Kumar, inspected the landslide spot near Samroli and asked the executing agencies to ensure that the road was made traffic-worthy at the earliest.

The deputy commissioner apprised the divisional commissioner that men and machinery were working on a war footing to restore the highway.

Ramban Deputy Commissioner Mussarat Islam, who is also personally monitoring the road clearance operations, said 25 out of the around 30 areas hit by landslides and mudslides on the highway were cleared on Wednesday itself.

The highway was blocked on Tuesday evening due to landslides, mudslides and shooting stones at 33 places in Ramban and Udhampur districts. A 150-feet-long road stretch and an under-construction bridge on the highway were also washed away due to flash floods.

The Mughal road, another link connecting the twin Poonch-Rajouri districts of Jammu region with South Kashmir's Shopian district, was also cleared for traffic after remaining closed for two days.

Earlier in the day, Senior Superintendent of Police, National Highway, Shabir Ahmad Malik said efforts have been stepped up to ensure the early restoration of traffic on the Jammu-Srinagar national highway.

"Over 700 trucks and passenger vehicles, stranded between Panthiyal and Banihal (in Ramban), were cleared and they reached their destinations in Kashmir since Wednesday evening, while efforts are on to clear the remaining 1,300 vehicles, Malik told PTI.
