

- Whereas, on your selection as constable in J&K Armed Police vide PHQ J&K Order No. 3932 of 2009 date 12-11-2009 and Subsequently your adjustment in IRP-19th Bn. vide APHQ J&K order No. 01 of 2010 dated:- 02-01-2010, you were provisionally appointed as constable by commandant IRP-19th Bn, vide his office order No. 962 of 2010 dated 27-03-2010 and you joined the department on the same date i.e 27-03-2010.
- Whereas, you remained posted in several Battalions and instantly you are posted on this unit since 28/05/2018, Holding the rank of constable under regt. No. 834/IRP-10th Bn. and were further deployed in A-coy of this unit to perform General duties.
- Whereas, on 23-05-2022, you left your legitimate duties/ place of deployment unauthorized and did not return bank till late evening accordingly your un-authorized absence stand diarized in Copy daily diary cide DD report No. 13 of date.
- Whereas, on leaving your legitimate duties un-authorized and non-resumption back for duties, coy Commander A-coy vide his office Signal No. A-Coy/IRP-10th /314 dated:- 24-05-2022 Communicate your absence to this headquarters. Accordingly, vide this office, signal No. Estt/PF-834/IRP-10th/2022/9355, dated 25-05-2022, you continued your absence at large scale and did not pay any attention towards the information/ notice.
- Whereas, following the matter you were again informed through concerned police station by Coy commander A-Coy of this unit vide his office signal No. A-coy/336 dated 04-06-2022 to resume your duties. But all in vain as neither you resume your duties nor any thing has been heard from your end regarding your whereabouts and well being regarding.
- Whereas, on total failure to resume your duties of Having been informed Through concerned Police Station by a chain of Communications, you were placed under suspension vide this office order No. 247 of 2022 dated 06-06-2022 with immediate effect and a proper department enquiry into your conduct has been ordered to be conducted by Coy Commander A-Coy of this unit.
- Whereas, On perusal of your previous service profile, it reveals that from the date of your initial appointment on 27-03-2010, till date you have been awarded (02) Major Punishments in the shape of stoppage of Annual Increment/ Forfeiture of Annual Increment Respectively and also (266) days of your service have been treated as Diesnon on Several occasions from which it depicts that in previous service tenure too, you have not remained duty bound/ law abiding official instead is a clear habitual of absenteeism.
- Whereas, on your total Failure to resume your duties despite of being informed several times either by Coy Commander Concerned or by this headquarters, it clearly depicts that you are not interested to serve the department anymore and your further formal existence on the rolls of this unit is of having no means and deserve for your removal from service on account of your previous service profile and instant un-authorized absence.
